Adittionally, courts are prohibited from substituting their judgment for that of the agency. Courts in administrative issues are prohibited from even listening to or hearing arguments, presentations, or rational"

"Ministerial officers are incompetent to receive grants of judicial power from the legislature, their acts in attempting to excerises such powers are necessarily nullities."

Burns v Sup Ct. SF, 140 Cal 1.
