1. Please note that priority spaces go to full time vendors. We have a map for spot placement, and it will be followed weekly. **Cancellation less than 48 hours in advance forfeits refund or credit of payment for that week.** We have the market rain or shine.
2. If you are a vendor that is only promoting your brick & mortar location it must be in Montgomery. This means you must have Montgomery address to be a vendor. This will meet the criteria for being a local business.
3. Payments must be received by 2 days (Tuesday) prior to the Thursday you are attending.



4. The Fee for the weekly event is \$25. You can pay weekly or by the month. You will receive a discount if paid monthly. **All methods of payment must be received by the Tuesday prior to the market on Thursday. PAYMENT WILL NOT BE EXCEPTED AT THE MARKET.** Cash or credit Card Only. Cash must be delivered to Rustic Cashmere (14356 Liberty St.) credit will be paid online via the payment link.
5. All Tents will be set up on the street surface. You must bring your own weights for the Tent.
6. **Smoking is not allowed in or around vendor booths.**
7. Drinking excessively is not permitted. Complaints will be given to the Farmer's Market committee for review and possible termination of your contract.
8. HMBA will not be responsible for any damages, loss, or expense incurred by the vendor during this event.
9. You Must submit with this form a copy of all licensing & permits.
