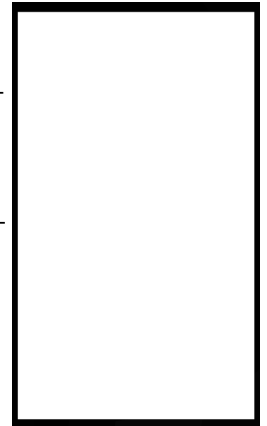

## IMPORTANT SHOW INFORMATION

### SET UP:

- ★ Friday, November 27th, 10 AM-5 PM . This does not mean show up at 5pm to set up. We will close the gates at 5pm sharp. You may bring your vehicle in on Friday to stock your booth. If we have rain you will need to be able to transport your items from designated areas for set up and tear down.
  - ★ Saturday, November 28th, 7 AM-8 AM. All booths need to be set up by 8AM on Saturday. SATURDAY you will not be able to bring your vehicle in until after the show closes and we decide it's safe to do so. NO VEHICLES IN THE SHOW AREA SATURDAY MORNING. NO EXCEPTIONS. All items must be carried or carted in.
- Vendors must keep booths open during all show hours.
  - Vendors may not pack up early for any reason without permission.
  - Vendor agrees to park in the designated vendor parking only.
  - Show dates are subject to change due to things out of our control or weather conditions or if the grounds are unsafe for any condition. If the show date is changed booth fees will be moved to the next scheduled show. No refunds will be given.
  - Vendors can not sublease booths. If you are on the contract you are the only one who can use your booth space unless another person is sharing your booth and their name is on the contract. SORRY NO EXCEPTIONS.
  - THERE CAN BE NO DRINKS OR FOOD SOLD WITHOUT PERMISSION THIS INCLUDES WATER.
  - Each paid vendor will receive **2** wristbands to the show. You must wear your wristband at all times during the show. You can purchase more wristbands for **\$5**. These can be used by people working in your booth, not people coming to shop.
  - Vendor agrees to clean your area and leave nothing in your booth when the show is over. Do not leave your trash for us to clean up. Please take all broken tents, boxes, any unwanted items, etc.

Vendor grants permission to the promoter to use images of vendors booths / items and name for any purposes to promote the event.

THERE WILL BE NO REFUNDS FOR ANY REASON PLEASE DO NOT ASK.

Vendor spaces will not be held until payment is made in full.
