



Guest Speaker Major Drew Dela Cruz USAF-DFC

August 22, 2021, more than 100 massive cargo aircraft were tasked with evacuating 114,000 refugees from Afghanistan, including the USAF C-17 piloted by, then, Captain Dela Cruz. His C-17, call sign Reach 651, was circling above Al Udeid Air Base in Qatar with 450 Afghan refugees aboard. The plane had been aloft for hours, had only one small toilet and no air conditioning as it flew through stifling subtropic air and ... it was running low on fuel.

The crew had been briefed earlier in the day that saboteurs planned to attack Hamid Karzai International Airport in Kabul possibly by suicide bombers so the crew had taken extra precautions to search everyone coming on board.

While the aircraft was waiting for landing clearance, a 16-year old mother began convulsing then fell unconscious. To better care for the woman away from the cargo bay, Capt. Dela Cruz ordered she be brought to the flight deck.

As the crew took her to the flight deck, two Afghan men tried to force their way to the front to gain entry to the cockpit. A Security Staff Sergeant physically restrained one of them as a loadmaster pulled the other away, thus defusing the possible attack on the flight crew. A female Sr. Airman saved the life of the young woman while a Lieutenant barricaded the cockpit door. Capt. Dela Cruz declared a medical emergency and was given immediate clearance to land. With extreme skill and assistance from another pilot, Dela Cruz was able to navigate the jammed tarmac and get the stricken woman to a waiting ambulance.

Dela Cruz' poise, sound decisions and command authority aboard Reach 651 led to his being awarded the Distinguished Flying Cross for a single act of heroism and extraordinary achievement in aerial flight. Seven other members of the crew of Reach 651 were similarly recognized.

Dela Cruz' parents, El Dorado Hills residents, Jill and Rick are justly proud of their son's actions. Rick Dela Cruz points out the last mission son Drew flew out of Kabul was his "proudest moment". His C-17 was full of United States Marines, and he was proud to get the marines out and back to safety.

A graduate of Oak Ridge High School in 2012 and the USAF Academy, Major Dela Cruz is stationed at Travis AFB where he resides with his wife, Janessa.




American 250:


John Hart (circa 1713 – May 11, 1779) was an American Founding Father, farmer, and politician in colonial New Jersey. As a delegate to the Continental Congress, Hart signed the Declaration of Independence.^[2] He died several years before the end of the Revolutionary War while still active in patriotic efforts.

In December 1776, the British advance into New Jersey reached Hunterdon County. A marked man because of his status as speaker of the Assembly, Hart was obliged to escape and hide for a short time in the nearby Sourland Mountains. His farm was raided by British and Hessian troops, who damaged but did not destroy the property. The Continentals' capture of Trenton on December 26 allowed Hart to return home. Prior to the Battle of Monmouth, Hart invited General George Washington and the Continental Army to make camp on his farm, and his offer was accepted. From June 22 to 24, 1778, 12,000 men occupied his fields, and on at least one occasion Washington dined with Hart.

Today there is a marker for John Hart's Cave where he was in hiding from the British. During this time his estate ransacked by Hessians, and was subsequently ruined financially He died in 1779. https://www.ushistory.org/declaration/signers/hart.html
