# :AFFIDAVIT :NOTICE-OF-UNDERSTANDING-AND-INTENT-MANDAMUS-COUNTER-CLAIM-CONDITIONAL-ACCEPTANCE.

This notice is issued with honourable and peaceful intent and in good faith so to establish a verified claim with due process.

This notice is issued as a courtesy for all or any agents of the organs of our collective social body, a reminding to all of their inherent sacred duty and trust to steward justly the organs of our collective social body.

This notice is issued as a matter of private necessity by we the people so to protect our families and tribes from the observable behaviour expressed by those whom have taken liberty to serve the sacred duty and trust to steward justly the organs of our collective social body.

This notice is issued as a result of loss of confidence in the trustees of the organs of our collective social body since the observable rogue behaviour since 2020.

This notice is issued with a declaration of peace and declaration of independent state, from the private standing as a foreign neutral, living in attitude of peaceful possession of certain tracts of land upon the continent Terra Australis

This notice exists as a declaration of honourable immunity from all other states as a foreign neutral.

This notice proclaims our collective need for each and every individual public servant to immediately volunteer to personally issue solemn in the fact soul cannon oath before any contracting of the legal person can proceed.

- $\sim$ 1 a. It is our understanding that all law that has ever existed and all law that does exist exists so we may together craft equity and honour in the commerce of will between all living souls.
- b. It is our understanding that the symbol of scales we use for the notion of law exists so to measure the equity of balance between will and consent. It is through our usury of liberty with our gift of free will where one will in commerce with another need negotiate consent. The scales measure and assist crafting the equity of consent. Will and Consent, Offer and Acceptance.
- c. It is our understanding that to contract is opposite to expand. To commerce with an other living soul is to enter into contract. This is to leave the limitless expanse of spirit and contract our life force into the confinement of some common endeavour, to enter the contracted world of logos and egos. In simple terms we enter a marriage of common purpose, a bond, all commerce and contract is a marriage of degree. From mere moments to a life time marriages are sown throughout our entire life adventure. We may have access to infinite types of contract both positive and negative.
- d. It is our understanding that honourable contract is composed of Offer, Acceptance, Consideration, Lawfulness of contract subject, Lawful capacity to contract and consent.
- e. It is our understanding that soul contract precedes all or any strawman contract and is the fundamental understanding of the difference between Corpus Juris Unum and Corpus Juris Secundum.

- ~2 It is our understanding that any 'I am' is a living soul inhabiting human form and that any 'I am' is but one fellow cell of an organism we may call our human species.
- ~3 It is our understanding that we as fellow members of our human species are in commerce as one species layer among many others in the biosphere of our living planet.
- ~4 It is our understanding that we are all fellow members of our human family and here in Australia are what we could call the Terra Australus continental portion of the collective species organism mankind.
- ~5 It is our understanding that the fabric of our Terra Australis continental portion of the collective species organism mankind operates with a shared meta physical body called our social body.
- ~6 It is our understanding that it is with our social body with which we create our society.
- ~7 It is our understanding that to operate our society efficiently to achieve heath, vitality, harmony and enlightenment for each and every individuating cell of our collective body. We have created a dead fiction extension of our collective self called a **corpse-oration** government. So all living souls may become the possessor of a dead person vessel with which to commerce with each other and the central dead corpse-oration 'system'. And by virtue of the **very existence** of the corpse-oration as organ of our collective social body it **is** the steward s' offer to contract. The actual government is dead-corpse-oration and it is the living-soul life force contributed by fellow living souls that is the living intent of the agenda of governance.
- ~8 a¬ It is our understanding the **corpse-oration** offer to contract is in accord with natural and moral law which is the foundation law for the harmony of all species of our bio-spheric wholeness and the harmony for our operation as a human family.
- b¬ It is our understanding that all and any fellow 'I am' who chooses the sacred duty and trust to serve our collective social body requires to make a fully public soul cannon oath as a personal guarantee of their integrity of will to steward justly the organs of our collective social body on our behalf.
- ~9 It is our understanding that for we as living souls sharing reality it is the law of commerce that stands next to natural law as the dominant law that commands all reality. Every molecular bond, every chemical reaction and interaction is a commerce of substance. We commerce oxygen for carbon dioxide in our every breath for example.
- ~10 It is our understanding that if we are to commerce in accord with natural law it is the covalent bonds demonstrated by the molecular structure of nature we need to mimic. Covalent bonds are a sharing of current that allows each part to mimic a noble gas. Co and valent, the sharing of value, true consideration. It is our understanding that our living experience of commercing with each other is fundamental to our understanding the concepts of the mechanics and dynamics of karma and dharma.
- ~11 It is our understanding that the nature of bond is symbolised by the scales of justice which exist to measure honour in commerce.
- ~12 It is our understanding that the highest fidelity of honour in commerce is unconditional love and exists as the most 'god' like commerce we may express and experience and is the highest fidelity of commerce we may have with all innocence.

- ~13 It is our understanding that the next lower octave of honour in commerce is Grace, or unconditional acceptance, where whether we like something or not we accept and allow, or in the Australian vernacular -"to cop it sweet".
- ~14 It is our understanding that the next lower octave of honour in commerce is conditional acceptance where through discussion and negotiation contracting parties reach agreement.
- ~15 It is our understanding that all else is dishonour, to go silent, to ignore, to debate, to petition, to protest, to fight and eventually war. All exist as a tort and can only ever exist as a virtue when no other option exists but to meet tort with tort. Compliance to avoid violence or through coercion is not consent.
- ~16 It is our understanding that the law of contract is that which serves our actions, interaction, reactions in our commerce throughout our social body. Maxim The Contract makes the law.
- ~17 It is our understanding that to contract in the current usury of the adverb-verb syntax as exampled herein, is not in-the-fact and can only exist as an opinion. True contracting in-the-fact exists only with the usury of the correct-sentence-structure-communication-parse-syntax-grammar. As advised by the Maxim As it is written so shall it be. This notice exists as an introduction for the in-the-fact-claim which follows. This in the fact claim exists as a peaceful example of the highest fidelity of scripting contract and a heartfelt encouragement for the organs of our collective social body to adopt this technology to rid our legal system of all confusion and concealment's.
- ~18 It is our understanding that the analogy of atoms coming together as molecular structure to form compounds is mimic-ed in the organic nature of family and tribe where the inherent mechanics of law commerce and law moral are infused into innocence via the dynamics of family and tribe bonds; the very heart and hearth of unconditional love, grace and conditional acceptance. Family the primary foundation of our species-organism-humanity.

#### Maxim – External actions reveal internal secrets.

- ~19 It is our understanding that the policies of any system that does not uphold and support the integrity of family are anti human and as pointed out by our institutions of religiosity are the unjust steward, the mammon anti-christ mentality attitude which may be worn by any one individual among many others. The attitude of government expresses the observable balance between the dominance of either the attitude for the common good soul centred-ego or the selfish greed attitude of the hypnotised separated ego. It is our understanding that the notion of Satanist is simply a mentality any living soul may express, and the best description of satanist found upon the net is any condition of the thinking that has a clear and potent understanding of the mechanics and dynamics of the psychology of man and then chooses to use that understanding and insights for advantage over their fellow man for power control and profit.
- ~20 It is our understanding that our god-lawful-living-soul-will is voiced through the filing of this NOTICE-OF-UNDERSTANDING-AND-INTENT-MANDATE-COUNTER-CLAIM-CONDITIONAL-ACCEPTANCE into the corpse-oration and is in effect by the legal maxim "notice to agent is notice to principal, and notice to principal is notice to agent".
- ~21 It is our understanding that beyond the natural law of family and tribe; our forming collectives of human endeavour and interest requires we all to create corporations, meta-physical bodies of contracted intent exampled by Private Membership Associations which as associations of members bound by the contracting to certain values and principals create a sovereign state or principality with in nation states.

- ~22 It is our understanding that the corpse-oration is an organ of our collective social body which when in honour exists to steward justly the delivery of health, harmony, vitality and enlightenment for our every individuating living soul/cell of our Terra Australis continental portion of our collective humanity organism body. As is the observable natural law of any living form.
- ~23 It is our understanding that the Christian narrative identifies the "Unjust Steward" as "Mammon" or the notion of Son of the Devil/Satan/Shadow side of the Creator, or an inversion of the good.
- ~24 It is our understanding that an unjust steward is one who would make usury of the mechanics and dynamics of our collective organs of our social body for personal gain/advantage, wealth and power. That would use maliciously the sacred duty and trust of office to hurt, harm and tort their fellow living-soul-men and women. That would indulge in ego masturbation gratification at the expense of those whose sacred duty and trust they betray; that would hold assumption that it may occupy territory and hold the population in contempt as public enemies and enemy combatants.

#### ONE CAN NOT BE FORCED INTO A FRAUD.

It is our understanding that to be tricked and groomed into joinder with the dead legal fiction is conspiracy to murder.

It is our understanding that to be forced into name, age, address, subject and title is the imposition of a religious observance.

- ~25 It is our understanding that by virtue of living souls combining efforts and intentions into a collective, although may amplify advantage, does not create more right than one would have if one was not a part of a collective body of bodies, a corporation. It is our understanding that if a contract was set-up in a form of trickery, deceit or doublespeak, being a deception, such an act of deceit has the potential to destroy the contract from the very beginning if it was discovered that the original intent was not made in All sincerity.
- ~26 It is our understanding that no matter how big a corporation of bodies the same fundamental principles of law apply. It is our understanding that no matter how big a State is they all share the same standing in natural law and law of nations. It is our understanding that a State is a state of mind, a state of nature and a state of being. It is our understanding that any living soul may choose which state they wish to exist in. It is our understanding that the body politic of a private members association is a sovereign state and that all living souls which form that association exist as sovereigns of a sovereign state as exampled by the Queen/King.
- ~27 It is our understanding that the corpse-oration bodies which immediately direct and serve the dead-person-vessel are the Local Government, the State Government, the Australian Federal Government which in turn are directed by other corpse-oration bodies as in the Monarchy and the Papacy, and a network of other collectivities. The legal maxim 'Notice to Agent is Notice to Principal and Notice to Principal is Notice to Agent' is with this NOTICE-OF-UNDERSTANDING-AND-INTENT-MANDAMUS-COUNTER-CLAIM-CONDITIONAL-ACCEPTANCE and is communicated to all of the **corpse-oration** bodies we have knowledge of and all of the **corpse-oration** bodies we have no knowledge of, by the fellow-honourable-god-lawful-living-souls behind the public-servant-persons within the labyrinth of **corpse-orations** which affect we all as god-lawful-living-souls living our honourable existence for the short time we call a life in our Human Race (to the portal of death)

- ~29 It is our understanding that this notice of understanding and intent mandate counter claim conditional acceptance is notice from our souls to all other living man and woman souls of the persons of the **corpse-oration** whose free will choice affects the life of our self and our family and our tribe by the karmic-debt of their free will choice actions.
- ~30 It is our understanding that the living souls, serving the dead **corpse-oration**-organs, of our species humanity body, is with the soul fusion, with the unjust steward agenda, of that body, or, the just steward agenda of that body, by their free will choice.
- ~31 It is our understanding that all living souls have a soul duty, to correct the wrongs of the unjust stewarding of, the **corpse-oration** bodies affecting all lives of all fellow cells/people of our collective organism humanity body.
- ~32 It is our understanding that the offer made by the **corpse-oration** matrix of bodies to the fellow members of our god-lawful-living-soul man and woman global family is with the soul fusion of all public servants who choose with their free will choice, to be with the karmic bond, by the affects of the agenda of the **corpse-oration** bodies, upon the every man, woman and child.

## :THE-ACCEPTANCE-BY-THE-:Peter-James: Mitchell.

- ~34 It is our understanding that we may accept that a corporation has the same status as a person and a person has the same status as a corporation, both are dead. Persons are dead vessels through which the life-force of individual living souls, inhabiting human form, may contribute life and effort to the dead corporation.
- ~35 It is our understanding that compliance to avoid violence is not consent.
- ~36 It is our understanding it is not a matter of acceptance but a matter of necessity through fraudulent inducement that we as living souls have need to possess and use the dead person vessel so to avoid violence. If we were to drive on the road with out a licence we would meet violence from a government agent, if we were to seek work with out a tax file number we would not be legally able to access income and would meet violence from a government agent for doing so. It is our understanding that the assumption behind the usury of licence and permit to control a population is a part of the War Powers, so an occupying force may manage its enemy.

- ~37 It is our understanding that most living-soul men and women know only that which they are told to know, that the perfidy of church and state perpetrates a soul zombie condition of state through religiosity, government schooling, and 'universe as machine mentality nihilistic dementia' of formal mainstream science, academia and media and the unfettered greed and unaccountably of the corporatocracy-technocracy-mentality.
- ~38 It is our understanding that the acceptance of all those who seek the karma of the unjust steward are advised of the soul-damage-hazard but may still choose to do so. This NOTICE-OF-UNDERSTANDING-AND-INTENT-MANDAMUS-COUNTER-CLAIM-CONDITIONAL-ACCEPTANCE is honourable remedy for accommodating them all.
- ~39 It is our understanding and acceptance that for a corporation to function it requires to have a paper/digital record and as such is separate to the living souls who bond together to give the corporation and persons life and performance.
- ~40 It is our understanding and acceptance that it is necessary for a corporation to be a dead entity as it is in the paper/digital record where each registered member of the collective, records their input into the greater body.
- ~41 It is our understanding and acceptance that the word 'corporation' stands for **corpse-oration** which is testimony of it being the dead which speaks through paper/digital record, the status of all or any corporation. It is our understanding that a Private Membership Association is testimony of the living spirit.
- ~42 It is our understanding and acceptance that the word 'person' exists so to identify each individual dead paper component with a person vessel, representing all the living souls contributing their life force/voice bringing life to a **corpse-oration**.
- ~43 It is our understanding that the word person may also mean per- a part of and -so/un- the source of all life. Though in legalese it would indicate a meaning of a person being a corporation or a corpse-oration which would indicate the assumption of a person is a dead entity.
- ~44 It is our understanding that the service, maintenance, management, navigation, posting and porting of the dead person vessel requires doing by a living soul, an alive man or woman.
- ~45 It is our understanding that the service, maintenance, management, navigation, posting and porting of the dead person vessel requires effort and attention of a work-man worthy of his hire, a captain or post master of the dead person vessel.
- ~46 it is our understanding that the Autographing of a postage stamp on the bottom right hand side of person vessel is the identifying of the position of Post Master and Captain for the living soul man or woman servicing, maintaining, navigating, posting and porting the person vessel on behalf of the corpse-oration; and furthermore the bringing of the vessel into the jurisdiction of the Universal Postal Union.
- ~47 It is our understanding and acceptance that there is an obvious undeniable difference between the status of what is a person and what is a living soul inhabiting human form as a man or woman.
- ~48 It is our understanding that our acceptance for the offer to commerce with the corpse-oration was honourably created by our parents innocently registering for us a person in the corporation. The forensic evidence of this is with the birth certificate.

- ~49 It is our understanding that our continuing acceptance is verified via our living work-man/woman efforts to settle and close the vote responsibility for our person vessel for another politician person. It is our current assessment that the current behaviour of the officers of the offices of the government exists in a malicious use of authority and is a breach of contract as clearly demonstrated through out the whole 'Covid' phenomena.
- ~50 It is our understanding that the Birth Certificate is forensic testimony of the existence of a record of the event of a live birth, and exists as a symbol of the value of the shared universe all who exist are a part of, and exists as an estate-trust held in care by the **corpse-oration**, and acknowledgement that a living soul man or woman exists beyond the person.
- $\sim$ 51 It is our understanding that our mother and father created for we as individuals an appellation with which we may be phonetically addressed.

- ~55 It is our understanding and acceptance that our 'signature' in 'cursive script' is a simulation of our autograph and is but a sign of our nature.
- ~56 It is our understanding and acceptance that our quantum language autograph exists so to distinguish our-self as a living breathing man/woman from the dead person 'signature' contact with the dead corpse-oration.
- ~57 It is our understanding that we as a god-lawful-living souls, that we as a man or woman the authorised possessor of the person which we have authored a sign of the nature of, and consequently have duty to keep the person we have authorised possession of, in honour and manage it's equitable commerce with all other persons. It is our understanding that our sovereign state is unlimited in its capacity to contract and may contract soul to soul, living man to living man and woman and also may contract through the dead vessel person with other dead person vessels and the dead-corpse-oration.

- ~61 It is our understanding that the behaviour of the **corpse-oration** presents situations where prudent self defence is necessary as remedy from bad actors using the collective power and force of the sacred duty and trust authority of the stewardship of our collective organ maliciously.
- ~62 It is our understanding that breached contracts may be modified or severed; but in a spirit of Christed light, this counter claim exists as honourable remedy for the dishonour and breach of contract by the living souls whose sacred duty and trust bring life to the organs of our collective social body. It is not government which hurts and harms people it is public-servants who knowingly, willingly, and intentionally do that.

#### :CONSIDERATION OF THE CONTRACT

~63 It is our understanding the benevolent consideration that we bring to the contract will be reciprocated. The consideration we bring is a peaceful and cooperative consideration for the living soul of the humans who with their freewill choice choose to be honourable office holders of the **corpse-oration** acting as fiduciary for our living soul man/woman. My consideration is to provide all information an agent requires, and fulfil all reasonable offers, claims, fees, orders, directives, taxes, all in exchange for the consideration of paying fairly in accord with the fee schedule for my settling and closing the commerce between the **corpse-oration** and its person. The **corpse-oration** will hold the consideration for us that we all as unique individual fractal expressions of unity consciousness will hold different beliefs to many others and will accept our fee schedule as remedy for the inconveniences, injury and damage the current attitude of the 'system' delivers to the ordinary man and women.   - ~II:"ALL ARE EQUAL UNDER THE LAW" which means that Commercial Law, being founded upon unchangeable principles of both Natural and Moral Law is binding on everyone. The fact that mankind forms systems, organisations, governments, does not supersede or abrogate natural or moral law.
  - ~III: "IN COMMERCE TRUTH IS SOVEREIGN" your word is your bond.
  - ~IV: "TRUTH IS EXPRESSED IN THE FORM OF AN AFFIDAVIT" A solemn expression of your truth as a foundation for the responsibility for any commercial transaction whatsoever. There can be no valid commercial transaction with out someone having put their neck on the line and stated that "this is a true, correct and certain situation".

- ~V: "AN UNREBUTTED AFFIDAVIT STANDS AS THE TRUTH IN COMMERCE" Claims are made, if they go unchallenged, they emerge as the truth in the matter.
- ~VI : "AN UNREBUTTED AFFIDAVIT BECOMES THE JUDGEMENT IN COMMERCE"
- There is nothing left to resolve.
- ~VII: "IN COMMERCE FOR ANY MATTER TO BE RESOLVED IT MUST BE EXPRESSED" Another way of saying that nobody is a mind reader.

- ~65 It is our understanding that the tax file number, the medicare number, the customer reference number, the drivers license number of our person are all forensic evidence for our claim that the dead person vessel exists and through which we as living souls have with our life-force efforts authored a simulation/cursive-signature communication through the person to the corpse-oration dead which speaks through paper/digital record.
- ~66 It is our understanding that it is through the focused attention and efforts of our living soul existence-performance which provides the life force necessary, for the dead person vessel, so to perform within the collective of the corpse-oration.
- ~67 It is our understanding that the honourable service, maintenance, management, navigation, posting and porting of the vessel is work that we as a living god-lawful-work-man/woman do on behalf of the corpse-oration created dead person vessel.
- ~68 a- It is our understanding that the commercial maxim "A workman is worthy of his hire" applies to the work of the [Benefactor: Peter-James: Mitchell] service, maintenance, management, navigation, posting and porting of the dead person vessel Mr Peter James MITCHELL.
- b- I hereby reject any prior or post, assumed or presumed, adhesion contracts and power of attorney, taken by rome and or corporations and agents thereof that have not provided full disclosure and claim any equity that I have created in accordance with the contracts as per the maxim "He who takes the risk, deserves the reward"

- c- "Equity will not aid a Volunteer" and I do not volunteer to be an unlawful administrator of the estate.
- d- To make usury of the legal name is to enter the situation of being identified as an executor de son tort, one who operates in his own wrong. It is legal to make usury of the legal name but it is unlawful unless one has been lawfully appointed as the de jure executor.
- ~69 It is our understanding that to be forced to service, maintain, manage, navigate, post and port the vessel with out remuneration would be condition of state of slavery.
- ~70 It is our understanding that this affidavit of claim/lein is the opportunity to discuss and negotiate the herein fee schedule.
- ~71 It is our understanding to be forced to do the work of fulfilling orders before a fee schedule is in place and agreed upon, then what ever we determine to be our price stands, as the corporation issuing orders has operated on the presumption it is getting services for free.
- ~72 It is our understanding that to breach the peace, to hurt or harm or create loss to an others life, liberty, rights or property, to use deception or fraud in commerce and contract is the only way a living soul may break the god-law.
- ~73 It is our understanding that all corporate legislation as rules, regulations, stipulations exist as directions for service, maintenance, management, navigation, posting or porting of the dead person vessel JOHN HENRY DOE and may only be brought to honour by the work of the lawfully appointed living soul [:John-Henry: Doe]
- $\sim$ 74 It is our understanding that it is only, not seeing the 'assumption' that has all living souls not operating upon a lawful fee schedule. For the assumption of authority is with the authorising of an assumption.
- ~75 It is our understanding that the whole of each and every legislation in creation is written in adverb verb fiction and can not and does not identify any facts and can remain technically only as an opinion or a fraudulent conveyance of language or a postal fraud.

- ~76 It is the private necessity and honouring the good faith of serving the integrity of the collective social body of our species that [:John-Henry:Doe] to continue usury of the dead vessel epitaph JOHN HENRY DOE and consent to provide all details necessary for the harmonious commerce of the said Government created, issued, registered and copy written dead person vessel in accord with the herein fee schedule with all **corpse-oration** agents.
