To all our participants and club members, THANK YOU. Your enthusiasm, hard work, and dedication are what continue to make this event such a meaningful tradition year after year.

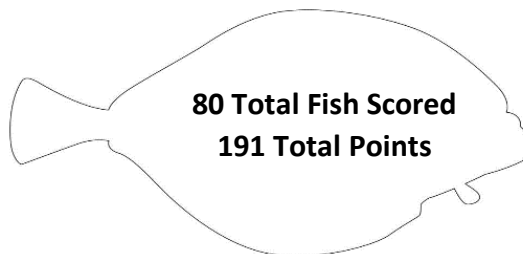
