**Legal Framework** 

Employment Equity Act, No. 55 of 1998: The principal Act regulating employment

equity in South Africa.

Employment Equity Amendment Act, No. 4 of 2022: Introduced sectoral numerical

targets and expanded enforcement provisions.

• Section 20(1): Requires designated employers to prepare and implement an

Employment Equity Plan.

• Section 21: Requires employers to submit reports (EEA2 and EEA4) to the Department

of Employment and Labour.

**Case Law** 

In Solidarity v Department of Correctional Services [2016] ZACC 18

The Constitutional Court upheld the use of national demographic targets but stressed the

importance of regional representation and individual fairness in Employment Equity

implementation.
