INTRODUCTION

As part of South Africa's compliance with global anti-money laundering standards and the [Companies Amendment Regulations, 2023](#), all companies and close corporations are now required to maintain **up-to-date Beneficial Ownership (BO) registers**. These registers must be submitted to the [Companies and Intellectual Property Commission \(CIPC\)](#) via its online portal and updated **within 10 business days of any changes**.

Failure to comply can result in penalties, delays in issuing compliance documents (such as a Letter of Good Standing), or even deregistration.

The company or entity whose ownership is being declared is the **Declaring Entity** and bears the legal responsibility to ensure all beneficial ownership data submitted is accurate, complete, and current. The **individual or filer submitting this information** to the CIPC must **be duly authorised by the Declaring Entity** through a **signed mandate or delegation of authority**.

This toolkit provides a practical, compliant framework to create and maintain your BO Registers across individual, company, and trust ownership structures, ensuring you capture all required information and have the necessary supporting documentation to meet regulatory standards.

WHEN IS BENEFICIAL OWNERSHIP DISCLOSURE REQUIRED?

You must file beneficial ownership details with the CIPC if:

- **You are a company or close corporation filing annual returns after 11 December 2023.**
- **There is any change in beneficial ownership (for example, a shareholder sells shares, a trust beneficiary changes).**
- **You are requested to submit a Beneficial Ownership (BO) register as part of compliance reviews, funding processes, or due diligence checks.**

All non-exempt companies, including private companies, external companies, and non-profit entities with voting members, must maintain and submit this information, even if ownership structures remain unchanged.

Note: Some entities are **exempt from submitting a full BO register** but remain **obligated to submit prescribed ownership disclosures** via the **CIPC portal**. This includes:

- **Listed companies,**
 - **State-owned companies and those controlled by the state,**
 - **Subsidiaries of listed companies, and**
 - **Any other entities specifically exempted by the CIPC or the Minister of Trade, Industry and Competition.**

Ensuring accurate and timely disclosure is critical to avoid penalties and maintain your company's good standing.

FILING THRESHOLDS & LEGAL DEFINITION OF CONTROL

An accurate Beneficial Ownership (BO) register is not just good practice, it is a legal obligation anchored in South African legislation aimed at enhancing corporate transparency and preventing illicit financial activities. Understanding who qualifies as a beneficial owner and the thresholds for disclosure is crucial to staying compliant and avoiding penalties.

Filing Threshold:

Any individual or legal entity holding **more than 5%** of the **Beneficial Interest (BI)** or exercising direct or indirect control over a company must be disclosed in the BO register.

What is "Control"?

Control encompasses the ability to **influence key company decisions**, even **without direct shareholding**. This includes:

- Holding a majority of voting shares
 - Having the right to appoint or remove board members
 - Exercising indirect control via trusts, layered ownership structures, or contractual rights

Legal Framework:

The obligation to maintain and file a comprehensive BO register is set out in the following legislation and regulations:

Companies Act, 2008 (Act No. 71 of 2008): Sections 33, 50, and 56 specify the duties to maintain and file ownership registers.

Companies Amendment Regulations, 2023: Regulation 30A details updated filing requirements and deadlines.

Financial Intelligence Centre Amendment Act, 2017 (FICAA): Aligns South African law with global anti-money laundering standards, imposing further reporting obligations.

Mastering these legal requirements is essential to mitigate risk, protect your company's reputation, and ensure smooth regulatory interactions.

FILING OBLIGATIONS TO THE CIPC

Since 11 December 2023, **all companies and close corporations are required to submit their Beneficial Ownership (BO) data to the (CIPC) before filing annual returns.**

Key points to note:

- Keep a Beneficial Ownership Register at your registered office.
 - Submit updates to CIPC within 10 business days of any change.

- Include full legal names, ID/passport numbers, percentage of interest held or control exercised, and nature of control (e.g., direct shareholding, voting rights).
- Provide supporting documentation such as share registers, trust deeds, or memoranda of incorporation.

Failure to comply can lead to penalties under the Companies Act and possible deregistration.

This written and signed mandate also forms part of the mandatory supporting documentation uploaded during the CIPC filing process. The filer confirms they have received full and accurate BO details from the entity and are acting within the bounds of their appointment.

Practical Example:

A Johannesburg tech startup failed to update its beneficial ownership register after onboarding a new investor holding 10% shares. During an audit, this omission triggered a compliance investigation, delaying their funding round by several months.

Case Law:

In the landmark case **Ex Parte Gore N.O. and Others 2013 (3) SA 382 (WCC)**: Courts may pierce the corporate veil to reveal individuals behind company wrongdoing, reinforcing the need for accurate individual BO disclosure.

Practical Example:

A Durban-based manufacturing firm submitted incomplete shareholding documents to CIPC and failed to provide a delegation of authority letter for the filer. CIPC rejected their filing, causing the company to miss a critical tender deadline.

n the landmark case **Ex parte Greeff 1988 (3) SA 751 (C)**: Emphasises transparency in ownership and effective control for regulatory oversight.

This template is designed to help entities capture and submit the full beneficial ownership details of trusts as beneficial owners, including trustees and beneficiaries, for compliance with CIPC requirements under the Companies Act and related regulations.

Explanatory Note:

The filer must be duly mandated in writing by the trust (or its representative) to submit the BO information. All supporting documentation, including trustee and beneficiary details, must accompany the filing. The filer confirms they have accurate and complete trust information.

Case Law:

In the landmark case *FIC v Tannenbaum (2020)* – Enforcement action for failure to disclose true beneficiaries led to asset freezing and criminal proceedings under the Financial Intelligence Centre Act.

RED FLAGS AND COMMON MISTAKES

Ensuring your Beneficial Ownership (BO) register is accurate and compliant requires vigilance. Many companies stumble on avoidable pitfalls that can cause regulatory headaches, delays, and penalties. Recognising these red flags early will help you stay ahead.

Red Flags to Watch For:

- ✘ **Incomplete or outdated BO data**, failure to update changes **within 10 business days** undermines compliance and can trigger penalties or deregistration.
 - ✘ Use of **nominee shareholders or directors without disclosure**, concealing the real beneficial owners creates transparency issues and regulatory suspicion.
 - ✘ **Complex ownership chains without clear documentation**, layered structures without clear, updated ownership diagrams raise compliance risks.
 - ✘ **Submission without a valid signed mandate**, filers must have written authorisation from the declaring entity; otherwise, submissions may be rejected.

✗ Missing or uncertified supporting documents — all ID copies, mandates, and ownership registers must be certified and current (within 3 months).

✗ Ignoring foreign beneficial owners, non-resident owners must also be disclosed with appropriate documentation.

✗ Misclassification of interest types, confusing voting rights, contractual rights, and other controls can result in inaccurate filings.

✗ Failure to file through the CIPC e-portal, manual or paper submissions are not accepted for BO data and cause delays.

Common Mistakes to Avoid:

✗ Neglecting to maintain a physical BO register at the registered office, as required by law.

✗ Using outdated templates that do not meet the latest Companies Amendment Regulations (2023).

✗ Overlooking the filing threshold (e.g., not disclosing beneficial owners holding over 5%).

✗ Delayed filings resulting in frozen accounts, tender disqualifications, or reputational damage.

✗ Assuming listed companies are exempt from filing beneficial ownership data, they are not.

✗ Failure to understand the different roles within trust ownership (trustees, settlors, beneficiaries) **leading to incomplete disclosure.**

✓ To avoid these issues, maintain an up-to-date register, certify all documents, ensure valid mandates, and file promptly via the CIPC portal.

By proactively addressing these red flags and common mistakes, you reduce your company's risk profile and demonstrate robust governance to regulators, investors, and partners.

FREQUENTLY ASKED QUESTIONS

Who is required to submit Beneficial Ownership information?

All companies and close corporations registered in South Africa, including listed entities, must maintain and submit up-to-date Beneficial Ownership registers to the CIPC.

What is the filing threshold for declaring beneficial owners?

Any individual or entity holding more than 5% of the beneficial interest in the company must be disclosed.

How often must Beneficial Ownership information be updated?

The register and CIPC filings must be updated within 10 business days of any changes in ownership or control.

What supporting documents are required for filing?

Certified copies of IDs or passports (dated within 3 months), a signed mandate authorising

the filer to submit on behalf of the entity, the completed BO register, and, where applicable, a diagrammatic ownership structure.

Can a third party file on behalf of the company?

Yes, but only if they have a valid, signed mandate from the company or close corporation, signed by at least 50% +1 of directors (or all members in a CC).

Are trusts required to disclose their trustees and beneficiaries?

Yes. Trust structures require detailed disclosure of trustees, settlors, beneficiaries, and any other individuals with control or significant influence.

What happens if a company fails to comply?

Non-compliance may lead to penalties, delays or refusal in issuing compliance certificates such as Letters of Good Standing, or deregistration of the entity.

Are foreign beneficial owners subject to the same rules?

Yes. Foreign owners must also be disclosed with the same level of detail and supporting documentation.

What if my ownership structure is complex?

In complex structures involving multiple layers or entities, a diagrammatic ownership structure should be prepared and filed to clarify control and ownership paths.

How often must the Beneficial Ownership Register be updated?

The register must be updated within 10 business days of any change in ownership or control, and always before submitting your annual return.

Do filing requirements differ for listed companies?

Yes. Listed companies must also submit beneficial ownership information but use a separate CIPC portal tailored for them.

What happens if incorrect or false information is submitted?

Submitting inaccurate or misleading information can lead to administrative penalties, criminal charges under the Companies Act and FICA, and reputational damage.

Who can file on behalf of the company?

Only individuals with a written mandate from the company, signed by the appropriate directors or members, may file beneficial ownership information.

How should sensitive personal information be handled?
