POLICIES

Securing appointment date

Your appointment date(s) and (services) will be secured when the signed contract and deposit have been received.

Deposit

All reservations with parties of up to 5 people must be reserved and guaranteed with a \$50 deposit. Parties of 6 or more must be reserved and guaranteed with a \$150 deposit. The reservation will be cancelled if the deposit and signed contract are not received by the due date. Deposits for reservations cancelled with at least 30 days notice will be refunded. Deposits for reservations cancelled between 14 and 30 days notice will be refunded 50%. Deposits for reservations cancelled with less than 14 days notice will be forfeited.

Parking or other fees

All extra fees incurred the day of the wedding due to location/transportation will be added to the Total amount due. Please plan ahead for any parking fees to be covered. This includes valet services at The Renaissance.

Payment

Remaining balance is due the day of service. Prices are subject to change as styling needs change or services are added. We accept cash, Venmo, Square cash, credit/debit.

Contract or appointment changes

Reasonable changes will be accepted up to 14 days prior to the service date. After 14 days the contracted amount will be the minimum amount due.

For parties up to 5 people: you may reduce the number by no more than 1.

For parties of 6-10: you may reduce the number by no more than 2.

For parties of 10 or more: you may reduce the number by no more than 4.

Late arrivals

If the wedding party is more than 15 minutes late the party will be charged an additional \$15 late fee for each guest serviced. This applies to the service start time, not the arrival time. I strongly suggest appointing someone to be in charge of making sure there is always someone in the chair from the agreed upon Start Time until all services are complete.

Cancellations

We do require 14 days notice for all cancellations. In the event that a reservation is cancelled less than 14 days prior to the reservation date, 50% of the remaining balance will be due by the original reservation date.

Cancellations due to emergencies will be considered on a case-by-case basis, and are completely at the stylist's discretion.

Reminders/tips for wedding party:

- Wear a button down or zip up shirt, something that will not have to go over your head
- DO NOT shampoo your hair within 12-24 hours of your appointment (unless you are receiving a shampoo/blow dry style) Working with the hair's natural oils, and a little texture allows for a cleaner finish to your wedding style. There will be an **additional charge** for any updo/down-do that requires blow drying before the hair styling.
- Arrive on-time with clean-ish, **dry** hair and parted where you prefer.
- Picture aids are the best way to ensure that you will receive the look you want from your stylist. Remember time will be of the essence so tell your party to have them readily accessible.
