Security Cameras. Are being permitted under the guidlines in, the documents. They must be mounted inside the unit living room/kitchen. They can be mounted on a window area looking out to the driveway/walkway only. Cameras are not permitted, positioned in any way that would record a view of another unit.

Exterior Lighting: Solar pathway lighting is subject to ARB approval and is only permitted for units ending in 1 and 4. Solar lights are allowed from the front of the unit 1 and 4, a maximum of 4 solar lights are allowed. Lights must be black. Maintenance of the lights are the sole responsibility of the

Unit Owner.

Guidelines will be incorporated in the Condo 1 Rules and Regulations.

ARB Procedure: There is an ARB Drop Box in the Club House and is marked Condo 1 ARB only. Further discussion is needed in the procedure, we are going to adapt, for collecting the ARB's. All ARB must have all the supporting documents for approval,

Insurance Rates: Linda Maxwell is going to organize a meeting with Gulf Shore Insurance to explain the changes, this will be early October.

Budget Items: Kris will email figures todate for the 2022 Budget. We are waiting for the Master Association to present their figures for us.

Any Other Business: Beverely reported that the grass need some attention, too may weeds. LD replied that J&K would be notified.
