

# Dependable Trash Out / Junk Cabbie

## Official Compliance Statement: Private Property Cleanup and Self-Haul Operation

Dependable Trash Out / Junk Cabbie operates strictly as a **private-property cleanup and self-haul service** within the City of Victorville. Our activities are **not part of any refuse collection franchise** and are fully consistent with the self-haul provisions recognized under **California Public Resources Code §40059** and **Victorville Municipal Code §6.37.080(D)**. We do not engage in the collection, placement, or servicing of stationary bins, dumpsters, or debris boxes within city limits. Instead, all debris removal is performed as a **one-time, labor-based cleanup** in which our crew loads unwanted materials directly into our own truck or trailer and **immediately transports them** to a **County-approved disposal facility**—typically the San Bernardino County Victorville Landfill located at 18600 Stoddard Wells Road. This service is **private in nature** and constitutes **self-haul transport on behalf of the property owner or occupant**, not a municipal solid-waste collection activity. No containers are left on-site, no recurring routes are established, and no activity is performed that infringes upon the exclusive collection rights granted under the City’s Franchise Agreement with Victorville Disposal Inc. (Burrtec Waste Industries). Accordingly, Dependable Trash Out / Junk Cabbie remains in full compliance with: The City of Victorville’s exclusive-franchise provisions; Applicable sections of the Victorville Municipal Code governing solid-waste management; and The County of San Bernardino’s regulations for lawful waste disposal at approved facilities.

### Equipment Placement Compliance Policy

To maintain full compliance with the City of Victorville’s exclusive solid-waste franchise provisions, Dependable Trash Out / Junk Cabbie strictly limits the placement and use of its dumpsters, roll-off containers, and trailers within city limits. During any cleanup operation, our equipment is used **solely as active loading apparatus** under the direct supervision of company personnel. All containers remain on-site **only while cleanup work is actively being performed** and are **removed immediately upon completion** of the loading process. At no time are dumpsters, roll-offs, or trailers: Left unattended or made available for self-service use by a customer, Stored overnight or for extended periods on private or public property within the City, or Utilized as stationary collection bins for later pickup. This live-loading policy ensures that all on-site container use is classified as **temporary operational equipment**, not as a “collection container” under the City’s franchise definitions. By adhering to these restrictions, Dependable Trash Out / Junk Cabbie continues to operate fully within the **self-haul and private-cleanup exemptions** recognized under California Public Resources Code §40059 and Victorville Municipal Code §6.37.080(D).
