1. Dog boarding £30.00 per 24 hour care.
2. Day care (up-to 9 hours) £25.00.
3. If cancelled less than 14 days before the booking the full fee, for the stay, will be charged.
4. In unexpected cases if your dog is excluded, or leaves, before the full stay is up, the full charge will still be invoiced.
5. All bookings are by appointment only. Drop off / collection times as follows:  
     7.45-10.00 & 16.00-18.30 Monday to Friday  
     8.00-10.30 & 16.00-18.30 Saturday and Sunday
6. Food to be supplied and stored in a non permeable sealed container. Food is not to arrive in plastic bags.
7. Proof of vaccinations to be submitted before any stay.
8. When dropping your dog off you must drive into the driveway.  
     No responsibility will be taken if dropped off outside of the gate.
9. Invoices are issued at the end of each month; payment within 14 days via bank transfer.
10. Licensed to board dogs by Rushcliffe Borough Council ref: AWL0029 - 5 Star Rating
11. IMDT Level 3 Award in Professional Canine Daycare and Boarding
12. Fully insured to £15,000 to cover care, custody, control or injury in our care
13. Public liability insurance £5,000,000. Documents can be provided upon request
14. First aid trained for dogs Level 3
