

Registration Guidelines & Terms of Use and Conditions

RemedyBlox' Weekend Empowerment Retreats

(Last Update: As of January 1, 2020)

Enrollment and participation in any Weekend Retreat Programs delivered by RemedyBlox is governed in accordance to THESE TERMS & CONDITIONS listed herein. It is imperative that before anyone registers for any Retreat Program offered by RemedyBlox that they read these Terms and Conditions carefully. If at any time one does not agree with the following TERMS of USE or CONDITIONS in part or in full, then they should not proceed with completing a registration request for the retreat programs which RemedyBlox offers in Canada and the US. If at any time one proceeds to register for a Weekend Retreat Program with the intention to attend in person then that shall constitute as these Terms of Use and Conditions having been read in their entirety and have been also understood and agreed to by every registrants that attends a RemedyBlox Weekend Retreat Programs.

Participation in any RemedyBlox' Weekend Empowerment Retreat is restricted to adults 19 years and older due to the sensitive and adult appropriate content being covered throughout the program event. Retreats are structured to accommodate up to 20 participants with a minimum of 12 registrants per event program. The all-inclusive weekend retreats are typically offered over a 3 days and 2nights stay at the retreat venue location (unless otherwise specified in advance) and typically scheduled to start on a Friday afternoon and end by Sunday afternoon.

Retreats are offered across Canada and the USA – and venue locations and dates are selected according to advanced expressed interest by at least 12 persons. Meaning if we receive interest for a particular retreat program (e.g., "Dealing with a Difficult Divorce") where the majority of individuals looking to attend that retreat are located in the North West part of Canada and wanting to attend in the Spring - then the retreat venue to be secured might be in Banff, British Columbia during the month of March. Conversely if majority of US registrants who contact us are located in the North West part of the continent and the majority want to attend in the Fall – then the venue location and date to be secured might be in September at a venue located perhaps in Big Sky, Montana. Booking of any venue location is also contingent on availability by the venue which is why we encourage those interested to attend a particular retreat program to register early on. That being said, for those who do not have a preference for a date or location of where a particular weekend retreat program may be held – we encourage them to reach out to us in writing to discuss them attending that Retreat Program instead.

Each retreat is held at 5-Star venues that offer a luxurious serene hotel resort setting and a spa atmosphere conducive to the holistic retreat program goal where activities are structured to offer healing and rejuvenating to the participants' body, mind and soul.

Due to the sensitive and private nature of some of the particular topics of discussion at our retreats we have privacy measures put in place to afford each participant with an enhanced level of anonymity and confidentiality during their resort stay to allow for open dialogue and opportunity to speak freely.

We also offer participants with the option of using an "alias" for their first name throughout their participation in the retreat program if they wish to keep their identify private. Furthermore, to protect participants' privacy we also require that no personal mobile phones or any other mobile devices equipped with recording by audio or video to be brought inside any program or group sessions or activities that RemedyBlox holds at the resort.

All participants will also be required to sign a non-disclosure agreement before participating in the Retreat Program they are enrolled, to ensure all in attendance agree in advance not to take any photographs or to record anyone during their stay at the retreat so that everyone's expectation of privacy is met. As such no cell phones or mobile devices are allowed to be brought inside or used during any of the retreat activities or group discussions held.

Anyone needing to make a phone call or needing to communicate by email during their stay at the hotel shall use the hotel's guest services, landline phones provided in the lobby or use their mobile devices inside their own hotel room and/or use computers found in the hotel's business services area. Furthermore, all registered retreat participants agree not to take any photos of any other retreat participant or to secretly record any parts of a conversation or what others might say or disclose during any part of the retreat program.

RemedyBlox empowerment retreat locations and names of those in attendance are to be kept in strict confidence by all registrants and at no time shall the location nor the dates of an upcoming retreat be publically posted, advertised or disclosed to the general public, the media or third parties by RemedyBlox staff, trainers, guest speakers or any of the retreat program participants. It is also understood and agreed by all who register and attend the retreat they will not publically share, disclose or post any details about the retreat program on any social media platform, in any public forum or reveal any details of the retreat program or its activities or discussions to any third party at any time for whatever reason.

The reason for keeping the retreat and its program details protected from public disclosure is to create a safe space for participants who need their privacy protected while at the same time to feel at ease and comfortable to speak openly about sensitive issues to achieve the cathartic release, gained closure and therapeutic healing the retreat aims to deliver.

That being said, privacy protections and expectation of privilege among all in attendance at RemedyBlox Weekend Retreats is limited and not guaranteed. Specifically, if at any time anyone attending the Weekend Retreat Program reveals or says something that would indicate they have the means, opportunity and motive to commit a criminal offense, or revealing they want or plan to cause themselves or someone else any harm, serious injury and/or death - then such disclosure shall not be deemed privileged and shall be reported and disclosed to the proper authorities for intervention. Also, if at any time any participant during the Weekend Retreat Program reveals having knowledge of a child, a senior or someone other whether vulnerable or not – as being in imminent present or future danger or at risk of any type of harm, threat of injury and/or death or having been killed then such disclosure shall be immediately reported to the appropriate authorities for their intervention deemed appropriate including the person who made such a disclosure to have their identity revealed to the authorities as well.

In respect to participation at any Weekend Retreat Program is deemed totally voluntary and each registered member holds the sole discretionary right to opt out of and not partake in any of the Program activities and/or educational sessions being offered to the participants. In the event someone opts out to not participate for whatever reason they can do so by excusing themselves from that session or activity and return later on to participate in another program activity.

Furthermore, all registered members who volunteer on their own volition to partake in any activities or educational platforms offered during the Weekend Retreat Program they enroll in – shall do so within their own limits and capacity including at their own assumed risk of harm or injury and shall indemnify RemedyBlox and any of its owners, affiliates, subsidiaries, shareholders staff, clients, volunteers, contractors, vendors, suppliers, creditors, lenders, third-party members or whosoever responsible or liable for any of their incurred or sustained losses, harms, injuries or damages whatsoever that may arise or they sustain during the participation at the Weekend Retreat Program.

In respect to our universal accommodation standards – any persons with disabilities requiring electronic assistive communication devices during the workshops and/or program activities is asked to please contact us in writing in advance to advise us of their accommodation needs so that we have the needed time to arrange for all reasonable accommodations prior to the program start date.

We also are committed to making our retreat programs accessible to all and we ask that anyone requiring special accommodations based on a disability, dietary restrictions or particular ethnic/religious/personal observances to communicate their accommodation needs to us in writing. Due to the logistics involved we require advance notification of all reasonable accommodation requests at least 30 days in advance of the retreat start date to afford us the time needed to incorporate the accommodation arrangements into our retreat program, meals served and activities schedules so as to make the retreat as accessible as possible to all in attendance.

STEP 1: Inquiries and Expression of Interest for a Particular Weekend Retreat Program

- i. Please contact us in writing using the online link on our "Contact Us" webpage or by email at: <u>info@remedyblox.com</u> to express your interest to attend a particular weekend retreat program listed on our website.
- ii. When contacting us we ask that you identify the particular retreat program you want to attend including your preference for the retreat location and scope of timeframe / date(s) you prefer and also which dates you would not be available to attend.
- iii. Upon receipt of your expressed interest to attend a specific "Weekend Retreat Program", we will notify you by email of the next steps including plans for where and when we are planning to hold that retreat.
- iv. Please note Remedyblox only secures the hotel venue for a particular retreat program after there is a minimum of 12 individuals registered to attend the program in a particular location and during a timeframe that meets their availability to participate.
- v. A registrant is considered as confirmed only after their registration form and payment in full for that upcoming retreat has been received by RemedyBlox and a confirmation slip with proof of payment slip has been issued.

STEP 2: REGISTRATION PROCESS

- i. Registration requests for a particular Weekend Retreat Program need to be submitted in writing to RemedyBlox using either the online link on our "Contact Us" remedyblox.com webpage or by email at: info@remedyblox.com.
- ii. We send a registration form by email that we require completed and returned to us in advance of the start date of a particular Weekend Retreat program that one plans to attend. (Typically the registration form needs to be returned to us at least 30 days before the anticipated retreat start date.)
- iii. Upon receipt of your completed registration form for a specific "Weekend Retreat" we will reply by email on the next steps.
- iv. Since our weekend retreat programs are limited to 20 participants only the first completed 20 registration forms received for a particular program and location RemedyBlox shall be considered for the next stage of finalizing the registration process.
- v. The final stage of the registration process entails payment in full to be issued to RemedyBlox.
- vi. We will issue an email request for payment for that particular retreat program which needs to be issued in full within 5 business days via PayPal.

- vii. If payment is not issued by the individual or it has not been cleared by PayPal in time we will notify the individual on the next steps to finalize their registration with the required payment without delay or otherwise we will release their space to the next person on the waiting list who is interested in attending and is in the position to submit their payment via PayPal by the identified deadline.
- viii. If a group reaches maximum capacity of 20 confirmed registrants any remaining individuals who expressed interest to attend in that retreat program shall be notified that the group limit has been reached. They will also be asked if they wish to be placed on a waiting list so we can notify them as soon as a space might become available for the particular retreat program they wanted to attend (or) when that retreat program will be offered again on another date and/or at the same or a different venue location.
- ix. Anyone who accepts to be placed on our waiting list will receive priority to register for an upcoming "Weekend Retreat" programs on the subject matter that they previously identified to us as being of interest to them.
- x. Individuals can opt-out at any time from being on a waiting list. Those who no longer wish to be on a waiting list or who no longer want to be notified by email of upcoming retreat openings need to email us at info@remedyblox.com or simply select the "unsubscribe link" on the bottom of the last email notification they received from RemedyBlox about an upcoming retreat program.

NOTE:

- a. Anyone who is placed on a waiting list shall always retain the sole right to choose whether they want to proceed with finalizing their registration when a spot becomes available in a retreat program.
- b. Being placed on a waiting list does not constitute an absolute right or expectation to be automatically registered for any weekend retreat program.
- c. Any member placed on a waiting list further understands and agrees that being placed on a waiting list does not entitle them nor does it offer them any special price discounts in the future. Instead, all parties who wish to register for any upcoming "Weekend Empowerment Retreat" shall be subject to the exact same terms and conditions of the registration process applicable to all other registrants.
- d. Only those individuals who respond in writing that they are interested to proceed with registering for a retreat program opening and who submit their payment in full over PayPal when requested of them by RemedyBlox shall have their registration request finalized and a confirmation slip issued.

STEP 3: CONFIRMATION OF REGISTRATION

- i. Once payment for a particular Weekend Retreat Program has been made in full via PayPal by the 5 days deadline and funds have been cleared by PayPal – RemedyBlox will issue a registration confirmation slip by email as well as communicate all other logistics about the upcoming retreat program, its location details, hotel room bookings, etc.
- ii. Only those who receive an official registration confirmation slip along with proof of payment slip from RemedyBlox shall be considered as confirmed registrants able to attend the upcoming Weekend Retreat Program.
- iii. Our confirmation notice will also reconfirm the location and dates and time of the program.
- iv. We ask that each registrant brings these two slips with them to the retreat and present it to our registration desk team who will be processing the sign-in and admission into the retreat program.
- v. For logistical reasons and privacy concerns there will be no opportunity for anyone to register "at the door" on the day the Weekend Retreat Program start date. Also anyone not confirmed as registered shall be denied entry into the retreat program including restricted from attending or participating in any of the retreat program events or activities whether as a participant or as an observer.

STEP 4: OTHER TERMS AND CONDITIONS

i. If someone is planning to travel out of province/state to attend a particular RemedyBlox weekend retreat program they will need to make their own arrangements for out-of-province medical / travel medical insurance as the price for the RemedyBlox weekend retreat does not include any health or travel insurance coverage for any individual retreat participants.

Payment Guidelines

- i. All payments for any retreat programs offered by RemedyBlox must be made using the secure PayPal service payment platform and issued by the identified timeframe (e.g., typically within 5 business days).
- ii. RemedyBlox does not accept any cash payments or cheques or money orders in person or sent by regular or registered mail to RemedyBlox at any time or under any circumstances for any of its "Weekend Retreat Programs" or otherwise.
- iii. Anyone who attempts or proceeds to make a payment for a Weekend Retreat Program in person or by sending a payment in part or in full by mail whether by cash, cheque or money order shall not have their payment accepted or processed by RemedyBlox.
- iv. All payments must be issued in US dollars currency using PayPal service payment platform.

- v. RemedyBlox also does not accept nor recognize any other forms of currencies or e-tenders such as bitcoin or any other forms of electronic payments as form of payment for any Retreat Programs being offered.
- vi. RemedyBlox hereby notifies all that any payments that are sent to us in part or in full outside of PayPal payment platform whether or not such payments are received by RemedyBlox shall deemed as forfeited funds in full at the issuers own assumed risk including as it pertains to any and all direct/indirect or associated losses they might sustain as a result of their payment being not being recognized or accepted by RemedyBlox.
- vii. Furthermore, anyone who issues payment outside of the requested and identified PayPal Service Platform shall be deemed as having understood the consequences which includes them forfeiting any and all expectations for any type of reimbursement or seeking compensatory relief in the future in part or in full from RemedyBlox as related directly or indirectly to the payment amount issued by them to RemedyBlox outside of PayPal service payment platform.
- viii. Furthermore, the issuer of any payments sent directly to RemedyBlox outside of PayPal service platform also indemnifies RemedyBlox from any and all direct and/or indirect losses and/or damages that one may have incurred or claims to have sustained as a result of RemedyBlox exercising its sole discretionary right to not proceed with accepting, processing or returning any payments issued outside of the PayPal service platform and/or for not registering or allowing someone to participate in a Retreat Program who opted to not pay for their place in a Retreat Program using the stipulated PayPal service platform which is the only valid and recognized form of payment by RemedyBlox.
- ix. Any cheques or money orders that RemedyBlox receives in the mail from an individual attempting to pay for an upcoming Retreat Program whether certified or not, shall not be processed. Instead the cheque or money order will be returned to the sender by mail to the return address identified on the original sender's envelope. If no return address is found or known to RemedyBlox then the cheques / money orders will be shredded and discarded.
- x. Each cheque / money order RemedyBlox does return by mail to the issuer shall have a "VOID" mark written across the front to confirm that the payment was not cashed or processed by RemedyBlox. Furthermore, RemedyBlox is released from all responsibility, liability or any other claims if for whatever reason the voided cheque or money order being returned to the sender fails to reach them for whatever reason. Our attempt to return the item to the sender shall be deemed as sufficient and the matter shall be considered as closed and final without prejudice.

EVENT REGISTRATION & ACCESSS

i. AT-DOOR REGISTRATION - NOT AVAILABLE.

- ii. No walk-ins allowed and no "at-door" registration is offered at any RemedyBlox Weekend Empowerment Retreats due to advance logistical fulfilment requirements.
- iii. RemedyBlox reserves the absolute unrestricted right and authority to refuse cash payments at the door on the date of an event for any reason including not to register anyone who had not registered and paid for their spot in full at least 15 days in advance.
- iv. We also reserve the sole discretionary right to deny entry to anyone confirmed as registered in a particular retreat program who arrive late, appear to be under the influence of alcohol or drugs, become boisterous, aggressive, abusive and/or are threatening to others where their behavior and/or presence is believed by RemedyBlox to be disruptive or harmful to others already partaking in the retreat's session or activity.
- v. Refusal of entry to any member to the "Weekend Retreat Program" shall be at the sole discretion and authority of RemedyBlox' free from any liability or responsibility for any direct or indirect costs, damages, losses or harms sustained or incurred by a member who fails to comply with the event registration terms and conditions in part or in full as cited herein.
- vi. The registration confirmation slip and payment confirmation documents we issue to each confirmed registrants are to be presented to our registration desk staff when one arrives for the event.
- vii. These confirmation slips are intended for their sole use by the person they were issued to and whose name appears on the slips.
- viii. At no time can or will any registration confirmation slip be transferred by the individual to whom it was issued to someone other unless with the prior written consent and authorization by RemedyBlox.
- ix. Furthermore, no payment made in part or in full for any "Weekend Retreat Program" shall be transferred by the payee to any other person at any time for whatever reason without the prior written authorization and consent issued by RemedyBlox.
- x. Confirmed registration slips must coincide with the date and location for which they were issued. Confirmation slips cannot be transferred from one Retreat Program to another or used for some other Retreat Program in the future. Anyone caught attempting to misuse their confirmed registration slip for another Retreat Program shall not only be denied entry but will also forfeit any compensatory or financial relief including not be entitled to any refund in part or full for any payments they may have made to RemedyBlox to attend the Retreat Program.

Cancellation & Refund Policy

All cancellation requests must be submitted in writing by email to RemedyBlox at: info@remedyblox.com where the following terms and conditions apply:

Cancellation Request Received 30 Days or more Prior to Retreat Start Date:

- Cash Refund in Amount Paid - Minus 10% Processing Fee -

A cash refund for the full amount paid minus 10% processing fee shall be issued by RemedyBlox through PayPal.

i. Any cancellation requests received 30 days or more prior to the start date of the "Weekend Retreat Program" RemedyBlox shall issue a full refund of the amount the individual paid to RemedyBlox using PayPal for the particular Weekend Retreat Program, minus a 10% processing fee which is deducted from the total amount paid by the registrant who is no longer able to attend for whatever reason.

Cancellation Requests Received 15 to 29 Days Prior to Retreat Start Date: - No Cash Refund/Only 50% Refund Issued in the Form of Credit Voucher -

- i. No cash refund issued a 50% refund in the form of a Credit Voucher will be issued.
- ii. Any cancellation requests we receive by email from 15 days up to 29 days in advance of the Retreat Program start date we will offer a 50% refund in the form of a Credit Voucher. The value amount of the Credit Voucher is 50% of the total amount the individual paid for that particular weekend retreat program which they can no longer attend or participate in for whatever reason.
- iii. The value of the Credit Voucher shall be kept on file by RemedyBlox for the member who is the only one authorized to redeem it by applying its value against the cost of another similar Retreat Program to be offered in the future.
- iv. The individual reserves the right to choose which upcoming "Weekend Retreat Program" they wish to register for and attend in the future.
- v. The individual who wishes to redeem their Credit Voucher value amount against the purchase of another "Weekend Retreat Program" in the future as offered by RemedyBlox and where that Retreat Program cost exceeds the Credit Voucher value amount they are trying to redeem, then the difference in the amount shall be issued to RemedyBlox by PayPal payment service platform by the identified payment deadline.
- vi. In the event the Credit Voucher value amount is more than the cost of an upcoming "Weekend Retreat Program" the individual wants to attend then RemedyBlox will convert the remaining amount into an new "Credit Voucher" that the individual can apply against the price of another future Weekend Retreat Program.

- vii. A \$10 processing fee is applied against the value of the Voucher Credit being redeemed.
- viii. The \$10 processing fee will be deducted by RemedyBlox from their "Credit Voucher" amount value at the time it is redeemed where the remaining amount shall be applied against the purchase of the newly selected "Weekend Retreat Program" cost.

Cancellation Request Received less than 14 Days of Retreat Start Date:

- No Refund Issued and No eligibility for Credit Voucher -

- i. Unfortunately any cancellation requests received 14 days or less of a Weekend Retreat Program start date are exempt from any cash refunds and also are non-eligible for any Credit Voucher redemption in part or in whole.
- ii. Anyone who has been confirmed as registered and who has paid in full for a particular "Weekend Retreat Program" which they cannot attend for whatever reason still need to contact us by email at: info@remedyblox.com to discuss if they would like to send someone else in their place.
- iii. Before RemedyBlox can consider accepting a replacement we will need to ensure that the person being identified holds similar life experiences and same interests of the group members attending the Retreat for whom the program has been specifically created and customized.
- iv. RemedyBlox will need to be given the full name and contact details of the individual being sent as a replacement so that we can process their registration accordingly before the start date of the Retreat Program and also verify that this type of Weekend Retreat Program is suited for them.
- v. If during our discussion with the person being suggested to attend as a replacement, we discover that they do not hold similar interest or do not share similar experiences of the other group members then we hold the sole discretionary right to not permit them to attend or to participate in the Weekend Retreat Program as it would not be conducive to the other retreat participants.
- vi. Furthermore, if no suitable replacement can be found for the individual who has cancelled their registration then it is understood and agreed that no cash refund or Voucher Credit shall be issued by or become the responsibility of RemedyBlox. Any losses anyone incurs who decide to cancel their registration 14 days or less of a Retreat Program start date shall be their solely their own where RemedyBlox shall not be held responsible in part or in full to compensate or reimburse any moneys they may have paid previously.
- vii. RemedyBlox will also not accept any last minute walk-ins on the starting date of the "Weekend Retreat" by anyone arriving unregistered and claiming they will be taking the place of someone who has been confirmed but is unable to attend. This rule is strictly applied as all participants need to be vetted and processed in advance by RemedyBlox for each Weekend Retreat Program as all course materials and activities are customized and structured specifically to the group members in attendance for their maximum benefit.

Credit Voucher Terms of Use

"Credit Vouchers" issued by RemedyBlox are Non-Accumulative and Non-Transferable and limited in their use as follows:

- i. The 50% Credit Voucher issued by RemedyBlox in lieu of cash refund is non-accumulative where the value amount of only one 50% Credit Voucher can be applied and used at any given time against another "Weekend Retreat Program" in the future.
- ii. At no time shall any member be permitted to accumulate the value of multiple Credit Vouchers (their own or another member's) with the goal or intention to attempt to compile and use the total value amount of multiple Credit Vouchers to pay for a single or multiple "learning platforms" being offered by RemedyBlox.
- iii. Only one Credit Voucher can be used at a time against the fee of one single Weekend Retreat Program.
- iv. Should the value of the Credit Voucher value amount be less than the Retreat Program fee then the outstanding balance owed shall be paid to RemedyBlox by the member according to the above noted policies and guidelines governing registration and payment processes via Pay Pal.
- v. In the event the 50% refund value amount of a Credit Voucher is greater than the Weekend Retreat Program fee then the residual balance remaining shall be commuted into a new Credit Voucher which the member can use again in the future against the purchase of another one single "Weekend Retreat Program" of their choice. Credit Voucher amount roll-overs can continue until such time the full value of the Credit Voucher has been exhausted.
- vi. Any Credit Voucher that a member may hold on file with RemedyBlox is deemed non-transferable to any other member or members unless with the prior expressed agreement and written authorization issued by RemedyBlox.
- vii. At no time can any member offer to sell to anyone or attempt to redeem the value amount of their Credit Voucher for monetary exchange which they hold with RemedyBlox as these Credit Vouchers hold no actual cash value except in the sense of the value amount being used against the identified costs and fees of a single "learning platform" being offered exclusively by RemedyBlox.
- viii. A member that fails to use their available Credit Voucher value amount as specified herein in the above paragraphs, whether in part or in whole within a 2 years period of the date the Credit Voucher has been issued to them by RemedyBlox, the remaining amount value for that Credit Voucher shall be deemed to have been abandoned and forfeited in full by the holder of the Credit Voucher and they will hold no further rights to claim any further compensatory relief for any amount lost through the expiration of the Credit Voucher.

- ix. The amount and value held by a Credit Voucher shall cease to exist and be deemed no longer valid holding no monetary value on the same day if and when should RemedyBlox stop operating in full or in part or having decided to stop offering the "Weekend Retreat Programs" for whatever reason.
- x. Furthermore any Credit Voucher issued by RemedyBlox to a member shall not survive or be deemed as valid after RemedyBlox terminates its business operations or educational programs or weekend retreats in part or in full for whatever reasons at its sole discretion.
- xi. Furthermore, any individual who may hold any Credit Voucher on file with RemedyBlox agrees by accepting such a Credit Voucher issued to them that they shall not make any direct or indirect future claims for compensatory relief nor hold RemedyBlox or any of its owners, affiliates, subsidiaries, shareholders staff, clients, volunteers, contractors, vendors, suppliers, creditors, lenders, third-party members or whosoever responsible or liable for any incurred or sustained losses, harms, or damages whatsoever when redeeming the Credit Voucher as if the value amount becomes voided should RemedyBlox become insolvent, or ceases to operate in part or in whole for whatever reason(s).
- xii. RemedyBlox reserves the full and absolute discretionary right and authority to revoke or void any issued Credit Vouchers it had previously issued to any individual whether in part or in full at any time for whatever reason without explanation.

We at RemedyBlox may amend, update or otherwise change, at any time and without prior notice, any or all of the Terms of Use, the conditions and/or the provisions cited herein.

Please check the contents of these Terms of Use periodically for changes, updates or revisions.
