NENA Treasurers Report prepared and presented by NENA Treasurer, Tim Jones. Chapter balances as of February 22, 2019 are as follows: Checking: \$2,657.06. Savings: \$43,496.18. NENA/APCO Joint Michigan Conference Chris Collom reported. Conference is being held at Mission Point Resort on Mackinac Island May 20-23, 2019. Looking at securing Kalamazoo for the 2020-2021 location. Schedule has been changed to include a super-session every day. Super session presenters include: Adam Timm, Doug Showalter, Katie Donovan, Jim Marshall and Ryan Dedmon. The conference will end at noon on Thursday. NENA Commercial Jim Hansen reported. Recent conversations have all been conference related. Reached out to some different types of vendors like: financial planning, awards, etc. 20 vendors currently registered. State 9-1-1 Committee Marc Gramlich reported. Dispatch training subcommittee audit was held on February 12th with two dispatch centers appealing. Appeals were held on February 21st and both centers were approved at appeal. FTE count for this year is 1963 with 10 centers opting not to apply for training funds.

State 9-1-1 Administrator Cindy Homant reported.

- FirstNet many thanks to the PSAPS who participated in the surveys for the readiness assessment document. Site assessments were done and the readiness assessment document has been completed. Going to be used as a baseline for the phase 2 technology transition document. This was presented at Interop conference and will be presented at Emerging Technology Forum.
- GIS Repository 64 updated MOAs have been received from participating agencies, with 9 still outstanding.
- SMART9-1-1 78 of 84 PSAPs that opted in are live with 6 PSAPs are in the deployment process. \$2.2 million purchase order in place to provide funding for licensing for those who opted in. The Upper Peninsula is deploying Rave Panic in 150 schools.
- Text 2 9-1-1 49 counties and 1 Wayne county service district
- NG9-1-1 Grant \$3,939,670.00 will be the total Michigan allotment. This is up from the \$3,100,000.00 due to states that didn't qualify. Grant allocations are as follows: \$2.6 million for CPE, \$500,000 for last mile fiber, \$800,000 for GIS.
- Emerging Technology Forum April 16-17th at Great Wolf Lodge. Rates of \$75 a night for lodging ends on March 25th

MCDA Chad Chewning reported. PSAP Management training was held in Grand Rapids in January. The training had 62 attendees each day and ended up earning \$26,000 for MCDA. Many thanks to Michael Armitage for his work on the training. The next meeting is April 5th in Isabella County.

MABAS Chad Chewning reported. Huron Valley EMS is now the red center for the state.

<u>9-1-1 GTW report – Joni Harvey, Kay Reynolds, Michael Armitage & Jordyn Sellek</u>

Report provided from group in regards to: Congresswoman Norma Torres and the 9-1-1 Saves Act, NG 9-1-1, and funding.

MLTS - Jordyn Sellek

Legislation was approved in 2011, after several extensions, the deadline is December 31, 2019. Representative Michelle Hoitenga (chairperson of the energy and technology committee) dropped HB 4249 to rescind the requirements. Meeting was had with Representative Hoitenga to address concerns and bill was still dropped. If you have any businesses in your area that it has helped/hurt your delivery of 9-1-1 by having or not having implemented, please get those examples to Jordyn. MCDA has already drafted letter opposing the bill, and Jordyn is requesting that APCO and NENA do the same. Jordyn would like all three organizations to sign the same letter.

Motion made by April Heinze for APCO and NENA to sign on to MCDA letter opposing the legislation, supported by Joni Harvey, motion carried.

denote the Vice President will chair the committee. This specific change is needed to proceed with the non-profit classification.

Motion made by Scott Tallmadge and supported by Karen Chadwick to change bylaws for required IRS language in bylaws, motion carried.
