Regular City Council Meeting  
September 9, 2024

Mayor Gomez called meeting to Order at 6:00 p.m. Present were Aldermen Ms. Sosa, Mrs. Cox, and Mr. Wooldridge, and Mr. Ives. Mrs. Harrison was absent.

The Utility Billing report was presented to the Council.

Mr. Gonzales stated he was going to start cleaning up the streets again. The mower is in the shop and as soon as we get it back, he will start mowing. They started working on pot holes last week.

Mr. Gonzales said Mr. Clayton is working on the renewal application for the wastewater permit and it is due by November 1st.

Ms. Martin gave the City Secretary report.

Mayor Gomez thanked the City employees and Council members for everything they did during the boil water notice. On behalf of the City employees, Ms. Martin thanked the Mayor for being a wonderful leader and a calm head during the emergency.
