Regular City Council Meeting  
July 8, 2024

Mayor Gomez called meeting to Order at 5:30 p.m. Present were Aldermen Ms. Sosa, Mrs. Cox, Mrs. Harrison and Mr. Wooldridge. Mr. Ives was absent.

The Pledge of Allegiance was observed. Mr. Potter led the opening prayer.

Mr. Deggs addressed the Council to request street signs be replaced.

Mrs. Pendley informed the Council that RCAD did not follow the timeline to switch collections and never gave her a new timeline that would work for them. They just sent the information with no warning on July 1<sup>st</sup>. No one is collecting property taxes for the City of Camp Wood at this time because the software company is working on transferring all of the data to the new system. They are working as quickly as possible.

No action was taken on the City Park Improvement Project at this time.

The City employees are in the process of installing the half pipe.

Mrs. Harrison made a motion to initiate a burn ban at this time. Ms. Sosa seconded the motion. All in favor.

Mrs. Harrison made a motion to stay in Stage 5 water restrictions and to allow the Mayor to lower the stage levels without council approval. Mr. Wooldridge seconded the motion. All in favor.

Mrs. Cox made a motion to close 5<sup>th</sup> Street from Friday afternoon until Sunday morning and to approve payment for half of the cost of the port a potty rental for Saturday. Mr. Wooldridge seconded the motion. All in favor.

Mrs. Cox made a motion to allow Mr. Sifuentes to use the parking lot behind the park for goat roping on Friday with the purchase of a permit. Mrs. Harrison seconded the motion. All in favor.

Mr. Wooldridge made a motion to allow the Chamber of Commerce to hold the Old Settlers Reunion at the park. Ms. Sosa seconded the motion. All in favor.

Mr. Wooldridge made a motion to adopt the Resolution rejecting Real Central Appraisal District's 2025 budget. Mrs. Harrison seconded the motion. All in favor.

Discussion on drive by water meters was cancelled at this time.

Mr. Clayton stated a new meter was needed at the spring.

The Utility Billing report was presented to the Council.

Mr. Terry said the new truck is running well.

Mr. Gonzales stated they have started picking up brush again.

Mr. Gonzales said we are not going to have a good hay crop this year.

Ms. Martin gave the City Secretary report.

Mrs. Harrison made a motion to approve all minutes as presented. Mrs. Cox seconded the motion. All in favor.

Ms. Sosa made a motion to approve Financial Statements. Mrs. Cox seconded the motion. All in favor.

Mr. Wooldridge made a motion to approve City bills for payment. Mrs. Cox seconded the motion. All in favor.

Mrs. Harrison made a motion to adjourn. Mr. Wooldridge seconded the motion. All in favor.
