- 1. The parade leaves COQUINA BEACH in BRADENTON BEACH at 10:00am. It will proceed through the 3 island cities, ending at BAY FRONT PARK in CITY of ANNA MARIA.
- 2. All floats and units must be staged by 9:30 AM.
- 3. You must be pre-registered before the day of the parade..
- 4. Entry fee to participate in this year's parade is \$25.00. Please see below.
- 5. A Release Form must be submitted by each entry.
- 6. Float or car must be decorated in colors and style befitting the spirit of Independence Day
- 7. All units with a generator must carry a 5 lb. ABC 2A-10B, C fire extinguisher and must have an annual stamp or be certified by an extinguisher company.
- 8. All units should have a sign or banner indicating who they represent (* See #13 also)
- 9. The firing of black powder is allowed.
- 10. The use of water balloons and high-powered water cannons is prohibited.
- 11. All units must be motorized or peddled. No marching, walking, or equine units can be accommodated.
- 12. No person or organization may charge a fee or request a donation to be on any float or to participate.
- 13. As a Non-Profit 501(c)(3) organization, we cannot allow any activities related to political advertising, solicitation, campaigning, or endorsements.
- 14. All entries into the parade must be approved by the Anna Maria Island Privateers. No exceptions!

Failure to abide by these rules could result in expulsion from the parade and possibility being banned from future Anna Maria Island Privateers Parades

*In the past, the Privateers have not charged a fee to participate in this parade. However, due to rising expenses, the Privateers will be asking for a small entry fee. This fee will be put towards our mission of "Pirates for Kids and Community."
