Please read the following articles of participation.

1. The parade leaves **COQUINA BEACH** in **BRADENTON BEACH** at 10:00am. It will proceed through the 3 island cities, ending at **BAY FRONT PARK** in **CITY of ANNA MARIA**.
2. Staging opens at 8 am. All floats and units must be staged by **9:30 AM**.
3. You must be pre-registered and entry fee paid by 7/3/25. Entry is \$25.
4. A Release Form must be submitted by each entry.
5. Float or car must be decorated in colors and style befitting the spirit of Independence Day
6. All units with a generator must carry a 5 lb. ABC 2A-10B, C fire extinguisher and must have an annual stamp or be certified by an extinguisher company.
7. All units should have a sign or banner indicating who they represent (\* See #11 also)
8. The firing of black powder is allowed.
9. The use of water balloons and high-powered water cannons is prohibited.
10. All units must be motorized or peddled. No marching, walking, or equine units can be accommodated.
11. As a Non-Profit 501(c)(3) organization, we cannot allow any activities related to political advertising, solicitation, campaigning, or endorsements.
12. The Privateers reserve the right to refuse a parade entry from participation. All entries into the parade must be approved by the Anna Maria Island Privateers. No exceptions!

Failure to abide by these rules could result in expulsion from the parade and possibility being banned from future Anna Maria Island Privateers Parades

In the past, the Privateers did not charge a fee to participate in this parade, however, due to the rising cost of expenses incurred to continue to have this parade, we must charge an entry fee going forward.
