### **BREEDING AGREEMENT:**

A \$1500.00 service fee for Grade and \$2000.00 for Registered is required to validate a contract and is due prior to semen being shipped. Incomplete contracts are not validated until all information is supplied. Registries require complete information for any foal to be registered. There is a "1-year live foal guarantee" (fails to produce a single live foal that can stand up alone and nurse unassisted within 24 hours from birth). If your mare doesn't have a live foal in 2025 you can breed again in 2025 for a 2026 foal.

### **SHIPPING AND HANDLING CHARGES ARE PAID TO NEW PARIS EQUINE:**

For shipped semen we charge a \$100.00 fee for collecting plus shipping charges. There is a \$25.00 box fee and the boxes do not need to be returned. If you pick up semen with your own box, the box fee will be waived. These fees must be paid (check or credit card) prior to shipment. **(Checks made out to New Paris Equine Center).**

### **ORDER REQUIREMENTS**

For semen to be shipped on the same day **ORDERS MUST BE PLACED BY 11:00AM EST.** Our collection days are Monday, Wednesday & Friday.

### **IN THE EVENT THE STALLION IS UNFIT TO BREED AND OR DIES**

In the event of the death of the Mare, Mare Owner shall be required to breed to a substitute Mare to the Stallion provided that the Stallion Owner has given advance approval of the proposed substitute mare. No refunds shall be permitted. In the event of Stallions death, infertility, or unfitness for breeding, the service fee, if paid will be refunded.

### **BREEDING SEASON**

The breeding season starts February 15th and ends July 31<sup>st</sup>.

### **SEMEN USAGE**

Use of the semen is limited to the mare covered by this contract. A breeding certificate will be filled out to cover the registration of one foal. Foal registration from this breeding is the mare owner's responsibility.

### **Mare Boarding**

For mares being sent to NPEC for breeding, NPEC will not be responsible, or held liable for death, or any injury that may occur to the mare or her foal during their stay at NPEC.
