For semen to be shipped same day, orders must be placed by 11:00 AM EST.

Collection days: Monday, Wednesday, and Friday.

### ***On-Site AI at Sterling Dreams Inc.***

Mare Owner must complete a mare boarding and breeding contract with Sterling Dreams Inc. All mare care, veterinary, ultrasound, and insemination fees are the responsibility of the Mare Owner and are to be paid directly to Sterling Dreams Inc.

### ***Booking/Breeding Fee Payment Terms***

A \$100 booking fee is due upon signing. Remaining balance is due before ordering semen or mare drop-off at Sterling Dreams Inc. Payments may be made via PayPal (fees to be covered by Mare Owner), check, or cash.

The stallion owner reserves the right to withhold all breeding services and semen shipments until the booking and breeding fees have been paid in full and cleared.

### ***Live Foal Guarantee & Rebreed Policy***

This breeding comes with a Live Foal Guarantee, defined as a foal that stands and nurses unassisted. If the mare fails to produce a live foal in 2027, the Mare Owner is entitled to one rebreed to the same mare - or a substitute mare approved in advance by the Stallion Owner - during the 2027 breeding season.

To qualify for a rebreed:

- The Mare Owner must notify the Stallion Owner within 72 hours of the mare aborting, losing the foal, or producing a non-viable foal.
- A veterinarian's statement confirming the event must be provided to the Stallion Owner within **10 days of that notice**.

All collection and shipping fees for rebreed services are the responsibility of the Mare Owner and must be paid directly to Sterling Dreams Inc at the time of service.

Booking and breeding fees are **non-refundable**.

If the Mare Owner does not request a rebreed during the breeding season immediately following the year of original breeding, all fees and breeding privileges will be forfeited, and this contract will be considered **fulfilled and terminated**.

If a rebreed is carried over into a third breeding season, an additional booking fee and any increase in the breeding fee will apply. **There is no Live Foal Guarantee for third-year rebreeds.**

***Liability & Indemnity***

Marlowe Meadows LLC is not responsible for injury, sickness, or death of mare/foal due to any cause. Mare Owner agrees to indemnify and hold harmless Marlowe Meadows LLC and staff from all related claims or damages.
