BREEDING AGREEMENT:

A \$3,500.00 service fee is required to validate a contract and is due prior to frozen semen being shipped. Incomplete contracts are not validated until all information is supplied. Registries require complete information for any foal to be registered. There is a "1-year live foal guarantee" (fails to produce a single live foal that can stand up alone and nurse unassisted within 24 hours from birth). If your mare doesn't have a live foal in 2027 you can breed again in 2027 for a 2028 foal.

*Send signed contract with check made out to **Watermark Ventures** to, Sterling Dreams 17568 CR 48 New Paris, IN 46553. Please do not pay for shipping costs with the same check as the breeding fee. These charges will be calculated at time of shipment.*

SHIPPING AND HANDLING CHARGES ARE PAID TO STERLING DREAMS INC:

Shipping fees must be paid when order is placed (check by phone or credit card). If you will have a vet or agent calling to order, set payment up ahead of time please.

ORDER REQUIREMENTS

When ordering Frozen semen we ask that it is at least one week in advance of the need. We only have a few shipping containers, so we need to be sure we will have one here to help fill your order in time.

All shipping containers must be returned promptly at the owners expense.

IN THE EVENT THE MARE IS UNFIT TO BREED AND OR DIES

In the event of the death of the Mare, Mare Owner has the option to breed a substitute Mare to the Stallion provided that the Stallion Owner has given advance approval of the proposed substitute mare. No refunds shall be permitted.

SEMEN USAGE

Use of the semen is limited to the mare covered by this contract. A breeding certificate will be filled out to cover the registration of one foal. Foal registration from this breeding is the mare owner's responsibility.

Mare Boarding

For mares being sent to Sterling Dreams Inc for breeding, Sterling Dreams Inc will not be responsible, or held liable for death, or any injury that may occur to the mare or her foal during their stay at Sterling Dreams Inc.

This contract is between the stallion owner and mare owner; Sterling Dreams Inc will not be held liable for any reimbursement of funds.
