#### BREEDING AGREEMENT:

A \$ 1500.00 service fee (multi mare discounts available, call James 260-499-1709) is required to validate a contract and is due prior to semen being shipped. Incomplete contracts are not validated until all information is supplied. Registries require complete information for any foal to be registered. There is a "1-year live foal guarantee" (fails to produce a single live foal that can stand up alone and nurse unassisted within 24 hours from birth). If your mare doesn't have a live foal in 2027 you can breed again in 2027 for a 2028 foal.

*Send signed contract with check made out to Top Shelf to, James Yoder 5300 W 700 S Topeka, IN 46571. Please do not pay for collection and shipping costs with the same check as the breeding fee. These charges will be calculated at time of ordering semen.*

#### **SHIPPING AND HANDLING CHARGES ARE PAID TO STERLING DREAMS INC:**

For shipped semen we charge a \$125.00 fee for collecting plus shipping charges. There is no box fee and the boxes do not need to be returned. **These fees must be paid when ordering semen (check by phone or credit card).** If you will have a vet or agent calling to order, set payment up ahead of time.

#### **ORDER REQUIREMENTS**

For semen to be shipped on the same day **ORDERS MUST BE PLACED BY 11:00AM EST.** Our collection days are Monday, Wednesday & Friday. As stated, above payment is required before or when the order is being placed.

Sterling Dreams Inc is not responsible for lost, delayed or damaged semen during transport.

**IN THE EVENT THE STALLION IS UNFIT TO BREED AND OR DIES**

In the event of the death of the Mare, Mare Owner has the option to breed a substitute Mare to the Stallion provided that the Stallion Owner has given advance approval of the proposed substitute mare. No refunds shall be permitted. In the event of Stallions death, infertility, or unfitness for breeding, and there is no frozen semen available, the service fee, if paid, will be refunded.

**BREEDING SEASON**

The breeding season starts Feb. 1<sup>st</sup> and ends July 31<sup>st</sup> . This was specified by the stallion owner.

**SEmen USAGE**

Use of the semen is limited to the mare covered by this contract. A breeding certificate will be filled out to cover the registration of one foal. Foal registration from this breeding is the mare owner's responsibility.

**Mare Boarding**

For mares being sent to Sterling Dreams Inc for breeding, Sterling Dreams Inc will not be responsible, or held liable for death, or any injury that may occur to the mare or her foal during their stay at Sterling Dreams Inc.

**This contract is between the stallion owner and mare owner; Sterling Dreams Inc will not be held liable for any reimbursement of funds.**
