

**Conditions of Approval**

- If the approved institution wishes to undertake during the currency of the approval the testing of any other category of drugs it should apply to the approving authority for necessary endorsement as provided in Rule 150-B. This approval will be deemed to extend to the item so endorsed.
- Any change in the analytical staff or in the person-in-charge of the testing shall be forthwith reported to the approving authority.
- The approved institution shall inform the approving authority in writing in the event of any change of the constitution of the institution operating under this Form. Where any change in the constitution of the institution takes place, the current approval shall be deemed to be valid for a maximum period of three months from the date on which the change takes place unless in the meantime, a fresh approval has been taken from the approving authority in the name of the institution with the changed constitution.
