#### **Beach Committee**

New materials have been ordered for the swimming area. New lines, markers, booes and Marked swim area.

Sensor lights at beach will be scheduled to turn off at 10:30PM

They will be two garbage cans for our use only.

Beach guard to bring down cans for pick up on Monday mornings.

George and Tony put up new fence on right of way. Had the right of way cleaned up by Swetizer. A lot of nails, boards needed a dump truck in order to remove.

We own the right of way – but do we do not need to maintain – but need to keep in normal order. SWe are responsible and our liability. It is not to be used as storage for beach chairs and umbrella.

If you are to see anyone dumping, call member of board. At the same time advise individual to remove or will call Police for illegal dumping. We are considering adding a light to the right of way with motion sensor.

Town of Westbrook, implementing guidelines to Beach Mooring, guidelines and application are available at Town Hall, or see George Abraham.

### **Council of Beaches**

Town is testing waters in four public beaches. Monday mornings tested, if results come back bad, they test again on Wednesday. If testing is bad beaches are closed for the rest of the week.

Council of Beaches wants now to add private beaches. After testing they can have all beaches closed if water has any kind of bacteria. Legally, they will agree to have all private beaches closed.

We do not want the Town to take our, we will take responsibility to close our own beach. It will be our call if we feel the water is not safe.

Town has charter for November elections for Westbrook Registered voters only.

Dogs on Beach – Clear we own you cannot bring your dogs to the beach. Clean up after your dog is a 12 month rule. We have the power to fine. Once a fine is issued a lien will go on their property. Town's postion No dogs are allowed in public beaches.

Dumping on Private Property – Wetlands not our property dumping is illegal. Also in Association Bylaws, will put sign on Wetlands – No Dumping
