## **Voluntary Participation**

I understand that these activities involve certain risks, including, but not limited to, the possible negligent or reckless conduct of other participants.

I hereby release, waive, and forever discharge them, their heirs, administrators, executors, and assigns, from any claims, demands, actions, or rights of action, of whatever kind or nature, either in law or in equity, arising from, or by reason of, my attendance at, or participation in, events or activities.
