

## **Elite Striking LLC of Liability and Release Form**

This form must be completed by each soccer player (participant). If the participant is under 18-years old, this form must be signed by the participant's parent or legal guardian. No player will be allowed to participate in the Activity (as defined below) without this form, properly executed, and on file.

I, the undersigned, in consideration for my voluntary participation in organized soccer and soccer training (the "Activity"), do hereby willfully acknowledge that my signature below attests to my understanding and agreement that:

I am aware that soccer is a physical, contact, sport that involves the risk of injury. I assume all health risks and hazards associated with my participation in the sport. I am in proper physical condition to participate in soccer practices and games and have no illness, disease or existing injury or physical defect that would be aggravated by my participation. I will inform my coach if this status changes. I further acknowledge that this risk may involve loss or damage to me or my property, including the risk of death, or other unforeseen consequences, including those which may be due to the unavailability of immediate emergency medical care. I will wear properly-fitted and appropriate shoes, and other protective equipment, as provided by soccer rules, to all training sessions.

I should have a current, active, personal injury insurance policy in force, which covers my participation. Under any condition, I am responsible for any and all medical expenses arising from my participation. I have the right and responsibility to inspect the equipment and facilities prior to events and, if I believe that anything may be unsafe, I will advise the coach or supervisor of the condition and may refuse to participate. Participation assumes consent.

I am fully aware of the current global Coronavirus COVID-19 virus outbreak and the inherent risks involved in choosing to participate in a sporting activity, and that participating in the Activity could increase my likelihood of contracting a virus. I understand that I am responsible to check the latest information regarding this virus outbreak. I agree not to participate in the Activity if I have experienced any virus-related symptoms.

I ACKNOWLEDGE THAT I AM VOLUNTARILY PARTICIPATING IN THE ACTIVITY WITH KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS OF INJURY, ILLNESS, DEATH, OR PROPERTY DAMAGE, TO MYSELF OR OTHERS, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES (AS DEFINED BELOW), OR OTHERWISE.

I authorize my photograph, picture or likeness, and voice to appear in any documentary, promotion (including advertising), television, video, or radio coverage of the league or tournament, without compensation.

I hereby expressly release and waive any and all claims, now or hereafter known, against Elite Striking LLC, Icaro De Oliveira, his estate or executor, agents, affiliates, businesses, successors, heirs, and assigns (collectively, "Releasees") from any and all liability arising out of or attributable to my participation in the Activity, including, but not limited to, injury, illness, death, or property damage, whether arising out of the negligence of the Releasees or otherwise. I covenant not to make or bring any such claim against the Releasees, and forever release and discharge the Releasees from liability under such claims.

I shall defend, indemnify, and hold harmless the Releasees against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including reasonable attorney fees, fees and the costs of enforcing any right to indemnification under this Agreement, and the cost of pursuing any insurance providers, arising out of or resulting from any claim of a third party related to the Activities.

**I have completely read this document and fully understand its contents. I acknowledge that I have given up substantial rights by accepting this document, including the right to sue the Releasees, and that I do so voluntarily. My signature attests to this on behalf of myself and my executors, personal representatives, administrators, heirs, next-of-kin, successors, and assigns.**

BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM THE RELEASEES IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, OR ILLNESS, TO YOUR CHILD, YOURSELF, OTHERS OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND THE RELEASEES HAVE THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

As the parent and natural guardian or legal guardian of the participant, I hereby agree to the foregoing Waiver of Liability and Release for, and on behalf of, the participant named above. I hereby bind myself, the minor, and all other assigns to the terms of the Waiver of Liability and Release. I represent and certify that I have the legal capacity and the authority to act for, and on behalf of, the minor in the execution of this Waiver of Liability and Release.
