VENDOR INFORMATION AND AGREEMENT

APPLICATION DEADLINE

January 31, 2023 DEADLINE for Receipt of Vendor Application and Payment of Fee

LATE vendor applications received after January 31, 2023 are subject to availability and an increase in the vendor booth fee to \$400 for Gold Vendor and \$300 for Purple Vendor.

USE OF BOOTH SPACE

Booth assignments will be made only upon receipt of a signed contract and fully paid booth fee. Vendors are restricted to their assigned spaces, and all items, equipment, boxes, or displays must be contained within each assigned space. Once spaces have been assigned, vendors are not allowed to change assignments without approval from the Vendor Coordinator. Vendors are not allowed to remove signs, tables, and/or chairs from another booth's assigned space or to share space with another vendor.

Vendors are required to setup within the assigned space and not to interfere with other vendors. The following practices are prohibited: 1) Using electrical or mechanical apparatus, music, and/or audiovisual equipment that interferes with other vendors and/or conference attendees; 2) Canvassing or distributing any material outside the vendor's assigned space; 3) Subleasing of vendor space; and 4) Using advertisement and/or display of signs outside of the vendor's assigned space without prior approval from the Vendor Coordinator.

CANCELLATIONS AND REFUNDS

<u>No refunds will be given after February 5, 2023</u>. If canceled at the discretion of Carolinas Alumni Chapter, Inc., the vendor will receive a full refund unless the conditions in the Right of Refusal and/or Cancellation section of this agreement apply. There will be no refunds for "No Shows."

RIGHT OF REFUSAL AND/OR CANCELLATION

The Alcorn State University Alumni - Carolinas Alumni Chapter, Inc. reserves the right to cancel this agreement and retain your application fee whenever it discovers that a vendor's product(s) is not as described in this agreement or is incompatible, in the opinion of Carolinas Alumni Chapter, Inc., with the purposes of the Alcorn State University National Alumni Mid-Winter Conference.
