Executive Council Report

The East Coast Region's Executive Council members met with the East Coast Board of Directors on Monday, April 26th. This was the pre-Board of Directors meeting/call, in preparation for their Board meeting on Saturday, May 8th. A post Board meeting/call will be held a couple weeks after their meeting, at a date to be determined.

Normally, the Executive Council report at the annual State conference would include a summary of the business meetings at the APCO International Conference and Exposition. Since the annual meeting of the NC APCO Chapter has been moved to May, this report will most likely be presented to the membership at the September Chapter meeting.

APCO International Conference is August 15-18 at the Henry Gonzalez Convention Center, in San Antonio, Texas. The annual meeting of the Executive Council will be on Friday, August 13th. Attendee and vendor registrations are open. As of April 26th, attendee registrations were around 800, which is about a hundred less that Baltimore, 2019. Vendor spaces are selling well. The Grand Hyatt is the host hotel for the Conference. Other conference hotels are the Marriott Riverwalk and Marriott Rivercenter, the Westin Riverwalk, and the Hilton Palacio Del Rio.

A couple items that will be on the Executive Council meeting agenda include a discussion on the Compassionate Care program, and where it will be housed, and possible policy manual amendments, cleaning up wording on APCO International Senior and Life membership.

Total APCO membership, as of 3/31/2021, is 33,155, up from 31,053 on 3/31/2020.
