APCO Project Retains is a staffing and retention toolkit offered by APCO International. This program utilizes call volume, retention rates, time away from the console (breaks, training, leave time (including FMLA and military leave) to determine staffing levels. You have the option of position coverage or volume influenced, or a combination of the two. Included with the program is an employee satisfaction survey and access to the 2009 Retains Report and the Retains Effective Practices Guide.
