NC APCO Meeting March 11th, 2016 Rowan County, NC

President Thomas called the meeting to order at 11:10 a.m. President Thomas welcomed everyone to Salisbury and thanked Allen Cress with Rowan County 911 and Frank Thomas from Rowan County Emergency Services for hosting the meeting.

President Thomas thanked CenturyLink for sponsoring lunch.

President Thomas introduced the executive board. 1st time attendees, past presidents and RPL's were recognized. Anyone who completes their RPL this year will receive free registration to the state conference.

Ray Gilleland made a motion to dispense with the reading of the minutes. Ronnie Barefoot seconded the motion. Motion carried.

Committee Reports:

Historical Committee:

Randy Surratt has been working on where all of our past presidents worked and has found all with the exception of two. He is still working on this. Several were from the highway patrol.

Frank Thomason reported that from the national level that since the conference last year the national executive board has started formally reviewing all the committees. There are several North Carolina members on those committees. APCO reviewed what the committees did and their missions – many have changed over the years. They planned to leave in place all committees with the exception of one – historical committee. Lin Ford raised her concerns to National along with several others. National has tabled the effort to abolish the national committee.

Frank encourages everyone who is interested in serving on a national committee to check the website or talk with him or President Thomas. There is a committee for everyone.

Pro-CHRT:

Ray Gilleland reported that on a national level they are looking at changing the name of this committee. Locally in North Carolina he has confirmed that telecommunicators are not classified as public safety in our state. We will have to have standards, rules and certifications to even hope to be classified as public safety. At that point we need to get the state legislators on our side. Please see Ray if you are interested in serving on this committee.

Inter-agency Communications:

Lewis Cheatham reported there was a conference call two weeks ago but there is not much to report. They were introduced to Seth Russell who is the new statewide interoperability coordinator (SWIC.) There has not been approval yet for the statewide interoperability plan. There will be a meeting in the next few weeks and there should be more updates then.

<u>911 Board</u>:

Dinah Jeffries was unable to attend the meeting today; however, on behalf of the APCO Board we want to encourage you to make sure you are working on your backup plans. If you don't understand how to set up a backup plan, get with Tina or David to get a copy of sample. There is also documentation on the Boards website. Don't wait until it's too late.

You also need to make sure you are attending the 9-1-1 Board meetings or dialing in each month. PSAPS must have a voice. There are currently discussions in place regarding certification, QA, Standards, Peer Reviews and the funding models. Make sure you are attending and making your voice heard. Don't be silent. If you don't agree with something proposed, make your voice heard. Don't sit and let rules or legislation pass without your voice being heard.

We the APCO Board are in favor of a certification program; however, we are not in favor of limiting PSAPS to follow the Sheriffs Training Certification. We need to have certification programs in place that can fit multiple PSAPS with multiple disciplines.

Candy Strezinski reminded everyone that the deadline for House Bill 512 is July 1st regarding back up plans for your PSAP. If you do not yet have the required back-up plan there is help available Also if you are working on your plan but have not submitted yet, please let David or Tina know.
