Inter-agency Communications: No Report
<u>CJIN</u> :
The CJIN Board met on October 5th and December 7th in Raleigh at the NC Judicial Center.
The two primary points of discussion were the 2017 Executive Report to the Legislature and Body Worn Cameras.
A draft version of the executive report is located on the CJIN Website (www.cjin.nc.gov). There is a lot of detailed information in the report concerning: □ Body Worn Camera's
☐ The LinX system (Law Enforcement Information Exchange) which is managed by the Naval Criminal Investigative Services (NCIS)
☐ The FBI National Data Exchange or N-DEX
☐ The Administrative office of the Courts (AOC) automation plans and
☐ Multi factor Authentication.

Body worn camera data was deemed "not a public record" by legislation last year. (House bill H972) They are now tweaking the legislation to allow it to be released or used by law enforcement agencies

in a training capacity. Representatives McNeil and Faircloth attended the December 7th meeting for a body worn camera workshop to discuss needed changes in the legislation.

Other Discussion points:

LinX system currently covers 84% of the state's population. Only a few counties have not participated yet. It is free for agencies to participate and only requires an MOU to be signed. It contains access to agency RMS and CAD records as well as NCIC, DMV and Dept. of Correction data. It has over 863 million event records and 72 million mugshots.

911 Board:

Mike Reitz reported:

During a December 911 Board work session the topic of updating the state 911 plan was discussed. The last plan was approved 2010, with a proposed plan in 2012 (never approved) and comments to the plan in 2016. The Board is going to form a group with representation from all organizations on the 911 Board to update the plan. The Board would like to have a draft plan by June 2018.

911 Board goals for the upcoming year:

1. Establish Rules/Standards for NG911

The next board meeting will be March 28th in Raleigh.

- 2. Reassess PSAP Cybersecurity / Utilizing Existing DIT Convenience Contracts
- 3. Explore Opportunities to Expand Continuing Education
- 4. Promote EMD Statewide

During the work session, the Board discussed a second grant cycle, or focus, for the upcoming year. Currently the focus is on consolidations and regionalization projects. However, the Board is considering a second focus for PSAP enhancements (expenditures would still fall under current statute). This second focus or cycle would not compete with the primary for grant funding; they would be completely separate. The Board is still looking at this and nothing is finalized yet, so more to come.

Statewide telecommunicator certification will be discussed at a stakeholders meeting in April.

ESInet project is progressing. There has been some confusion concerning the hosted CPE project; hosted CPE is not mandatory. If you have questions regarding this, please see myself or another Board member.

The overflow position policy approved by the Board in March 2017 has caused some confusion. Randolph County has filed an appeal concerning this policy. Their appeal will be heard by the funding committee towards the end of February. Please let me know if you have any questions, comments or concerns with regards to this overflow position policy.

Richard Taylor is retiring at the end of April, more to come on his position replacement as well as a retirement celebration.

Regional Reports:

Region A:

Martin County has finalized construction documents and they will be released for bidding on January 12, 2018. Pre-bid is scheduled for January 25, 2018 and bid opening on February 20, 2018.

Pasquotank County will utilize the Martin County PSAP for their backup. They have a secondary radio project going on which is currently in the tower assessment phase. They have one tower that is partnered with the NCSHP and need to follow the requirements of the newly reinstated tower lease agreement. That phase should be completed soon.

Hyde County was fully consolidated with the Dare regional center on December 6, 2017. The move to Dare was predicated on the cut-over to their new paging system. Both went well, with minor hiccups.

Beaufort County:

• Belhaven Fire Department lost their Assistant Chief in a tragic accident the night of January 19th on the Pungo river in what some are calling the perfect storm. The US Coast Guard, water rescue teams from local fire departments, NC Wildlife, NC Marine Fisheries, Beaufort County Emergency Management, and the Beaufort County Sheriff's Office worked into the night battling 4+' seas and heavy snow with wind chills in the teens to attempt to rescue the Chief. On the afternoon of the 20th the Chiefs body was recovered. Everyone please keep the members of the Belhaven Fire Department and the many responders including Beaufort County 9-1-1 team in your prayers.

- Will Caputo was promoted to assistant director on January 15th.
- Summer Hopkins was promoted to shift supervisor on February 15th.
- Linwood McLawhorn was promoted to shift supervisor on February 15th.
- Motorola in in the process of beginning the installation of the MC7500 radio system.

Pitt County – Jimmy Hodges has been promoted to 9-1-1 Director.

Region B:

Richard Batchelor reported:

Raleigh-Wake is hiring 12 telecommunicators.

Durham is hiring telecommunicators.

In Apex:

- David Boggs retired after 33 years of service. He was presented with an APCO Box during his retirement.
- Communications is now its own unit; it no longer falls under Records/IT/Communications.
- On January 1, Rick Thomas was named communications manager. His old position and David's communications functions were rolled into one position.
- Contracts are being reviewed by legal and they hope to be live on the MCC7500 Consoles by the end of the FY.
- They have one person in training, and one opening.
- They are asking for two additional shift supervisors in FY19, this will give us three per shift.
- In association with the IACP and USDOT Traffic Incident Management System (TIMS), they will become the second agency in the US to pilot a new program for logging traffic incident data in CAD. They will track the time of call to dispatch, dispatch to arrival, arrival to road

clear, and road clear to incident clear. They will also log any secondary collisions as a result of the primary incident.

Town of Cary did a feasibility study about staffing.

Region C:

Tracy Trogdon reported:

David Carroll with Lumberton reported they have been having major issues with their radio system but it is getting better They are fully staffed.

Pender county is fully staffed.

Fayetteville is recruiting – they are down by 11. They received Tri-ACE accreditation.

Cumberland County received their EMD re-accreditation and has three vacancies. Cumberland County Cape Fear Valley Health Foundation did a cardiac save ceremony and telecommunicators were invited to this.

Region D:

Janet King reported:

High Point is fully staffed.

Surry County has two full-time openings.

Burlington reported two trainees completed training in December. They are still in the process of hiring a full-time position. Angela Connor name TC of year. They have replaced the UPS at all the tower sites and have completed radio programming.

Forsyth County transitioned to the latest Viper Positron system. They hope to be in their public safety building by April 1st.

Davidson County is down five positions. They are getting ready to start an academy. They are ready to move again on the Vesta project.

Randolph County recently hired four people. They recently had the 911 board audit. Shift Sgt. Lane

Richardson received a medical directors award for the most CPR saves in 2017. They have

completed monthly backup drills since moving to the new center.

Guilford County has 12 vacancies. They will transition to the P25 radio system at the end of March.

They are also upgrading their radio system.

Moore County – Jason Still has been named 911 manager.

Region E:

Ray Gilleland reported:

Rowan County is in the final stages of a backup center. Rowan and Cabarrus are using same backup

center.

Cabarrus County – Rowan-Cabarrus Community College is offering the sheriff's standards course

from 2/19-26.

Iredell County advised construction on their new building is underway.

Catawba County is enjoying their new building.

Stanley County has one full time opening and hope to be adding 2-3 part-time positions.

Grayson Gusa discussed changing the areas for the regional ambassadors. Some regions are larger -

either by size or population - than others and we would like to balance out the regions more. Twenty-

three counties would be affected. We will be sending this out to the membership for feedback.

The NC Association of Chiefs of Police has a draft that will make any Telecommunicators that work under a municipal police chief become certified by the Sheriff's Training and Standards. It will affect 26 agencies is what we were told.
