911 Board:

Mike Reitz reported:

Update on the proposal discussed in the Funding Committee to increase the 911 fee was presented by Randy Beeman and Chuck Green during the NENA meeting. The 911 Board will vote on the issue in March.

PSAP managers meetings have been scheduled and it is a good opportunity for managers to engage with the 911 Board staff and ask questions.

State 911 Plan project is moving forward and a report will be presented at the September Board meeting which is during the NC Public Safety Communications Conference in Cherokee.

Overflow position policy was discussed during the February funding committee meeting and staff is looking into the issue concerning the math calculations. It will be discussed again at an upcoming committee meeting. A policy defining this position is needed, but we want to ensure it is a fair policy and fits all PSAP's.

911 Board Committees are a great opportunity to listen and be engaged in the business of 911 in our state. A lot of the work of the 911 Board is completed in committee, so it's a good way to be involved in the issues concerning our PSAP's.

Discussion during another report centered on cybersecurity and it was mentioned that the 911 Board is looking into this issue and more information will follow. It was also mentioned that all PSAP's should be exercising and training their back-up plans.

Greg Hauser with Charlotte Fire is leaving his position the first week of April. He has accepted the position as the new statewide interoperability coordinator with state emergency management.
