RO TQCSI (USA) LLC understands the importance of protecting the privacy of individuals and is committed to complying with the United States of America Privacy Principles, and, where relevant for Europe, the General Data Protection Regulation (GDPR), to ensure the confidentiality of any personal information collected.

Specifically, we will ensure:

- Open and transparent management of potential information TQCSI (USA) are upfront with clients about how and why information is being collected and for what purpose the information is being retained.
- Anonymity and pseudonymity where TQCSI (USA) are tasked to collect information where anonymity may be assured (e.g., survey of clients), then every attempt is to be made to de-identify any information collected.
- Collection of solicited personal information personal information is only collected to ensure appropriate contact with TQCSI (USA) clients for auditing, certification, training, and seminars.
- Dealing with unsolicited personal information TQCSI (USA) does not engage in the collection, access, or distribution of unsolicited information.
- Notification of the collection of personal information personal information is only collected by TQCSI (USA) to ensure appropriate contact with an individual through the life of contract.
- Use or disclosure of personal information information will only be used to facilitate the respective auditing, certification, or training; no information will be disclosed to any third party without prior approval.
- Direct marketing no personal information is disclosed for the purposes of direct marketing.
- Cross-border data disclosure of personal information no information will be transferred overseas unless absolutely necessary to facilitate auditing, certification or training. In these rare cases, the nature of information will not be personal in nature.
- Adoption, use or disclosure of government related identifiers no Commonwealth or State identifiers are adopted, collected, or used
- Quality of personal information we ensure any personal information collected will be relevant for the nature of work, accurate, complete, and current.
- Security of personal information we will protect personal information from misuse, loss, or unauthorized use.
- Access to personal information access to the personal information collected will be limited to those authorized to work on the account by the client.
- Correction of personal information we encourage personal information to be regularly updated and personal information collected to be available to the individual concerned.
- For our European clients, TQCSI (USA) only collects data in line with the above for the purposes of facilitating auditing and certification services, and any personal information retained can view and correct information held at any time upon request. TQCSI (USA) will keep this information current through checking at each audit.
