It's that time of year again... Tax Season 2024 is here!

We would personally like to thank you for returning for 2023 income taxes. We truly enjoy working with you, our <u>business</u> family. <u>Thank you</u> for the kind referrals and voting us the Best Accounting Firm in the Region! I have been asked "if we still accept new clients"? ("Yes" BUT – we are really evaluating going forward what clients we will be accepting). Things get hectic in the offices and your patience means the world to us during the "tax season" months.

Please note in the attached newsletter that we have adjusted our office policies. Please take the time to see if these are applicable to your situation. If you provide loose, not totaled receipts, we will access a "bookkeeping" fee to process these. We will provide you with either an electronic **OR** paper copy of your return. We generally need 10 business days to process your materials and to avoid any expediting fee.

As I also have stressed over recent years, Federal, State and Local governments are increasingly pressed for funds due to the economy and tight budgets. We stress and emphasize diligence at getting us <u>timely</u> information, making sure to let us know about estimated payments, providing us ALL forms received, and providing us accurate information. The tax return we provide to you is only as good as the information we receive. It is critical to let us know if you are making any estimated payments, providing all investment/income documents and life changes. Your notes are invaluable!!!

As we have emphasized and warned, Pennsylvania continues to attack and fight all deductions. Due to the ongoing budget issues, we fully expect this to continue. PA rejected at least 80-90% of the returns in 2020 that claimed PA UE expenses. If you desire to appeal and challenge later, this is a time-consuming process and not part of our tax prep fees.

Due to costs and time, we have raised the copy fee for additional returns. PLEASE KEEP THE COPY OF THE RETURN we provide to you. You can make as many copies to forward to whoever you desire. As a reminder, we generally do not process returns until at least Jan 31. In addition, we will not be processing any tax returns April 1 to April 15. We are happy to file an extension if needed and process later in the summer (we will not be again working on 2023 returns until likely late August and then late September).

When dropping off your taxes, important items to note for us (please complete checklist)...

- Direct deposit bank info—cancelled checks required (need to know upon drop off)
- Correct Birthdates for you and all family members
- Did you make estimated payments for this year?
- If securities, stocks / funds were sold, we need the **cost basis** info from your advisor
- Any life changes -weddings, new children, divorce?
- New phone number or email address
- Will you be dropping off more information?

Note: We have new, secure mail slot in front/main office door (if you deposit documents, we have it!).
