Sewer connections are the responsibility of the homeowner to have a contractor connect from the house to the sewer main line following.** (1) I am and shall continue to be bound by the District's ordinances, resolutions, rules and regulations applicable to cost, control, maintenance, and operations of such District's utility services, (2) I am personally liable for the prompt and timely payment of all District utility charges incurred for said services; (3) my failure to promptly and timely pay such charges may result, at the District's option, in the termination of my utility services (in accordance with the procedures of the District's Code and the laws of the State of Utah), and/or the pursuit by the District of such other enforcement remedies as the District may have at law and/or in equity to enforce the terms of this agreement and the District's applicable ordinances, resolutions, rules and regulation, (4) whether or not Judicial enforcement is pursued by the District I shall pay the costs and reasonable attorneys' fees incurred by the District in connection with collection and/or other enforcement of my obligations, responsibilities, and liabilities hereunder; and (5) the remedies provided herein are cumulative, and the exercise of any other remedy or remedies deemed necessary thereby for the collection of such delinquent amounts.
