A Note from the Chair: Laura Davis




Happy Spring, Lake District neighbors! We know it's nearly Spring because the "Fish Refuge" signs are up all along the DDLD shoreline south of the Dunkirk Dam, all the way to Highway N. The Fish Refuge protects the fish in this essential habitat so they can successfully spawn. People who violate this no fishing law at this time are liable to get a ticket and a fine, but of course anglers have the most to lose by disturbing the fish at this time. So, hopefully it won't happen much. Some people think the refuge only applies to catching Muskie, but it actually **prohibits all fishing until May 15th**. Fishing above

the dam is still permitted. We've started preparations for the installation of an accessible pier and kayak launch above the Dunkirk Dam later this spring. As you recall, the Township received a Recreational Boating Facilities Grant from the DNR Waterways Commission last fall. The DNR will grant half of the \$78K cost, and the DDLD and the Township will split the remaining half. This is Phase I of the development of safe river access above and below the dam. We're already thinking about what we need in order to make a portage route to the southern shore of the river, and a launch that can accommodate canoes and kayaks, and also emergency craft.

Please mark your calendars for July 16! The DDLD and Town of Dunkirk are planning a community picnic at Lyon's Park to celebrate our new accessible pier and kayak launch, and look ahead to the southern shore. Hope you can make it!

The **Town of Dunkirk** is in the process of updating their twenty-year **Comprehensive Plan**. Becky Dakin is a member of the committee and is lending her skills in composition and editing. The updated plan will include an explanation of the Lake District along with the DDLD map. One of the stated goals in the Plan is: In cooperation with the Township, DDLD will develop a Dunkirk Parks and Open Space Plan that will complement the Dane County Parks and Open Space Plan to maintain eligibility for State Stewardship grant funds.

Review: Wisconsin Lakes & Rivers Convention

Ted Christman and I (Becky Dakin) attended the Lakes & Rivers Convention in Stevens Point held March 26-28. Our first session was titled, "Let's Talk: Lake Districts Who Operate or Manage a Dam." I had suggested this topic to the conference planners six months ago and hoped we might have a few people join us. The room was standing-room-only with over fifty people in attendance! The session was led by Uriah Monday of the DNR and Peter Jensen, Professional Emergency Planner. They reviewed Chapter 31 of the state statute providing a background for the discussion. We were reminded about the required inspections and reports. Once they opened it up for questions things got exciting. The energy in the room was intense as people needed help and they wanted answers.

Questions were asked like, "One of our Lake District members has removed the dam that's on his private property. Our lake is now a mud hole." "How do we build/re-build our dam?" "We have a member that goes out and adjusts the dam water level to keep his basement from flooding since he built his house below the water level. What do we do?" "Our insurance was cancelled. Did this happen to anyone else?" "If we don't maintain the required water level are

we putting ourselves at risk?" "Our dam operator just does whatever he wants. How do we make a formal agreement?"

At the end of the session we were assured that the contact information of each attendee will be shared so we can talk with each other. The conference planners also said they may set up a Listserve to facilitate our ongoing discussions.

The many questions demonstrated that the Dunkirk Dam Lake District *ain't doing too bad!* Ted and I left realizing that we still have a lot to learn but acknowledge that the management and operation of our dam is in good shape. We'd like to talk with our Dam Safety Engineer from the DNR and pick his brain. We'd like to have a long discussion with Tom Reiss to better understand our Emergency Plan and our Inspection Reports. It's exciting to continue our journey into our stewardship of the Yahara River and the Dunkirk Dam.
