## Martin County can get piece of \$870 million for internet

Indiana is receiving close to \$870 million for broadband. A huge investment is underway to make sure rural and underserved communities have equal access to broadband. Where the money goes will be based on data collected.

As many people as possible need to submit information about their internet in order for Martin County to get the most funds possible.

You may have completed similar speed tests over the past year or two – but this is the one that will determine where the most need is and where the money will go.

Here's what to do to make sure your location is counted:

1. If you do not have internet, email your address to Indianabroadband@iot. IN.gov. In Martin County, you may call 812-295-2412 and provide your address and the Extension office will email the information in for you.

If you do have internet of any kind (excluding cell data):

-Visit https://connectingindiana.com/ to submit a speed test. Make sure you are connected to your home (or business) internet and not to cellular data. It is important to do this multiple times at different times of the day.

2. Visit https://broadbandmap.fcc.gov, enter your address and look to see which internet providers are listed as available for your address. Make sure the "fixed broadband" tab is selected. If your address comes up at the wrong spot, click on the dot that is closest to the address pin and verify that it is the correct address. If it is not, click location challenge on the right. If your provider availability list is incorrect, click availability challenge on the right.

A couple of important notes:

-If your tested internet speed is less than 100Mbps download and 20Mbps upload (aka 100/20) you are considered underserved

-If your only internet option is satellite – you are considered unserved.

-If you have dedicated wireless (not cell phone data) that is considered served. This is not for cellular data. However,

## Loogootee School Board discusses property tax increase impact

The Loogootee School Board spent some time discussing the public's reaction to the property tax increase due to the school's upcoming expansion and remodel projects, at their meeting last Thursday, January 18.

Board Member Brent Courter said he feels the board needs to do a better job showing that the impact to property owners will not be as substantial as they think it will. He said he was talking to a property owner recently whose home has a market value of more than \$300,000 but has a net assessed value of \$45,000, after deductions. He said the property owner was surprised at how little the school will be increasing his property tax based on that assessed value. He said the impact is not as bad as many believe it is. Superintendent Dr. Brian Harmon said many are confused about market value and assessed value. Market value is what a home would be priced if that home was listed for sale. Assessed value is what the county assessor says is the home's value. Many property owners also have deductions on their property which reduces the assessed value further.

Property owners can go to https://www. in.gov/dlgf/understanding-your-tax-bill/ tax-bill-search/ and search their most recent property tax statement. There they can see what their assessed value is with their deductions, if any. Once the assessed value is found that amount should be divided by 100 and then multiplied by 0.3013. This will give the additional tax a property owner will pay for the school's projects. Those projects include a new 22,000 square foot activities center, remodeling the middle school building, remodeling the elementary school playground and building a bus barn. The school's current tax rate, before the increase, is 0.7839. Dr. Harmon said the school's tax rate is below the state average now and should be below the state average with the increase. It was also noted that the board does not yet know the exact amount of the projects so the tax rate may change. It cannot go higher but can go lower. Example: A home that has an assessed value, after deductions, of \$75,000, would pay an additional \$226 a year. Dr. Harmon also noted that with the circuit breaker (property tax caps) in place in the state, a residential property owner cannot pay more than one percent of their home's value, farmers cannot pay more than two percent and commercial property owners cannot pay more than three percent. The board voted to put the projects out for bids with opening of bids to occur in February. The goal is to have the middle (See 'LOOGOOTEE' on page 2)

The rest can be left blank if you don't know the answer.

# Councilman's Corner

Emergency plans underway to secure freshwater supply for East Shoals

In a crucial development for the residents of Shoals on the east side, urgent measures are being taken to replace a deteriorated 750-foot freshwater line servicing the town. The issue lies in the flange joints at each pier, a result of mounting and initial installation challenges that restricted the joints' movement with the bridge. This deterioration has reached a critical point, prompting action.

Town Council President Cary D. Albright is spearheading efforts alongside HWC Engineering to devise

an emergency plan and engineering drawings for the replacement project. The focus is on securing a full grant through the state revolving loan fund, which caters to disadvantaged communities. With 36 percent of Shoals' population falling below the federal poverty level, the town qualifies for this support.

This emergency situation demands immediate attention, as the freshwater line serves as a lifeline for East Shoals. The estimated cost of the project is \$1.7 million, making external funding crucial. Council President Albright has actively engaged with Congressman Bucshon, who, in turn, has alerted the state of Indiana about the impending freshwater supply crisis.

Collaboration with HWC Engineering,



the rate study consultant, and the state of Indiana's SRF state revolving loan fund is underway to expedite this critical project. The aim is not just to replace the deteriorated line but to secure a sustainable solution for the long term, ensuring the well-being of the community in Shoals.

As the town faces this emergency, the proactive approach of Council President Albright and collaboration with key stakeholders highlight the dedication to securing the essential freshwater supply for East Shoals. The residents eagerly await a positive outcome from the grant application, trusting that this collective effort will safeguard their access to clean water.

Taking time to educate and prepare yourself now can save you time, money, and headaches once winter weather hits. In 2020, an estimated 25,000 injury crashes occurred in wintry conditions (NHTSA).

This list is not an exhaustive or complete list of winter driving tips, but we here at ISP - Jasper hope they will help you and your loved ones drive safely this winter. But remember, they only help if you read and apply them!

What can you do now?

Tires - As outside temperatures drop, so

Battery - Your car's battery is also negatively affected by cold temperatures. Now is an excellent time to check your battery and charging system.

Wipers - Worn or damaged wipers are no match for snow and ice. Check and replace them if needed.

Wiper Fluid - It is easy to empty your washer reservoir during heavy snow or on a slushy roadway. Make sure to top it off now with a winter-grade fluid.

Emergency Kit - Crashes, breakdowns, and getting stuck on an unplowed road can happen even for the safest drivers. Don't be caught off-guard; have an emergency kit with a blanket, flashlight, jumper cables, road flares, or emergency lights available. You may also want to pack a small shovel and some kitty litter or sand to help get "unstuck."

January is the time to plan for the new year's gardens. While all types of gardening have seen an increase in interest in recent years, one of the most popular has been growing flowers for cutting. Some grow cutting gardens just to have fresh flowers for personal use, but many small businesses have sprouted as a result of the renewed interest in cutting gardens. Cut-your-own-bouquet flower farms have been established in many locations. Such small businesses are especially popular in areas near cities. Going to a flower farm is not only a way to get flowers for any occasion; the trip to the farm actually becomes an outing and even a social event for a group of friends or family. Many of these locations offer vases and arranging services, or they will teach customers to arrange bouquets. In most cases, flowers are sold by the stem.

The difference between a cutting garden and a landscape is mainly in the arrangement of the planting beds. Landscapes tend to mix various types of plants in beds and borders, while cutting gardens are usually arranged more like the traditional vegetable garden, with a particular flower growing in beds or rows. This is especially important for the cut-your-own farms. While I welcome visitors to Sandhill Gardens, I would not want people trampling through my beds and borders cutting blooms. Still, when I gather flowers for personal use or for my churches, I personally may cut flowers from the landscape.

My plans are to grow some cutting beds in the vegetable garden area this summer. To have a steady supply of flowers, I plan to concentrate on cut-and-come-again flowers. These flowers, annuals for the most part, actually need to be cut on a regular schedule. Cutting blooms will cause the plants to become sturdier and will increase the number of stems on a plant. While the secondary blooms may not be as large as the first round of flowers, there will be more of them. If timed right, there should be blooms until frost.

Some flowers fare better as cut flowers than others, and a good cutting garden should certainly feature such plants. It is hard not to like sunflowers, but the smaller, multi-stem sunflowers certainly are better in bouquets than the huge flowers of Mammoth sunflowers. One may plant separate beds or rows for each type of sunflower or mix cultivars together. Be sure to follow the seed packet instructions on spacing of plants. Zinnias are probably my favorite flowers for cutting. I plan to plant several types of zinnias. Other good cutting flowers include marigolds, snapdragons, cosmos, larkspurs, bells of Ireland, amaranths and celosias. I may do some secession planting of gladiolus bulbs and some dahlias.

A cutting garden also needs some plants for foliage to complete the bouquets. Herbs, including lavender, rosemary, basil, dill and fennel provide scented foliage to bouquets. Mints of various types also may be used as filler foliage, but I do not recommend planting mint in the cutting garden, as it tends to take over an area. I also use leaves from my collection of hostas and coral bells to add color and texture, and the fern-like growth of asparagus is a traditional filler. The many varieties of coleus are also great to include in bouquets.

This is by no means an exhaustive list of cutting garden plants. I encourage you to do some research. (That is a fancy way of saying spend time dreaming over a good seed catalogue.) You may grow a wide variety of plants or choose to specialize. I once knew a gardener who grew only purple flowers. As with all gardens, you should please yourself. Have a good time planning.

The U.S. Department of Agriculture signed into law H.R. 6363, the Further Continuing Appropriations and Other Extensions Act, 2024 (Pub. L. 118-22), which extended the Agriculture Improvement Act of 2018 (Pub. L. 115-334), more commonly known as the 2018 Farm Bill, through September 30, 2024. The water quality practice incentive builds on other improvements to Continuous CRP that were made in 2021, including expanding CLEAR30 from two pilot areas to nationwide availability and repositioning SAFE within Continuous CRP to give producers and landowners more opportunities to participate. Additionally, FSA has improved CREP by creating flexibilities within CREP for partners to provide matching funds in the form of cash, in-kind contributions, or technical assistance, adding staff to work directly with partners, and expanding opportunities for Tribal Nations to participate, beginning with three Tribal Nations in the Great Plains, the Cheyenne River, Oglala, and Rosebud Sioux Tribes, for the first time ever, to help conserve, maintain, and improve grassland productivity while reducing soil erosion and enhancing wildlife habitat.

Signed into law in 1985, CRP is one of the largest voluntary private-lands conservation programs in the United States. It was originally intended to primarily control soil erosion and potentially stabilize commodity prices by taking marginal lands out of production. The program has evolved over the years, providing many conservation and economic benefits.
