Major snowfall

Shoals Town Council goes over multiple topics

The Shoals Town Council met Monday, February 8. Those in attendance were Council Members Cary D. Albright, Clint Hoffman, and Cecil Ragsdale; Clerk-Treasurer Sierra Rutledge, Town Attorney Dave Lett, Municipal Utilities Manger Kevin Crecelius, Park Board President Zack Brown, and Park Board Members Sara Clark, Kaylee Diamond and Chad Damon. Others in attendance were Micky Crew.

Council Member Albright requested for a motion to renew the property and casualty liability insurance policy with changes as needed to include the deletion of items no longer owned, along with the workman's compensation insurance policy, both being with DeWitt Insurance. Councilman Ragsale made a motion to renew the policies with Councilman Hoffman making the second and all were in favor.

Resident Micky Crew came before the council with complaints concerning a neighboring property to hers. Crew requested the council do something about the trash, debris and other concerns she had pertaining to the property. The council stated to Mrs. Crew that they would issue violations in accordance with town ordinances with the town marshal.

Attorney Dave Lett presented the timber contract for Council Member Albright's signature for the timber cutting of town-owned land on Sherfick School Road, with Indiana Timber & Veneer. The council put Municipal Manager Kevin Crecelius as the point of contact to see out the operations of the job. Next, Lett presented Ordinance 2021-1 for approval which is an ordinance revising the tap in fees to the water and sewer systems of the town. Councilman Ragsdale made a motion to approve the ordinance with Councilman Hoffman making the second and all were in favor. President Albright stated he wanted to reiterate that this does not affect current utility customers only new ones tapping into the main lines on the system.

-- OUR HISTORY --

The time of our county starts with our history. There are a lot of our friends and neighbors who have a passion for the history of the places and the people that brought Martin County to where it is today. The MCCF has a Martin County Historical Society Fund, which is a "designated" fund, whose earnings will always go for the Historical Society's work. Our history helps to define who we are.

-- OUR MUSEUM --

Our Martin County Museum, the old courthouse, is the home of a lot of our history. The courthouse was constructed in 1876 and is on the National Register of Historical Places. It has historical significance to our community and quite a few of your families. And did you know that it is one of only seven courthouses, from the 92 Indiana counties, which is not located on a town square? This courthouse has many reasons why it needs to be pre-

The Historical Society has been working on the preservation of the old courthouse and multiple needed repairs including the bell tower and lighting, brick and mortar repair, building restorations, and more. They have obtained grants and donations from many sources, including the MCCF. While there is still more to do, the completed repairs have helped ensure that the museum will remain for many more years.

-- OUR VETERANS --

One of the more recent repair and restoration projects is the future veterans' room at the museum. This room will house military displays to honor our local veterans and heroes. The Historical Society reached out to the community for help to fix the ceiling in the room and received an outstanding response, which is not a surprise for Martin County. The MCCF also saw the importance of the veterans' room and what it will mean to many in our community. There are also other needed repairs and improvements to the room

- more details to come. If COVID cases remain low, the high school students will be returning to in-person learning everyday beginning after spring break.

Superintendent Roush congratulated the board on the successful joint board meeting with Mitchell and Orleans Schools on January 26. In partnership with Mitchell and Orleans, the school will be working with Vincennes University to help provide online dual credit classes to high school students. They also discussed the opportunity for high school students to take the new medical dual credit classes offered

in high school to earn their CNA before they graduate. Students are currently in year one of their medical coursework. Dr. Roush notified the board that they will be approving summer school and summer cleaning crew at the next board meeting. She also reminded the board that the new playground installation will begin over spring break. Finally, Dr. Roush notified the board about a new STEM grant that the school received for \$30,000 to help cover STEM and lab materials, and she spoke of a new federal COVID grant that will be coming up in the next few months.

The meeting adjourned at 6:58 p.m.

Attorney Lett presented a license agreement/memorandum of understanding between the town and a property owner on West River Road for use of the property by the town of a future trail project. Councilman Hoffman made a motion to accept the agreement with Councilman Ragsdale making the second and all were in favor.

Attorney Lett opened and read the sealed bids received for the 2001 GMC Sonoma and the 2005 Ford F-150. Several bids were received. Councilman Ragsdale made a motion to accept the bids from the highest bidders for each vehicle with Councilman Hoffman making the second and all were in favor. The winning bid for the 2001 GMC Sonoma was Mark Robbins at \$1,356 and the 2005 Ford F-150 was Ray Hopkins at \$2,505. Attorney Lett read aloud two sealed bids received for the advertised water company jobs SMU Water #1 and SMU Water #2. Bids received were from CountyWide Painting SMU Water #1 \$3,500, SMU Water #2 \$2,800 for a total of \$6,300 for both jobs and Viking Construction SMU Water #1 \$3,200 and SMU Water #2 \$4,400 for a total of \$7,600 for both jobs. The board will take the bids under advisement and award at the March meeting.

The council members presented each of the park board members with a certificate of appreciation on behalf of the town as a thank you for all of their volunteer time, work and efforts towards the ball park area. Albright stated the board appreciated how hard the park board has worked to make the improvements that have been done under their leadership.

Council Member Albright requested a motion be made for HWC Engineering to prepare information for the Town of Shoals to apply for a federal grant in the December call for applications to address the Main Street area. Next, Albright requested a motion to make the current part-time clerical position in the clerk-treasurer's office full-time for a position of deputy clerk II. Councilman Ragsdale made the motion with Councilman Hoffman making the second and all were in favor.

Master Gardener

The first round of All-America Selections for 2021 have been released. Three flowering plants and three vegetables are among the plants given this honor.

Since 1933, All-America Selections have been accepted as being the cream of the crop of new plant releases. The reason is that these plants have been tested in more than 80 gardens across the United States and Canada and have been found to exhibit outstanding characteristics. Only a small percentage of the plants tested actually receive the AAS award seal. That designation is forever thereafter touted in seed catalogues and on plant tags. Some of those original selections from 1933 are still being sold and still exhibit that coveted shield. In addition to the national awards, some plants found to thrive in specific regions are awarded a regional award. Indiana is part of the Great Lakes Region.

All three flowers in the recent list of awards have been found to have outstanding blooms. Celosia Kelos Candela Pink was described by one judge as being the Energizer bunny of the garden. Bright pink blooms rise above the foliage like candles and continue to do so all summer long. Since it is a new plant, you may have to search for it this year, but the AAS prize ensures that it will be around for many years and usually becomes more-widely available after the first year. Leucanthemum Sweet Daisy Birdy is a perennial that has been a part of trials for three years. It is a Shasta daisy on steroids. The blooms are five inches in diameter, with white petals surrounding a yellow center. A special feature of the blooms is a ring of smaller feathery white petals that add an interesting crown around the center. The plant has been found to be very reliable and hardy and is disease resistant. It is a low-maintenance plant that needs little work other than some dead-heading to keep the blooms coming. It has been recommended for moon gardens, so I will certainly be seeking this plant this spring to put into my moon garden at Sandhill Gardens. The only seed-grown flower to receive the AAS award this year is Zinnia Profu-

sion Red-Yellow Bi-color. This zinnia has good disease resistance and does not flop as many zinnias are prone to do. The yellow petals surrounding a red center will morph to salmon, apricot and dusty rose, and a plant may have all of the colors with blooms at different stages on the plant at the same time. This flower also received awards in European trials. Seeds for this selection are available from Park Seed Company.

Three vegetables selected promise improvements over older varieties in the garden. Echalion Brulee is a shallot, a member of the onion family. It sports coppey-pink outer skin with a rosy purple interior and has thick rings. It matures earlier than other shallots and has a citrusy flavor when eaten raw. It is recommended both for home gardeners and market gardens. You may find seeds for this shallot at Johnny's Seeds. Goldilocks is an acorn squash that was chosen for its vigorous plants, disease tolerance and high yield. The bright orange squash has a nutty flavor and is also great as an autumn ornamental. Seeds are available from Osborne Seed and Territorial Seed. Pepper Pot-a-pano is a dwarf jalapeno, perfect for pots and hanging baskets. The small spicy fruits mature earlier than other jalapenos and they are also very ornamental. You may buy these seeds from Park Seed.

Meanwhile, a snowy landscape makes it look like nothing is happening in the garden. However, I planted lettuce in a cold frame on Valentine's Day, as is the tradition, and it is time to begin planting seeds for other greens and cole crops in cold frames and greenhouses.

I have had many inquiries about the foliage that people have seen sprouting up in their gardens. The foliage of crocuses, daffodils and other spring flowers is very tough, and this is not at all unusual. The snow cover this week is actually good insulation against the frigid temperatures and as the warmer temperatures melt the snow, we will see more foliage and probably blooms within the next couple of weeks. Spring is coming!

Hoosiers have opportunity to purchase health insurance during special enrollment period

The Indiana Department of Insurance wants Hoosiers to know they have another opportunity to enroll in health insurance on the Federal Affordable Care Act Exchanges (HealthCare.gov) if they missed enrolling in the fall. The 2021 regular open enrollment period ended on December 15, 2020. The new opportunity to purchase health insurance follows the executive order signed by President Biden on January 28 to reopen enrollment on the Federal Marketplace. The special enrollment period is February 15 to May 15.

Starting February 15, Hoosiers seeking to take advantage of this Special Enrollment period can find out if they are eligible by visiting HealthCare.gov. If eligible, you can enroll and select a plan with coverage that starts the first of the month after plan selection. The premium must be paid by the 15th of the month after plan selection for coverage to start on the first of the next month. If the premium is paid between the 16th and the end of the month, coverage will start on the first of the month after next. You will have 30 days after submitting your application to

choose a plan.

Current enrollees will be able to change to any available plan in their area without restriction to the same level of coverage as their current plan. During the Special Enrollment Period, current enrollees will need to go through their application and make any needed changes to their current information, then submit their application to receive an updated eligibility result to continue on to enrollment. Indiana Navigators are certified with the Indiana Department of Insurance and are located in counties across the state. You also may choose to work with a local insurance agent or agency. You can verify if an agent or agency is licensed in Indiana on the Indiana Department of Insurance website.

Beautification Board information. Rutledge stated President Amber Hoffman said the board's 2021 meeting schedule has been posted on their Facebook page. Hoffman requested to expend the \$20,000 received from the Martin County Community Foundation Grant for the signage project and that she would be meeting with a local contractor this week to get a quote for labor and installation for the project. Councilman Ragsdale made a motion to allow the board to expend their grant money with Councilman Hoffman making the second and all were in favor.

Rutledge presented a quote received from SVFD Chief Jim Hamby for the replacement of four batteries for first responders in the amount of \$900. Councilman Ragsdale made a motion to approve

the purchase with Councilman Hoffman making the second and all were in favor.

Municipal Utilities Kevin Crecelius presented two quotes from Tony Truelove for tree work needed at the wells area and on High Street. Councilman Ragsdale made a motion to approve both quotes with Councilman Hoffman making the second, contingent on proof of insurance, and all were in favor.

Rutledge stated that council members Albright and Ragsdale had met with HWC Engineering concerning the 2021 Community Crossing Grant application and at this time the town potentially would be able to address six areas for improvements.

Rutledge stated that with the increase in the county income tax the town's monthly distribution has increased with

the largest increase being in the EDIT fund substantially.

Councilman Ragsdale asked Rutledge to relay some information about the OCRA Main Street Organization program. Rutledge stated she had been told that there are some citizens interested in putting together a group to hopefully get things in motion to move forward to making it possible for Shoals to become a part of this program.

Park Board President Zack Brown asked the council for permission to move forward with land acquisition requirements for land the park board is interested in. After discussion, Councilman Ragsdale made a motion to authorize Attorney Lett to prepare a document to move forward with Councilman Hoffman making the second.
