The Shoals School Board met February 14. Bill Bauer resigned his position as on the school board effective February 11, 2019. Sam Boyd motioned to accept the resignation and Drexel Turpin seconded. The motion passed 4-0. The board will have 30 days to appoint a new member.

Jenell Hoffman nominated Drexel Turpin to be the new president of the board. Sam Boyd seconded this motion. The motion passed 3-0-1 with Drexel abstaining.

During patron input, Lorna Troutman talked about a presentation that the Robotics Team gave last week. They had Captain Mark Oesterreich, Icdr Michael Lemmons and Greg Petty from Crane attend the demonstration. The students placed 2<sup>nd</sup> at the Kentucky State Robotics competition in January.

Hoosier Uplands donated \$7,800 to Phase I of the school's walking trail and Duke Energy donated \$1,000 to further the building of the new greenhouse by the agriculture students. The board accepted the donations.

The renewal of Dr. Roush's contract was brought to the board. Sam Boyd motioned to renew the superintendent's contract and was seconded by Jenell Hoffman. The motion passed 4-0.

The superintendent presented on the possibility of starting 529 College Savings Plans for the kindergartners. This would be optional for parents, but the school would make the initial \$25 deposit to create the account. Drexel Turpin made a motion to send letters home to parents for this program and Sam Boyd seconded. The motion passed 4-0.

The nurse has a standing order for auto-injector Epinephrine pens that is renewed every year by the board. The board approved the renewal.

The IT director and superintendent submitted a request to change the student software program from Harmony to Skyward. The process will take approximately six months and will be ready for the new school year. The board approved.

A facility usage request was presented for the FTC Robotics Team to use the STEM room for practice on January 19 in preparation for the Kentucky State Championships. The board ap-

proved.

The sophomore class parents request to sell Merkley Meats from February 1-15 for funds for the prom and their senior trip. The Class of 2024 parents request have the 7th graders sell Little Caesars Pizza Kits from March 7-21 for funds to start the Class of 2024 account. Varsity Softball Coach Aimee Farhar requests to sell team shirts as a fundraiser. FFA sponsor Ben Kent requests to sell strawberry flats for a spring fundraiser. The board approved.

## Martin County joins Odyssey Case Management program

The Martin County Commissioners met Tuesday night, February 19. Commissioner Dan Gregory was not present. Gregory has missed the past several commissioners' meetings. Commissioner Paul George, when asked if Gregory was okay, said that he has been on travel and will return in March.

Clerk Gerald Montgomery and Judge Lynne Ellis asked the commissioners' permission to partner with Odyssey Case Management. Odyssey is the state's case management system and puts all cases, criminal, civil, small claims, etc. in a central database where anyone can access it. According to the judge, they have been paying \$24,000 a year through CSI for the same management however since the state is asking counties to switch to Odyssey, for now it is being offered for free. It was also noted that Odyssey offered to upgrade computers to handle the system. Clerk Montgomery said that he had put in his budget for this year to purchase new computers in his office, however, he is going to hold off doing that now to see what he can get through this new

The commissioners approved switching to Odyssey.

Sheriff Travis Roush told the commissioners that the jail is in need of new security cameras. He said the prosecutor's office has also expressed the need for cameras so they are going to go in together to see if a discount will be given. He is estimating the cost to be around \$30,000. Sheriff Roush said his jail commander is currently checking with other jails to see what the latest technology is because he doesn't want to have to replace the cameras again in the next few years.

Sheriff Roush also reported that there are currently 82 inmates in the jail with 25 of them from Vigo County. He estimates that with the Vigo County inmates, they will be able to bring in an extra \$300,000 in revenue for the county this year.

Highway Superintendent Leo Padgett said that residents on Ironton Road have requested that a school speed zone sign be placed on the road. He said the students, per the residents, exit the school at high speeds and they fear a child will get run over. Commissioner George said he didn't have a problem with having a 25-mile-per-hour speed limit in the area of the school but suggested that Padgett speak to the school and the county attorney first.

Padgett asked for the commissioners' advice with coming up with roads to pave to include on the Community Crossings grant application for 2020. He said that hot mix needs to be applied on roads that are ready and he wants to spend this year tearing up the current asphalt to be prepared for next year. The commissioners said they would discuss it with him and come up with the roads that need done.

Padgett also told the commissioners that if they have a historical bridge analysis done on bridge 58 on Brickyard Road, if approved to have historical value, INDOT would pay for the (See 'MARTIN COUNTY' on page 3)

# Wanted man rams deputy's vehicle leading to pursuit and shots fired

On Saturday, February 16 at 5 a.m., Martin County Sheriff's Office Corporal Tyler Reed was checking an abandoned vehicle on Pridemore Cemetery Road when another vehicle approached Corporal Reed. Corporal Reed made contact with the driver and recognized him as James R. Maple III, 30, of Indianapolis. Corporal Reed knew that Maple was wanted out of Lawrence County, Indiana. Corporal Reed also smelled the strong odor of marijuana coming from Maple's vehicle. Corporal Reed confirmed through dispatch that Maple had an active warrant and requested that Lawrence County officers come to his location to assist. Corporal Reed then pulled his vehicle forward and angled it to block Maple's vehicle from leaving. Corporal Reed exited his vehicle and ordered Maple out of his vehicle.

Maple then put his vehicle in reverse and angled it toward Corporal Reed and his vehicle. Corporal Reed had to move out of the way to avoid being struck and crushed between the two vehicles. Maple then rammed Corporal Reed's vehicle and forced it out of the way and then fled west on US 50 and Corporal Reed initiated a pursuit. Maple tried to elude Corporal Reed near the National Gypsum Factory entrance by turning around and fleeing back east and Corporal Reed continued the pursuit. Maple then turned north on to Red School Road near SR 650 with Corporal Reed behind him, then turned back west on US 50 and continued to the US 50/US 150 junction where he turned on to US 150. The pursuit continued to Mill Road where Maple turned.

Corporal Reed briefly lost sight of the vehicle as Maple crested a hill. After Corporal Reed crested the hill Corporal Reed observed a vehicle coming towards him. The vehicle turned out to not be the suspect vehicle. Corporal Reed asked the driver of the vehicle if he had met any vehicles. At this time, several gunshots were fired from behind Corporal Reed. Corporal Reed then noticed the suspect vehicle partially concealed under some trees in the front yard of a residence. Corporal Reed left the immediate area to await assisting officers. Officers from



Enrollment is up 22 students from last year, this includes 12 new students that have registered with Shoals after the first of the school year. All students have their course offering requests for next year. After much discussion with the teachers, they are moving to an eight period a day schedule next year. This will allow for smaller class sizes and open up more options for the new graduation pathways. Teacher Audrey Gibson's College and Careers sophomore class is planning a Jug Rox Make a Difference Day. This will focus on giving back to the local community businesses. 8th grade induction night is on March 5. There will be light refreshments served and Mrs. Jessica Hert will explain graduation pathways. The students will create their schedules on this night for their freshman year. The group is looking for many service projects. After the program, they were invited to present again at Indianapolis at the Small Rural School Association's Annual Conference. The school will be working with the SIEC in Jasper to help provide teachers with technology integration in the classroom. The school has now entered the "ideation" stage of our ROI grant that they have been working on for the last few months. The school, along with Mitchell and Orleans, will receive up to \$1 million to help the school align with local workforce development among students. The school is very excited for this opportunity. The school will be training teachers over the summer in mapping curriculum. This will help the curriculum standards to align across K-12. Good luck to the Shoals Community Schools Robotics team in their state competition that is upcoming. the Martin County Sheriff's Office, Daviess County Sheriff's Office, Shoals Town Marshal, Indiana State Police, and Indiana Department of Natural Resources soon arrived. Corporal Reed's narcotics-certified K9 Virka was utilized for a free air sniff of the suspect vehicle. K9 Virka gave a positive indication for the odor of narcotics. K9 Virka and Shoals Town Marshal Eckert's K9 Adel were both utilized for a track of Maple. A search of the area was conducted resulting in Maple's trail but he could not be located. Maple's hat and vape pipe were located in the area as well as shell casings.

Officers then received information on Maple's location. Officers converged on a residence approximately two miles from the shooting site. After 30 minutes of commands for Maple to exit peacefully with no response, the sheriff's office armored vehicle was utilized to ram the mobile home multiple times. Maple then exited peacefully and was taken into custody and transported to the Martin County Security

A search warrant was executed on Maple's vehicle. A search of the vehicle resulted in officers locating a large amount of methamphetamine and marijuana, a scale, labeled baggies, paraphernalia, and over \$4,000 in cash.

Additional currency was seized from Maple's person totaling nearly \$2,000.


A search warrant was executed at the residence where Maple had been located. A search of the residence resulted in officers recovering methamphetamine and several firearms. The occupants of the residence, Amy Qualkenbush, 28, of Shoals, and Dustin Holt, 29, of Shoals, were taken into custody and transported to the Martin County Security Center.

Maple was charged with attempted murder, a Level 1 Felony; dealing in methamphetamine, a Level 2 Felony; possession of methamphetamine, a Level 3 Felony; possession of marijuana, a Class A Misdemeanor; dealing in marijuana, a Class A Misdemeanor; resisting law enforcement, a Level 6 Felony; reckless driving, a Class C Misdemeanor; criminal recklessness, a Level 6 Felony; leaving the scene of an accident, a Class B Misdemeanor; possession of paraphernalia, a Class C Misdemeanor; and a Lawrence County

repairs or replacement. The cost of the analysis is around \$15,000 and the commissioners agreed to have HWC Engineering do the work.

Resident Vickie Wathen, of Old School Road, has attended several commissioners' meetings to express her concern about poor culverts and poor road conditions that are causing flooding on her property. She returned again Tuesday night with photographs to show the commissioners the problems. Wathen wants the county to help her replace a culvert under her concrete driveway to help with water flow. She said she doesn't feel like it is her fault it needs replacing. Commissioner George had told Wathen at a previous meeting that he would go look at the property. Wathen asked him Tuesday if he had been to look. George said he hasn't had time but he and the highway superintendent would set a time soon to have a look.

Wathen said the county helped her replace another culvert in her driveway in 2011. She paid for the culvert and the county provided the labor and

Veteran Service Officer Linda Evans-Dillon told the commissioners that the veterans van only took one trip last month. She said she didn't know

if there had been any complaints regarding the van, however she wanted to make it known that she never turns down a veteran from Martin County. She said some veterans are paid mileage to go to the VA clinics so they prefer to drive themselves to appointments because they cannot be driven in the veterans' van and then claim mileage. She said other veterans she used to serve have moved outside the county, passed away, or are currently in the nursing home. Commissioner George said he hasn't received any complaints.

Martin County Alliance Director Tim Kinder spoke to the commissioners about the broadband summit to be held Thursday night at 6 p.m. at the Martin County Community Building. He said the summit was for the public and elected officials to learn why broadband is important to rural communities and how the county can be a broadband ready community. The state will be giving grants to help with the installation of broadband and Kinder wants Martin County to be ready to take advantage of the grant dollars.

Kinder also invited the commissioners to the grand opening for ManTech, a new company opening in Martin County's portion of the WestGate Tech Park. It will be held on Wednesday, March 6 at noon.

## AG Curtis Hill: Be suspicious of advertising mailers claiming you have won a prize

Attorney General Curtis Hill is warning Hoosiers to be skeptical of advertising mailers claiming they have won prizes — especially when "winners" must pick up prizes at car dealerships or other sales-oriented venues.

"Typically, the announcement that 'you're a winner' is merely a ploy to entice you to go listen to someone's sales pitch," Attorney General Hill said. "We want Hoosiers to be alert to all varieties of misleading advertising so they can avoid wasting their time or, even worse, getting talked into making ill-advised purchases."

In the last 12 months, the Office of the Attorney General has filed lawsuits against five promotional firms in connection with deceptive auto-advertising mailers promising prize winnings. Thus far, lawsuits have resulted in judgments against two such firms; the other three are pending.

Most recently – on February 10, 2019 – a Marion County court approved a consent agreement between the state and Traffic Jam Events LLC, which resolved claims by the Attorney General that the promoter violated Indiana law.

The complaint alleged the following with regard to Traffic Jam Events:

The company sent mailers to more than 443,000 Indiana residents. As part of promotions orchestrated on behalf of auto dealers, Traffic Jam Events sent out game pieces such as scratch-offs. The mailings indicated that recipients with winning game pieces had won significant prizes – such as \$5,000 cash, an iPad or a \$500 gift card.

Each mailing, however, contained identical game pieces with winning numbers. Thus, each mailing communicated to all recipients that they had won significant prizes when they had not. Recipients who went to dealerships to claim winnings were then awarded their "prizes" – typically nominal items such as \$5 gift cards. Then they were subjected to sales pitches for vehicles.

The Attorney General claimed the

mailings violated the Deceptive Consumer Sales Act in multiple ways – including false representations that recipients won specific prizes and false representations that the game pieces in the mailings determined whether recipients won prizes. Further, the complaint alleged the prize mailings also violated the Promotional Gifts and Contests Act by failing to include on the prize mailings the name and address of the promoter (Traffic Jam Events); failure to correctly state the odds of winning and the retail value of the prizes potentially awarded; and failure to include a disclaimer that recipients would be subjected to a sales pitch when claiming their prizes.

The consent agreement entered between the parties and approved by the court requires Traffic Jam Events to pay the State of Indiana a civil penalty in the amount of \$57,500.

Traffic Jam Events is also required to include various specific disclosures in its mailings. It is also prohibited from sending any mailings that claim recipients have won prizes when they have not; from representing game pieces as determinant as to whether recipients have won prizes; from classifying recipients as "winners" unless they have actually won a substantial prize; and from any other future violations of Indiana law.

In addition, Traffic Jam Events is required to provide the Attorney General with copies of all mailings it sends to Indiana recipients over the next three years so the Attorney General can monitor Traffic Jam Events' compliance with the judgment.

The cakes were originally called Little Shortcake Fingers, but during a business trip Dewar and a friend noticed a shoe factory sign that read, "Home of Twinkle Toe Shoes." Dewar had been looking for a new name for his products; his friend suggested he call it "Twinkle Fingers," which was shortened to "Twinkies." The five-cent snack soon became one of Continental's bestselling items.

## **USDA to host 2018 Farm Bill** implementation listening session

U.S. Department of Agriculture (USDA) Under Secretary for Farm Production and Conservation Bill Northey announced that USDA is hosting a listening session for initial input on the 2018 Farm Bill. USDA is seeking public input on the changes to existing programs implemented by the Farm Service Agency, Natural Resources Conservation Service and the Risk Management Agency. Each agency will take into account stakeholder input when making discretionary decisions on program implementation.

"The 2018 Farm Bill is intended to provide support, certainty and stability to our nation's farmers, ranchers and land stewards by enhancing farm support programs, improving crop insurance, maintaining disaster programs, and promoting and supporting voluntary conservation," said Under Secretary Northey. "We are seeking input from stakeholders on how USDA can streamline and improve program delivery while also enhancing customer service."

The listening session will be held February 26 at 9 a.m. in the Jefferson Auditorium in the South Building located at 14th Street and Independence Ave. S.W. in Washington, D.C.

The listening session is open to the public. Participants must register at farmers.gov/farmbill by February 22, 2019, to attend the listening session and are encouraged to provide written comments prior to the listening session. For those orally presenting comments at the listening session, written comments are encouraged to be submitted to regulations.gov by February 22, 2019. Additional written comments will be accepted through March 1, 2019. Comments received will be publicly available on www.regulations.gov.

"Truly this is a Farm Bill that improves farm safety net programs, protects federal crop insurance, and preserves strong rural development and research initiatives. At USDA we are eager to hear from our stakeholders on policy recommendations, so we can start working on implementing these important Farm Bill provisions," said Northey.

The signs of the approach of spring continue. As I walked through the gardens recently, I found that the aconite blooms had been joined by hellebores, vernal witch hazel and, on Valentine's Day, the first crocus blooms of the season. I also kept a Valentine's Day tradition and planted a cold frame bed with leaf lettuce.

I spent some time inspecting bud swell on various shrubs. Most of the spring-flowering shrubs are showing signs of the coming spring. As the buds swell, it is a good time to take some cuttings to bring inside. The warmer temperatures in the house will cause the branches to bloom out more quickly, supplying a foretaste of the coming season.

With the recent rains and a day of light wind, I took advantage of the perfect weather for a controlled burn to clear off sections of my prairie. Since I have moved paths through the prairie, it prevents the fire from spreading very far. Fire from lightning strikes was nature's original way to clear off the natural prairies that once stretched from Indiana to the Great Plains.

The time has come for preparing fruit trees and grape vines for the growing season. I could not begin to give detailed instructions for pruning in the limited space of this column. I would refer any aspiring orchardists to the Purdue Extension Service for publications on proper pruning techniques. You may either find that information on the website or go to your county Extension Service office.

Another important task for the orchard and vineyard is the application of a dormant oil spray. This light horticultural oil will smother eggs of some insect pests and will also act to ward off some disease problems. This application must be made on a day when no rain is expected for 24 hours and when temperatures are expected to remain above freezing. The application should saturate the tree or vine, making sure that the whole surface is covered. This may well be the most important spray application of the entire season, since it prevents several problems.

It is also time to begin the clean-up of last year's growth debris that was left in the fall. I leave most of the plant material in the gardens to provide food and shelter for the birds through the winter. By this time, most of the seeds have been eaten or dropped and the stalks have been matted down. With the beginning of hellebore blooms, it is also time to cut back last year's foliage. Be careful when doing this, as it is easy to also cut down the bloom stalks. I spent several hours clearing the beds nearest to the front of my house this week. Those beds team with signs of spring. Many of the perennials have begun to grow and removing last year's debris made the beds look neat and spring-like. Over the coming weeks, we should see a steady progression of spring's awakening.

We certainly are not beyond another cold spell, and there is always some concern that the new growth will be killed by extremely cold temperatures. As I have said many times, there is very little we can do to prevent damage, so just enjoy what nature sends us.
