Purdue has tapped Smithville Fiber to increase connectivity performance from its West Lafayette campus to the WestGate@Crane Technology Park by upgrading existing fiber services at WestGate using Smithville's advanced core network.

This new network architecture provides multiprotocol label switching to the customer edge supported by a 100-gigabit optical transport network. The Purdue Research Foundation manages WestGate Academy under the name Purdue@WestGate, and Smithville has been a partner providing highspeed internet connectivity to the Purdue Research Park in West Lafayette since 2009.

"The importance of providing and maintaining fast, reliable and secure connectivity for businesses cannot be underscored enough," said Greg Deason, senior vice president of the Purdue Research Foundation and director of innovation and entrepreneurship at the Burton Morgan Center for Entrepreneurship at Purdue University. "We are pleased to have an outstanding compasame exceptional fiber services to Purdue@WestGate as they do to our Purdue Research Park in West Lafayette."

Upgrades have already begun in the WestGate area and continue in other areas of the state. WestGate Academy WestGate@Crane Technology Park tenants can access these advanced

Two students arrested after making threats at school

these students access to learning without disruption," said Tina Closser, NSWC Crane STEM coordinator and WestGate Academy tenant.

Joe is passionate about education and quality of place in our district. "I am interested in bringing the conversation back to Daviess, Dubois, Martin, and Pike counties," says Lannan. "We have to produce strong graduates and retain our best talent. To do this, our district needs to be an inviting place to live, learn, work, and play." He states that "reproductive healthcare and gun safety are educational aspects of the national issues that our local representatives can actually do something about." His slogan, seeking to represent the people of District 63, states "A Common voice for Common Ground."

A new documentary from WTIU Public Television takes viewers on a statewide tour of Indiana's wild and natural landscapes and reveals their little-known connections to the Indiana of 200 years ago. Indiana's Wild Landscape premieres March 5 at 8

Two centuries ago, Indiana was an endless forest with vast wetlands and inhabitants such as elk, wolves, bison, and alligators. Indiana's Wild Landscape uncovers the natural and wild areas of the state that still remain 200 years later, tucked away among Indiana's large-scale land-scapes.

Flora and fauna from Indiana's past are shown living today in wild areas across the state. Frogs and thousands of salamanders inhabit ephemeral forest pools around the Lake Michigan area, hemlock and pine trees that survived the ice age thrive in the cool climate created by the sandstone canyons of Shades State Park, and in the karst country of southern Indiana, mountain lions have slowly started to return to the state.

The documentary utilizes recently available drone filming technology to showcase Indiana's landscape from the air. Viewers see unique perspectives of the state through treetops and caves; along waterways and lakes; and from the edges of cliffs, gorges, and waterfalls.

Through time-lapse storytelling, viewers witness natural phenomena that they would not normally experience, including flora changing over time.

The program is produced by Samuel Orr, a professional time-lapse photographer, and creator and cinematographer of the Emmy-winning series The Natural Heritage of Indiana.

You can help animals such as bald eagles, barn owls, spotted turtles, Indiana bats and more by donating to the Indiana Nongame Wildlife Fund as you do your taxes.

The fund supports DNR Division of Fish & Wildlife programs that manage more than 750 nongame and endangered wildlife species in the state. Nongame means the species is not hunted, trapped or fished. No state tax dollars are used.

You can donate all or a portion of your state tax refund. Donations fund research, habitat conservation and more.

Past successes include restoring bald eagles, river otters and peregrine falcons to the state. In recent years, projects have included implementing techniques to improve natural reproduction of hell-benders, Indiana's largest salamander.

If you file with paper forms, look for the eagle logo on Schedule 5/Schedule IN- Donate.

If you file through online tax programs, you will be prompted to donate at the end of filing, and the eagle logo will not be present.

The fund is also supported by a match

of federal funds through the State Wildlife Grant Program. For each \$5 donated, another \$9 will be added, equaling \$14 for wildlife. Annual donations through the tax check-off have declined by 60 percent since 2016. This was likely due to changes that required donations from tax forms to be on a separate page, Schedule IN-5. A code is now required to donate, which further complicates the
