Townships hold more than \$1.2 million in surplus funds

Martin County has six township trustees' offices – Perry, Halbert, Lost River, Mitcheltree, Rutherford, and Center. At the end of 2022, the six townships combined had \$1,226,011.58 in unused funds that rolled over to this year. All six townships spent a total of \$353,705.78 in 2022. Of that \$151,903 was spent on salaries and office expenses.

Each township has a trustee, an elected official with a four-year term. Each trustee also has a paid secretary (Lost River Township chooses not to) and a paid advisory board of three people. All six township trustees in Martin County in 2022, operated the trustee's office from their homes and were reimbursed for rent, utilities, phone, and travel, in some cases.

There are 1,008 townships in Indiana. The main job of a township trustee is to provide money to people in need. Township assistance is given to individuals who are in an emergency situation and have no other means to provide the basic essentials of life. Residents in need can request help paying for funeral expenses, utilities, rent, medical and dental expenses, prescriptions, vehicle repairs, fuel, groceries, and

clothing.

The trustee also provides fire protection to its citizens when the township is not incorporated into a city or town. This includes making an annual payment to a fire department, in the form of a contract, to provide fire service to their township residents.

The trustee also maintains cemeteries by hiring people to provide mowing services. Other duties, per state statute, can include helping by providing and maintaining township parks and community centers, destroying detrimental plants, noxious weeds, and rank vegetation; and providing insulin to the poor.

Money is provided to the townships from property taxes, auto excise tax, and county option income tax. Interest earned from the rollover of cash balances is also

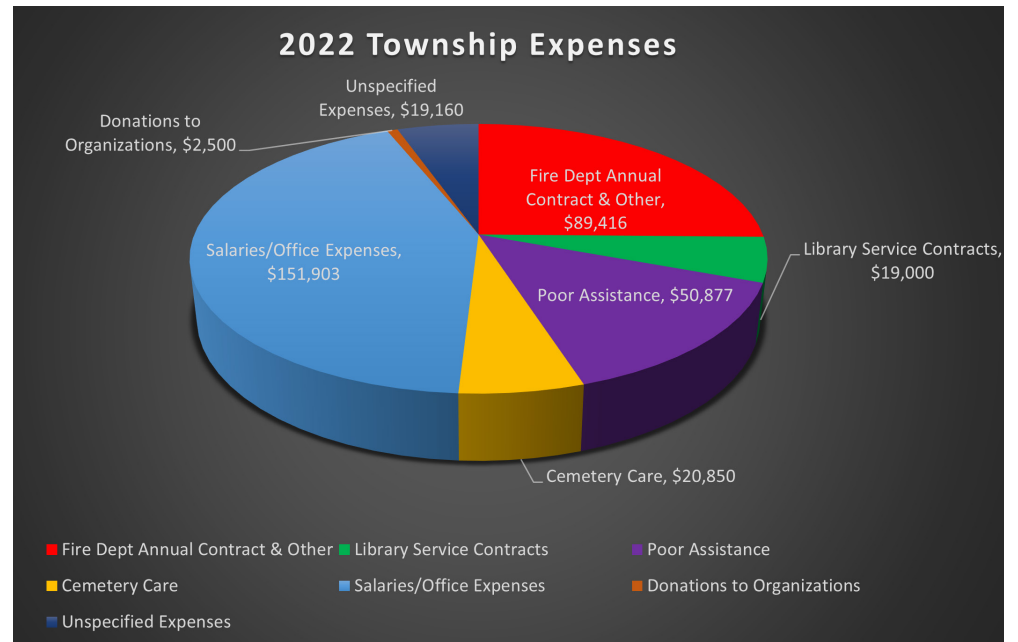

Mid-States Corridor topic of Loogootee City Council meeting

The Loogootee City Council met Monday night, March 13.

Joe Lannan, who is contracted with the city to work on their behalf pertaining to the Mid-States Corridor, gave the council an update on the three new routes proposed. Lannan said between comments submitted to the Mid-States office from Martin County residents, along with a letter signed by Martin County's elected officials, the tier one environmental survey has been halted and the new routes were presented. He said the letter from officials had stated that the corridor would be traveling through 17 miles of Martin County and then bypassing Loogootee which would have serious economic effects on the city. Lannan said the goal is to find effective ways for residents to have their voices heard now so they will potentially have an impact on what is decided. He added that he understands a majority of residents don't want the new highway at all but the goal is to be a part of the discussion if the corridor is inevitable.

Jason McCoy, who was in the audience, asked Lannan when he contracted with the City of Loogootee to work on their behalf.

Mayor Noel Harty replied that it was last July. McCoy asked if he could see a copy of that contract. He also asked if Lannan is working on behalf of all Martin County residents. Lannan replied that he is only contracted with the city.

Brian Ader, who was in the audience, said he along with other residents and elected officials, met with Senator Mike Braun recently and they discussed the desire to just upgrade Highway 231. He said he appreciates what Lannan has been doing to help with the project. He said, at this point, the residents need to get onboard with helping steer the project to what would benefit Martin County. He said Martin County holds the purse strings currently with this project and Senator Braun, as a representative of Martin County, needs to be that representative. "He needs to listen to what we have to say," said Ader.

Mayor Harty said he is not in favor of the new highway but if it's going to happen, they do not want it to bypass Loogootee or that would cause major economical impact to the city.

Mark Nowotarski, who started the Coalition Against the Mid-States Corridor, was present and said he commends Loogootee residents for getting a meeting with

Martin County Made Day held

included in the budget.

Each year the township trustees are required by state law to file an annual report. Those reports, according to the state Gateway site, must be provided to the state for upload onto the state database 60 days after the end of the year. To view all reports, visit https://gateway.ifonline.org/report_builder/. Information directly from the state reports is broken down below for each township.

Rutherford Township

Per the 2018 US Census Bureau population estimate, Rutherford Township had 749 residents.

Rutherford Township's trustee is Terry J. Street. His clerical assistant is Renee Street. The three-member advisory board consisted of Virgil S. Street, Danny Berry, and Jeff Horney. In 2022, Rutherford Township began with a balance of \$59,135.38. After tax revenue of \$45,141.65 for the year and then disbursements, totaling \$40,797.39 the township ended 2022 with a balance of \$63,479.39. Of the \$40,797.39 that was paid out, \$18,458.76 went toward salaries and office expenses including the trustee's salary of \$6,180, his secretary's salary of \$3,090 and the advisory board member's salaries of \$643.66 each. To maintain the trustee's office in his home, Street was paid \$5,280, (\$440 per month) in rent, utilities, and phone for the township office and \$14,143.36 was reimbursed to Street for mileage. Rutherford Township paid Truelove Lawn Mowing \$2,000 to provide mowing of cemeteries and \$2,500 to Tree Pros, Inc. The township also gave \$14,296.47 to the Haysville Fire Department for a fire service contract and \$200 each was paid to Keith Keller, Kenny Haven, Brandon Epple, and Derrek Johnson from the firefighting fund. As for helping the poor, \$914.68 was given to two people (two households) who requested help last year. Of that \$504.33 was paid to Daviess-Martin REMC and \$410.35 to Premier Propane.

Halbert Township

Per the estimated 2018 US Census Bureau population estimate, Halbert Township had 1,604 residents.

Halbert Township's trustee is Exzelia Montgomery. Her clerical assistant is Pauletta Montgomery. The three-member advisory board includes Stephanie Horton, Travis Montgomery, and Kimberly Albright. Halbert Township started 2022 with a cash balance of \$318,627.94 and after tax income of \$47,869.52 and spending of \$64,409.42, the township ended the year at \$302,088.04

Of the \$64,409.42 total spent in 2022 by Halbert Township, \$28,741.97 was used to pay for salaries and office expenses including the trustee's salary of \$12,736.88, the clerical salary of \$4,155.76 and \$877.32 each to the three advisory board members.

Also \$3,022.83 (\$252.90 per month) was paid to Exzelia Montgomery for the use of her home and phone for the trustee's office.

For Halbert Township's cemetery care \$300 each was paid to Janie Johnson and Jaron Gibson, \$600 was paid to Marlin Courtright and \$1,200 was paid to Bill Keller.

For money given to the needy, 89 requests were made for help and 30 households received poor assistance, totaling \$13,567.45. Of the 27 households (85 total recipients) receiving help, money was paid to the following on behalf of those seeking help: The Bauer Family \$40, Kevin Boyd \$1,690, Centerpoint Energy \$478.47, CVS Pharmacy \$432, Daviess-Martin REMC \$3,212.81, Dubois Water Utilities \$88.39, Duke Energy \$2,691.87, Gill Funeral Home \$1,200, Orange County REMC

\$108.04, Premier Companies \$850, Shoals Municipal Utilities \$975.87, Tim Rincker \$250, Thorne-George Family Funeral Homes \$1,200, and Property Sure \$350.

Also, \$12,700 was paid to the Shoals Fire Department and \$7,000 to the Shoals Public Library.

Lost River Township

Per the 2018 US Census Bureau population estimate, Lost River Township had 567 residents.

Lost River Township trustee is Mildred Brown, and she does not pay a clerical assistant. The 2022 advisory board consisted of Alice Butler, Keith Emmons, and Bruce Fithian. At the beginning of 2022 the trustee's cash balance was \$76,266.33 and was \$87,095.52 at the end of the year, after \$40,867.86 in revenue and \$30,038.67 in expenses.

Of the \$30,038.67 paid out in 2022, \$7,432.21 was spent on salaries and office expenses including \$2,828.60 for the trustee's salary and three advisory board members were paid \$535.12 for the year.

Brown paid \$741.43 (\$61.79 a month) for the use of her home as the township office.

For cemetery care in Lost River Township, Blake Cooper was paid \$800, Keith Albright was paid \$1,000 and August Bauer and David Butler were paid \$500 each.

The township paid \$1,500 to the Shoals Public Library and \$15,000 to the Lost River Fire Department plus \$856 for insurance.

The township provided poor assistance totaling \$2,450.46 to five families with payments to Premier \$550, Daviess-Martin REMC \$547.60, Synergy \$532.86, Randy Stevens \$600, JayC Food Store \$100 and RJ's \$120.

Center Township

Per the estimated 2018 US Census Bureau population estimate, Center Township had 1,673 residents.

Center Township's trustee is Ann Stewart, and her clerk is Kevin Stewart. The three-member advisory board includes Norma Baker, Matthew Sullivan and Dean Crandall.

Center Township's cash balance was \$155,512.50 at the beginning of 2022. At the end of the year the balance was \$149,494.08, after tax income of \$48,980 and spending of \$54,998.42.

Of the \$54,998.42 spent last year, \$18,633.60 was spent on salaries and office expenses. Of that, \$7,360.08 was paid to Ann Stewart and \$1,993.18 to her clerk. The advisory board members were each paid \$613.34.

The Stewarts were paid \$2,400 (\$200 per month) for the use of their home as the trustee's office.

For cemetery care, \$2,300 was paid to Jayce Graber and \$1,900 was paid to Richard Ivey. \$3,800 was paid to Riggle and Sons Tree Service.

Center Township gave \$12,000 to the Town of Shoals for a firefighting contract and \$6,500 to the Shoals Public Library.

There were 43 poor assistance requests to the trustee last year and all were granted, totaling 28 households. The amount given in assistance in 2022 was \$9,864.82. The following was paid, Duke \$2,127.77, RJ's \$106.71, Shoals Municipal Utilities \$1,101.10, Shoals Senior Housing \$234, Propane Direct \$200, St. Vincent de Paul \$200, East Fork Water \$360, Kevin Boyd \$200, REMC \$1,959.35, Premier Ag \$606, Ruler \$161.12, Bauer Family \$183.11, CVS \$25.66, and Queen Lee Funeral Home \$2,400.

Mitcheltree Township

Per the 2018 US Census Bureau population estimate, Mitcheltree Township had 621 residents.

Mitcheltree Township's trustee is Tammy Gore and her clerk is Steven Anderson. The three-member advisory board includes Charity Tolbert, Sharon Belcher and Becky Sellers.

At the start of 2022, the trustee's cash balance was \$248,765.85 and stood at \$272,098.92 at the end of the year, after \$62,508.57 in tax income and \$39,175.50 in spending.

Of the \$39,175.50 spent last year, \$19,409.50 was spent on salaries and office expenses including \$7,000 for the trustee's salary, \$5,000 for the clerk's salary and \$800 for each advisory board member.

The trustee's office, located in Gore's home, had \$1,920 (\$160 per month) for rent and telephone expenses.

\$2,500 was donated to the Trinity Springs Mustering Elm Park and \$4,000 each was paid out to the Shoals Library. \$4,000 was given to the Indian Creek Fire Department.

\$6,500 was paid to Logan Dant for cemetery care.

There were seven requests for township assistance in Mitcheltree for 2022 and seven households helped for a total of \$2,766. Norbert Mattingly was paid \$200 and Daviess-Martin REMC was paid \$1,366 and Queen Lee Funeral home \$1,200.

Perry Township

Per the estimated 2018 US Census Bureau population estimate, Perry Township had 5,003 residents.

Perry Township's trustee is Jason Hennette and his clerk was Steven Anderson. The three-member advisory board consists of Brandi Hennette, Tony Dant, and Julie Green.

Perry's cash balance at the begin-

ning of 2022 was \$335,728.39 and was \$351,755.63 at the end of the year, after \$140,313.62 in tax income and \$124,286.38 in spending.

Of the \$124,286.38 spent last year, \$59,227.41 was paid in salaries and office expenses including \$18,000 for the trustee, \$13,000 for his clerk and \$2,500 for each advisory board member). \$11,500 to Gregory and Sons for repairs and maintenance and \$2,950 to Cameron Truelove for cemetery mowing.

A total of \$6,000 (\$500 per month) was paid in rent to Hennette for the use of his home as the trustee's office and \$1,681.49 was paid to Frontier for his phone and internet.

\$10,000 was paid to the City of Loogootee for fire protection and \$19,763.40 was paid to buy a new Kubota for the Loogootee Fire Department.

Perry Township gave out \$21,313.28 in poor assistance in 2022. There were 61 requests for assistance and what was paid out benefited 61 households. The following received payments on behalf of those seeking assistance: Charles Tedrow \$171.10, Stewart Blake \$250, Duke Energy \$7,337.18, Premier \$750, Martin County Cremation \$315, Ed Green \$200, Town of Crane \$1,000, Marie Truelove \$675, Larkin Apartments \$157, Rick Norris \$325, Centerpoint Energy \$1,067.86, Pam Loughmiller \$500, Martin County Co-Op \$469, Daviess-Martin REMC \$1,300, Propane Direct \$300, City of Loogootee \$1,849.43, Jay Smith \$300, Carl Wiscaver \$650, Matthew Wellokent \$200, and Blake Funeral Home \$3,000.

the senator. He said no one will meet with him, including Braun, Mark Messmer or the governor. He said he has been told the corridor is not a done deal, despite what the elected officials are saying. He said Martin County didn't have a seat on the RDA (Regional Development Authority), that started the Mid-States Corridor discussion, and this should have never been the case.

The comment period for the new environmental study ends March 31. Residents can send comments at <https://midstatecorridor.com/comments-and-questions/>.

In other business, the council approved Police Chief Aaron Means' recommendations to hire Wesley Baumgart as full-time patrolman, Kyle Long as assistant police chief, Tyler Davis as full-time patrolman and Alisha Wagoner as part-time dispatch. Means also reported that officer Dylan Erwin resigned but wants to stay on part-time.

Loogootee Fire Chief Eric Thomas, who took over as Loogootee Fire Chief at the beginning of the year, told the council that they have eight sets of turnout gear that have expired. He said in his first meeting with the department, he asked everyone to bring in their gear and this is when it was discovered. Fire gear only lasts 10 years, regardless of its condition. Thomas said the National Fire Protection Association (NFPA) requires the gear be destroyed so the eight firemen with the expired gear cannot respond to calls at this time. Thomas would like to buy 10 new sets of head-toe gear, eight for the firefighters with expired gear and two extra for new hires.

Thomas told the council that he is working to keep better track of inventory as chief and doesn't believe the council was educated on what the fire department needs by way of budget. He wants them to consider that all their equipment, down to fire truck tires, has an expiration date. He wants the council to consider this during budget time for 2024. He plans to slowly replace the turnout gear, four to six sets at

a time, until all 29 firefighters are outfitted.

The council approved the \$36,000 to come from the LOIT (Local Option Income Tax) fund for public safety. Council Member Teresa Nolley said this fund needs to be looked at because they are already paying three police officer salaries from LOIT. She said they need to make sure they have enough money in that fund before moving forward.

Chief Thomas also presented a signed letter from the former Loogootee Mayor Don Bowling regarding the original agreement with Air Evac for the landing zone in Loogootee. Thomas said he is aware the pickleball committee is moving forward with building new courts next to the landing zone however the contract with Air Evac says Bowling had agreed to a 100 foot by 100 foot area for the helicopter landing zone, that is free of debris. He said he is not against the pickleball courts but wants to make sure the area is kept the way it was agreed upon.

The mayor read an update from Clint Roos from Midwestern Engineers regarding the prep work they are doing for the drainage issue in Green Acres in the city. Roos said that Brandon Parker has completed getting locates and all utilities have been marked. Parker will now be in contact with property owners before survey work begins. Once the survey is complete, they will begin drawing up plans for the drainage improvements, including getting easements from property owners.

The council approved a quote for \$14,680 to completely remodel both bathrooms of the municipal building. It was noted that they had budgeted \$11,000 for the work last year.

A resident in the audience questioned whether the council was going to change the city ordinance that prohibits chickens. She said that the cost of eggs is very high and she doesn't see an issue with residents owning a few chickens, as long as they don't have roosters that will bother neighbors. Mayor Harty said they will discuss the issue in a future meeting.

A funeral service was held Saturday, March 11 in the Memorial Chapel of Chastain Funeral Home & Cremation

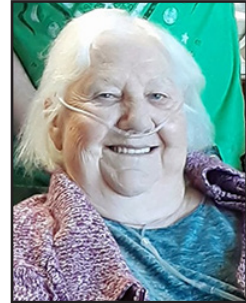

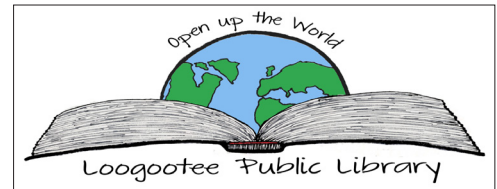

In the Garden

The warm weather that has pushed spring flowers into early bloom has certainly awakened the desire to garden. I want to dig in the soil and plant something! Indeed, I have already planted lettuce in the cold frame and St. Patrick's Day is the traditional day to plant peas. I may also plant some kale and other greens in areas where they may be covered if the mercury dips too far. However, I am keenly aware that it is just too early for planting most warm season crops and annual flowers.

Some vegetables, herbs and flowers do very well planted indoors and then transplanted into the garden after the May 10 frost-free date. Read your seed packets. Most will tell you if a particular plant may be grown indoors for transplants. In most cases, it will say that the seed may be planted six to eight weeks prior to the frost-free date. In Southern Indiana, that date is around May 10, so we are now in the indoor planting period.

First, get your pots ready. If re-using containers from previous years, empty out the old soil and wash the pots with hot water. You do not have to use the fancy trays used in commercial greenhouses. Any pot that has good drainage will do.

Next, get the potting mix ready. Do not use soil from your garden and I do not recommend using potting soil, especially if the soil you have contains fertilizer. The seed contains all of the nutrients needed by the tender plant for its first weeks, and the added nutrients may result in spindly plants. I suggest using a soil-free mix, usually containing mostly coir or peat. You will notice that bags of seed-starting mix are very light. This is because there is little moisture in them. Before you use the soil, slowly mix water into it. You do not want it soggy, but such mixes do not absorb water easily if you do not add the

water before planting.

You may need to get the seeds ready also. Most seeds do quite well planted directly into the potting mix, but some seeds need special treatment. Read the packet to see if soaking the seed is recommended. Other seeds need to have a cold treatment, which may be accomplished by putting the seed in the refrigerator for a few days. Other seed need to be scarified by breaking the outside layer with a knife, file or rough sandpaper to ensure rapid germination.

The information on the seed packet also will tell you how much potting mix needs to be used to cover the seed. Some seeds actually need light to germinate. Plant the seed and spray the pots with water. You may cover the pots with clear plastic to help hold in the moisture.

Some crops benefit from bottom heat to promote germination. You may purchase heating mats made for this purpose, but you may also get the needed heat from your appliances. The top of a refrigerator or freezer may be warm enough to provide the heat needed, and since light is not needed by most seeds at this stage, the pots may be left on the appliances until the seeds germinate and then moved to an area where they young plants will receive light.

If you are depending on the sun to provide the light needed for plant growth, you will have to rotate the pots frequently to ensure the tender plants do not grow toward the window. You may decide to invest in some grow lights. This is not as expensive as it once was. Today, there are LED grow lights that are inexpensive. As the plants grow, you may need to adjust the lights and eventually remove the plastic coverings. Keep the plants watered and you should have some healthy transplants by the time the weather warms enough for outdoor planting.

Farmer sentiment dips in February

The Purdue University/CME Group Ag Economy Barometer dipped 5 points to a reading of 125 in February. Farmers' perspectives regarding both current conditions on their farms and expectations for the future also weakened. The Index of Current Conditions fell 2 points to 134 and the Index of Future Expectations declined 6 points to 121. The Ag Economy Barometer is calculated each month from 400 U.S. agricultural producers' responses to a telephone survey. This month's survey was conducted February 13-17.

"Increased concern over the risk of falling output prices, rising interest rates and uncertainty over the future growth of U.S. agricultural exports is weighing on producers' minds," said James Mintert, the barometer's principal investigator and director of Purdue's Center for Commercial Agriculture.

Producers' expectations for their farms' financial performance in 2023 compared to 2022 weakened in February. The Farm Financial Performance Index declined 7 points to a reading of 86. Farmers continue to point to concerns about higher input costs (38 percent of respondents), rising interest rates (24 percent of respondents) and lower output prices (18 percent of respondents) as their biggest concern for the year ahead.

Agricultural exports have been a key source of growth for U.S. agriculture for decades. Beginning in 2019, the Ag Economy Barometer survey routinely included a question asking producers about their expectations for agricultural exports in the upcoming five years. Since peaking in 2020, when just over 70 percent of respondents said they expected exports to increase in the upcoming five years, the percentage of farmers looking for exports to grow over time has drifted lower. In February just 33 percent of survey respondents said they expect exports to increase, which leads Mintert to suggest that a lack of confidence in future agricultural export growth is contributing to weakened senti-

ment among producers.

Despite strong farm income, the February reading of the Farm Capital Investment Index changed little, rising 1 point to a reading of 43. This month 72 percent of producers said it is a "bad time" to make large investments in their farming operation, while just 15 percent reported it is a "good time" to make such investments. The disparity between producers' responses to the question and actual farm equipment sales continues to be focused on costs. Of those who said now is a "bad time" to make large investments, 45 percent of respondents said it was because of an increase in prices for farm machinery and new construction, while 27 percent of respondents said it was because of "rising interest rates."

Producers' expectations for short-term and long-term farmland values fell in February but remain positive. The Short-Term Farmland Value Index declined 1 point to 119 while the Long-Term Farmland Value Index dropped 5 points to 137. Although both indices remain above 100, indicating a positive outlook on farmland values, the percentage of producers who said they expect values to decline over the next five years reached 19 percent this month, the highest percentage since this question was first routinely included in barometer surveys in 2019. Still, over half (56 percent) of respondents expect values five years from now to be higher than today. This month just 33 percent of respondents said they expect values to rise in the next 12 months, while 14 percent said they expect values to weaken.

Each February, the barometer survey includes a question focused on farm growth, asking respondents about the annual growth rate they expect for their farm over the next five years. This year 49 percent of respondents said their farm either had "No plans to grow" (33 percent) or "Plan to exit or retire" (16 percent). Of those respondents who expect their farms to grow, 19 percent expect it to grow by "Less than 5 percent annually," and 22 percent said they expect it to grow by "5 percent to 10 percent annually."

To the editor of the *Martin County Journal* and Mitcheltree residents,

Are you aware the bridge near Fred Sims Road on Highway 450 is being replaced? More than likely you are aware by now and know it is greatly needed due to flooding on the highway. But are you aware this will be a complete closure? No one lane with a light or a bypass to go around construction? The detour is through Lawrence County. The estimated time for the closure is 8 months. And we know how that works with Indiana weather, construction setbacks, supply shortages and such things that delay projects by the state.

I am NOT against the bridge replacement. It is very much needed. I am against a state highway being closed for 8 months, cutting over 600 people off from medical emergency and law enforcement services. If I call an ambulance and it is at the civil defense building, it will take them over 45 minutes to get to me ONE WAY. 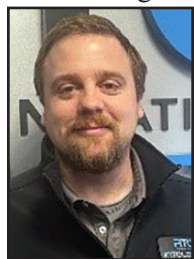
