Information on the COVID-19 virus

Reported illnesses have ranged from mild symptoms to severe illness and death for confirmed coronavirus disease 2019 (COVID-19) cases.

The following symptoms may appear 2-14 days after exposure: Fever, cough, and shortness of breath

According to the Martin County Health Department, no one has been tested for the virus in Martin County, therefore no one is known to be positive.

Early information out of China, where COVID-19 first started, shows that some people are at higher risk of getting very sick from this illness. This includes older adults, people who have serious chronic medical conditions like heart disease and diabetes and lung disease.

If you are a close contact of someone with COVID-19 or you are a resident in a community where there is ongoing spread of COVID-19 and develop symptoms, call your healthcare provider and tell them about your symptoms and your exposure. They will decide whether you need to be tested, but keep in mind that there is no treatment for COVID-19 and people who are mildly ill may be able to isolate and care for themselves at home.

The CDC offers the following advice: Stay home when you are sick, call your health care provider's office in advance of a visit, limit movement in the community, and limit visitors

The virus is thought to spread mainly from person-to-person, between people who are in close contact with one another (within about 6 feet) and through respiratory droplets produced when an infected person coughs or sneezes. These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs.

People are thought to be most contagious when they are most symptomatic (the sickest).

Some spread might be possible before people show symptoms; there have been reports of this occurring with this new coronavirus, but this is not thought to be the main way the virus spreads.

It may be possible that a person can get COVID-19 by touching a surface or object that has the virus on it and then touching their own mouth, nose, or possibly their eyes, but this is not thought to be the main way the virus spreads.

How easily a virus spreads from person-to-person can vary. Some viruses are highly contagious (spread easily), like measles, while other viruses do not spread as easily. Another factor is whether the spread is sustained, spreading continually without stopping.

The virus that causes COVID-19 seems to be spreading easily and sustainably in the community ("community spread") in some affected geographic areas.

In a continuing effort to slow the spread of COVID-19, Indiana Governor Eric J. Holcomb has announced additional ef-

Shoals Council discusses mobile home ordinance, clean-up days

The Shoals Town Council met Monday, March 9. In attendance were Council Members Cecil Ragsdale, Cary D. Albright, and Clint Hoffman; Clerk-Treasurer Sierra Rutledge, Town Attorney J. David Lett, SVFD Chief Jim Hamby, Beautification Board President Amber Hoffman, Kathy Collins, Monty Holt and Chris Bearden.

Chris Bearden stated he owned a lot on Stephens Street and is requesting to move out the current mobile home located on the lot and move a newer model in. He stated the old mobile home would be sold to Monty Holt. Mr. Holt was also in attendance and requested approval to move the mobile home he was purchasing from Bearden and place it on a lot he owns on 2nd Street. The trailer being moved in would also be replacing an older model mobile home. Pictures of the mobile homes were presented to the council.

Council Member Cecil Ragsdale asked if both mobile homes would be completely underpinned and decks placed. Bearden and Holt stated they would. Council Member Albright made a motion to approve Bearden's request of the mobile home placement with Council Member Hoffman making the second. All were in favor. Council Member Albright made a motion to approve Holt's request and Council Member Hoffman made the second. All were in favor.

The council thanked the both gentlemen for coming. Council Member Ragsdale asked both gentlemen if they were aware of the new law concerning safety tie downs and both said they were aware and that both mobile homes would have the safety tie downs.

Beautification Board President Amber Hoffman came before the council with an update on projects. Hoffman requested up to \$600 from the board to complete projects that will be constructed with money from the donation fund and the community foundation grant. Council

Member Albright made a motion to approve the request from Hoffman with Council Member Ragsdale making the second. All were in favor. Amber Hoffman stated they hope to have the projects complete before the Catfish Festival. She stated the board was busy making plans for grant applications and seeking donation requests for pots, soil and tools. She stated with one grant they are seeking to do improvements to the overlook. The board thanked Hoffman again for all of her hard work.

Council Member Ragsdale brought up the property clean-up updates. He requested an ordinance 83-4 violation letter be sent to a property on Low Street and another property on High Street.

Clerk-Treasurer Sierra Rutledge presented the council with a sheet of fund balances for all funds. She also gave the council the 2020 ballpark cleaning contract with a recommendation from the park board. The park board recommended the contract be awarded to Roger Jackson. Rutledge stated there were no changes from the previous year's contract. Council Member Hoffman made a motion to approve that the contract be awarded to Jackson with Council Member Albright making the second. All were in favor.

Rutledge presented an amended Resolution 2019-2 to the board. Resolution 2019-2 sets a rental fee and requirements for rental of the ballpark. The amendment lowers the rental fee to \$150 and requires a liability insurance policy to be provided. Council Member Albright made a motion to approve amended Resolution 2019-2 with Council Member Hoffman making the second. All were in favor.

Rutledge stated the small scoring table located at the little field at the ballpark had deteriorated and needed replaced. She contacted Mr. Kent at the Shoals Community School and the shop class

have, and in return, their students would be counted as students of the Shoals Community School Corporation.

The elementary principal recommended hiring an elementary homebound teacher for the 2020-2021 school year. The board approved.

The high school principal requested permission for IU to provide another year with a career advisor counselor for the 2020-2021 School year, which is free to the school. The principal also requested for GM to provide a free distracted driving presentation on April 10, 2020. The board approved.

The board approved graduation date be set for May 23 at 2 p.m. in the main gym.

The board approved the athletic department's request for physicals to be held April 23 or May

6.

The board approved the following facility usage requests:

-Southern Indiana Gold Basketball to use the gymnasium.

-Summer League to use the cafeteria for baseball and softball signups and also the gym for baseball pictures. The date is to be announced.

-Shoals Christian Church to use the gym for the Good Friday Service. Also, to do a cookout for the softball and baseball teams in late May.

-Shoals Lions Club requested to host the annual Easter Egg Hunt in front of the Schools on April 11 at 1 p.m.

The board approved the following fundraiser requests:

-The Shoals Beta Clubs to sell tickets for 31 Bingo prior to the event on March 13. Funds will be used to help Beta students pay for National and State Beta Conventions.

-The high school softball team to have a spaghetti dinner on April 4 to raise funds for a new pitching machine and other equipment.

-The high school softball parents to sell Texas Roadhouse rolls to purchase equipment needed and items for the team.

Superintendent Candace Roush recommended summer school for three weeks during the 2020 summer for students. The board approved.

The board held the first reading of the summer job coach job description.

A driver's education program will be held during the summer of 2020 at the Shoals High School.

Middle School Principal Austin Malone reported on the procedures and awareness that the students and staff are using for the coronavirus. Testing this week will be the 3rd and final NWEA window. Malone attended the Edmentum Rural Education Summit on March 3 and 4. He met with 20 other leaders similar to Shoals as well as attending a live panel with five educators as they answered questions and provided strategies pertaining to leading a school in a rural setting. He wanted to thank Doug Wagoner for always being helpful, kind, and being one step ahead of everything. He also wanted to thank the middle school faculty for building student relationships and their cooperation. He said they value their teachers and everything that they do.

Elementary Principal Shannon Wagoner reported that all hands are on deck with the current coronavirus situation. All of the teachers have been phenomenal and creative with getting the e-learning days prepared in advance. Fundraisers have been a huge success. They were able to raise up to \$20,000. The funds that were donated will be used towards field day. iRead will be next week. Ms. Wagoner was able to visit the FabLab in Chattanooga Tennessee last week for three days. There were so many ideas that they will be able to use at the school.

Dr. Roush informed the board that the vaping convocation for students and in-

formational meeting for parents that was scheduled for next Monday has been postponed until May and the IU School of Education tour was postponed until later in the year. Dr. Roush explained how excited she was to travel to Chattanooga, Tennessee to view their new innovation labs because Shoals will have one in place by next school year as a pilot school for ROI. Dr. Roush thanked the Padanaram community for their invitation to view their school as well as a wonderful breakfast with their community members.

Dr. Roush explained to the board that the Special Education Co-Op at North Lawrence was dismantling, and the school will be hiring a school psychologist as well as a behavior and autism consultant next year. The federal funding that went to Joint Services will be coming back to the school to pay for those positions.

Dr. Roush updated the board about a road closure on SR 150 that will last from the middle of March until the middle of May.

Dr. Roush thanked Janie Johnson for her many years of service and dedication to the Shoals Community School Corporation. She will be missed by many.

Finally, Dr. Roush congratulated all of the fall sports teams as well as the robotics team who won the semi-state championship and due to the coronavirus will not get to play their state championship game.

The board also offered a big thank you to the nurses for being ahead of the game with the Coronavirus and they appreciate everyone's help in the matter.

The meeting was adjourned at 7:11 p.m.

The following are additional directives from Governor Holcomb.

Indiana will adhere to the Centers for Disease Control and Prevention for large events and mass gatherings. The guidance recommends no in-person events of more than 50 people. Here is a link to the guidance: <https://www.cdc.gov/coronavirus/2019-ncov/community/large-events/mass-gatherings-ready-for-covid-19.html>

Under the current guidance for schools, 273 public school districts are closed, using e-learning days, or on spring break and have announced a future closure. The Department of Education is working with the remaining 16 school corporations to determine their next steps and needs

Bars, nightclubs and restaurants are required to close to in-person patrons and may provide take-out and delivery services through the end of March

Hospitals and ambulatory surgical centers should cancel and/or postpone elective and non-urgent surgical procedures immediately. This action will help the healthcare system conserve resources and personnel necessary to meet emerging health needs

Physicians should continue to perform critical procedures necessary to prevent short-term and/or long-term adverse effects to their patients' overall health

The state's Emergency Operations Center has been raised to a Level 1 status and will work in conjunction with the incident command center at the Indiana State Department of Health for planning, coordination, predictive analysis and other functions

State employees will maximize the use of remote work and meet virtually whenever possible while maintaining operations. Non-essential in-person meetings will be limited to 10 persons or less and should meet virtually whenever possible. High-risk individuals should not attend meetings in person

State employees over the age of 60 with underlying health conditions are advised

The clerk-treasurer then presented the current Sitex Corporation agreement that is up for renewal. Rutledge stated the price had just increased again and she thinks that another service would be cheaper. Council Member Albright stated the board does not want to renew the agreement. Town Attorney Lett advised Rutledge to notify the corporation in writing.

Rutledge presented the council with a sample of one new set of street pole banners for Main Street. Council Member Albright made a motion to purchase the set of banners with Council Member Ragsdale making the second. All were in favor.

Rutledge stated the "Spring Clean Up" date needed to be set, and she recommended it be set for the same day as the beautification board volunteer day which is May 16. The board agreed for Spring Clean Up to be May 15-17, 2020.

Rutledge asked for approval to try a 1st annual "town-wide yard sale" for Shoals. After discussion with all those in attendance, the dates for the event were set for Friday and Saturday, May 15 and 16. Hoffman asked, with it potentially being a very busy weekend in Shoals, if caution signs could be placed at each end of town for safety. Fire Chief Hamby stated he would talk to INDOT about some congested area signs. Rutledge stated the Jug Rox Student Volunteer day

in town would be May 7, 2020.

The clerk-treasurer presented two meter deposit applies for C. Sims and J. Campbell and a transfer for S. Harding/T. Hewitt. Council Member Albright made a motion to approve the meter changes with Council Member Hoffman making the second. All were in favor. Rutledge stated that a property on Lynwood Street, that has been discussed for a potential project area, needed a decision to move forward or not. Council Member Albright made a motion to have Town Attorney Lett investigate the purchase of the property and retain appraisers. Council Member Hoffman made the second and all were in favor. Rutledge stated water main flushing will take place starting on Sunday, March 22 and should be completed by Tuesday, March 24.

Fire Chief Jim Hamby gave an update from the recent ISO inspections and presented the invoices from Nichols Fire & Fleet for assistance with the inspections. Hamby stated he felt that everything with the inspection went well and he is striving to lower the rating for Center and Halbert townships through a fill and dump timing exercise with the current fleet equipment. Hamby let the council know he is working on setting up a joint meeting with the town and Center and Halbert townships concerning fire protection information.

With no further business, Council Member Albright made a motion to adjourn with Council Member Hoffman making the second and the meeting closed at 6:56 p.m.


The Loogootee Public Library will be closed until further notice.

Martin County jobless rate bumps to 2.9 percent in January

Martin County's unemployment rate bumped up to 2.9 percent in January, from 2.1 percent in December. The county had the 8th lowest jobless rate in the state for January, tied with Gibson, Johnson and Steuben counties.

In January, the county had 5,378 residents in the workforce and 155 of them were unemployed. In December, there were 5,360 residents able to work and 113 of them were without jobs.

In January of 2019, Martin County's jobless rate was 3.5 percent with 5,341 residents in the workforce and 188 of them unemployed.

Daviess County's unemployment rate also moved up from 2.3 percent in December to 3 percent in January. The county had the 12th lowest jobless rate in the state for January, tied with seven other counties.

In January, the county had 16,748 residents in the workforce and 504 of them were unemployed. In December, there were 16,728 residents able to work and 390 of them without jobs. In January of 2019, Daviess County's unemployment rate was 3.5 percent with 16,704 residents in the workforce and 583 of them unemployed.

Dubois County's jobless rate moved from 1.9 percent in December to 2.7 percent in January. The county had the second lowest jobless rate in the state for January, tied with Boone and LaGrange counties.

In January, the county had 22,959 residents in the workforce and 615 of them were unemployed. In December, there were 22,989 residents able to work and 446 of them without jobs. In January of last year, Dubois County's jobless rate was 3.2 percent with 23,128 residents in the workforce and 730 of them unemployed.

Greene County's unemployment rate jumped a full point to 4.7 percent in January. The county had the 10th highest jobless rate in the state for January, tied with Blackford County.

In January, the county had 13,692 residents in the workforce and 637 of them were unemployed. In December, there were 13,669 residents able to work and 509 of them were jobless. In January of last year, Greene County's unemployment rate was 5.7 percent with 13,929 residents in the workforce and 794 of them unemployed.

The top ten spots in the state for lowest jobless rate for January were Hamilton County at 2.6 percent, Dubois, Boone and LaGrange counties at 2.7 percent; Jackson, Hendricks and Bartholomew counties at 2.8 percent; and Steuben, Martin, Gibson and Johnson counties at 2.9 percent.

The top ten spots in the state for highest jobless rate for January were Crawford County at 6.1 percent, Vermillion County at 5.8 percent, Lake County at 5.3 percent, Starke County at 5.1 percent, Fayette County at 5 percent, Jasper, LaPorte, Newton and Sullivan counties at 4.8 percent; and Blackford and Greene counties at 4.7 percent.

Indiana's unemployment rate drops to 3.1 percent for January and remains lower than the national rate of 3.6 percent. The last time Indiana's unemployment rate was lower than 3.1 percent was November 2000. The monthly unemployment rate is a U.S. Bureau of Labor Statistics

(BLS) indicator that reflects the number of unemployed people seeking employment within the prior four weeks as a percentage of the labor force.

Indiana's labor force had a net increase of 3,749 over the previous month. This was a result of a decrease of 877 unemployed residents and an increase of 4,626 employed residents. Indiana's total labor force, which includes both Hoosiers employed and those seeking employment, stands at 3.39 million, and the state's 64.4 percent labor force participation rate remains above the national rate of 63.4 percent.

Employment by Sector

Private sector employment has decreased by 1,300 over the year and has grown by 8,400 over the previous month. The monthly increase is primarily due to gains in the Trade, Transportation and Utilities (3,600); the Leisure and Hospitality (3,200); and the Private Educational and Health Services (2,600) sectors. Gains were partially offset by a loss in the Manufacturing (-4,800) sector. Total private employment stands at 2,741,900, which is 7,400 below the new January 2019 peak.

Memorial Hospital opens alternative screening site

As they continue to closely monitor and proactively plan for COVID-19, Memorial Hospital and Health Care Center has developed an Alternative Screening Site, located at 695 West Second Street (entrance on the west side of the building- follow the yellow signs) for those patients who do not require emergency department services, but who have symptoms of fever, cough, and respiratory congestion or shortness of breath.

Services provided at this site will include the following: testing for influenza A & B, strep throat, respiratory syncytial virus (RSV), and chest x-rays. At this time, they are unable to provide COVID-19 testing at this site or at the Memorial Hospital Emergency Department unless the patient meets the criteria defined and authorized by the Indiana State Department of Health.



Road closure scheduled for US 150 in Shoals

The Indiana Department of Transportation announces a complete road closure on U.S. 150 in Shoals.

Beginning on or around Monday, March 23, contractors will close U.S. 150 at a location about two miles east of the junction of State Road 550 and U.S. 150 for a geological slide repair and replacement of small drainage structures. This is the first of three locations in which work will be performed.

In the Garden

For more than a hundred years, each March, people have come out for the Chicago Flower Show and the unofficial beginning of spring. The show has weathered two world wars, the Great Depression and countless other obstacles. However, a virus has brought the show to its knees in 2020. Like so many other events, the Chicago Flower Show has been cancelled. I have been to the show in the past, but I always seem to make it to the Indianapolis Flower and Patio Show, which usually is about the same time and is a lot closer. I had tickets for that show this year, which should be happening this week. It, too, has been cancelled.

Many cities host spring (or late winter) flower shows. Serious gardeners and hobbyists alike look forward to these shows. The shows usually include nationally known speakers, landscapes built inside buildings and vendors galore. I usually buy some specialty seeds at a spring show. There are also booths filled with plants, tools and garden décor. The lack of shows to attend this year makes it seem like spring will be delayed.

Actually, we will have a rather early spring this year. The vernal equinox will occur on Thursday, March 19 at 11:49 p.m. The fact that February had 29 days this year results in the equinox's occurring a day earlier on the calendar. Most calendars show March 20 as the first day of spring. It is the first full day, but for 11 minutes, it will be spring on March 19.

For first time gardeners, my best advice is to start small. You do not need to grow everything in the seed catalogue. DNR-managed reservoir facilities remain open

The Indiana Department of Natural Resources operates Brookville, J.E. Roush, Salamonie, Mississinewa, Cecil M. Harden, Cagles Mill (Lieber SRA), Patoka and Monroe lake facilities and services through long-term leases with the U.S. Army Corps of Engineers (USACE), which constructed them. The USACE manages the dams, water levels and acreage immediately around the dams.

All Indiana DNR-managed facilities at these lakes, including campgrounds, wildlife areas, boat ramps, nature centers, property offices, and other public facilities and services remain open at this time.

The public facilities managed directly by the U.S. Army Corps of Engineers at or below the dams at these lakes (tailwater areas, observation mounds, etc.) are closed.


HUNTER HIGHTOWER
