# Shoals robotics team finishes season at state championship

The Shoals High School First Tech Challenge (FTC) robotics team "Jug Rox Robotix" completed their competition season with the title of Indiana State Championship Winning Alliance. The 2018 Indiana State Championship was held at Crawfordsville Senior High School on Saturday, February 24 and comprised of 32 other teams that had advanced from six qualifying events. The Jug Rox teamed up with Warrior Tech out of Denver, Indiana and Pixelated out of Granger, Indiana to obtain the title through several double elimination rounds. This was the icing on the cake for the Jug Rox after a very successful year at the qualification tournaments that lead up to state cham-

In addition to the title of Winning Alliance the Jug Rox were finalists for the "Think Award" at the state championship which is given to the team who's engineering notebook focused on the design and build stages of the team's robot and exemplified their journey as a team and engineers. The first part of the FTC robotics tournament consists of a judging interview in which the team presents the robot design and activities of the team during the design and build process. The second part of the FTC robotics tournament consists of a head to head competition of the robots.

# Loogootee School updates board on police presence

The Loogootee School Board met last Thursday, March 15. Board Members Chad Wade and Scott Hall were not present at the meeting. The main topic of discussion was the school hiring a resource officer. Loogootee Police Chief Kelly Rayhill spoke briefly about what his officers have been doing at the school each day from 7:30 a.m. to 3:30 p.m. He said they spend time in various areas of both schools, including being in the parking lot before and after school and in the cafeteria during lunch. He said the students have been very receptive to the officers, offering hugs and high fives.

Each of the six officers at the Loogootee Police Department have been taking turns on their time off to provide the school security each day, however, Chief Rayhill said they would like to get that down to just one officer in the future, for more unification. Rayhill also stated that the school's technology manager was able to download the school's security cameras on the officers' phones, so they can watch areas where they are not stationed. Chief Rayhill said they've encountered minor issues just about every day since they have been providing security. Superintendent Chip Mehaffey said he's had the chief on speed dial for the past few years so the police can handle is-

sues that arise, such as matters pertaining to the department of child services, adults without permission coming in to pick up a child or custody issues. He said that many people in the community believe having an officer at the school is solely for security but it's way more than that.

Superintendent Chip Mehaffey said that the school has received several grants over the past year-and-a-half, totaling \$380,000. While those grants are not for school safety, he said this frees up money in the general fund to pay for the resource officer and the school has plenty of funds available to cover the position's salary. "As long as I am superintendent, the school will have a resource officer," said Mehaffey. He also noted that, each year, the school applies for two grants associated with school safety but so far, Loogootee has not been approved for either. He said the state does not have enough money allocated to help every school.

Superintendent Mehaffey also reported to the board that 60 community members attended an ROI (Regional Opportunity Initiative) meeting at the school last week. Lilly donated millions of dollars to ROI for the Ready Schools Grant for schools to get students better prepared for employment after high school, that doesn't necessarily involve a college degree.

# Senior Marine Corps leader visits NSWC Crane

On March 13, Lt. Gen. Daniel O'Donohue, the Marine Corps' Deputy Commandant for Information, and his team visited Naval Surface Warfare Center, Crane Division (NSWC Crane) to learn more about Crane's work in areas such as cybersecurity, expeditionary warfare, and electronic warfare.

Lt. Gen. O'Donohue's visit came on the heels of Marine Corps Commandant Gen. Robert Neller's trip to Crane last October. Following his visit to NSWC Crane – the first time a Marine Corps Commandant had ever visited Crane – Gen. Neller encouraged Lt. Gen. O'Donohue to make a trip of his own as soon as possible.

In 2015, Gen. Neller formed an information warfare task force to lead development and integration of new information warfare capabilities. That task force led to the establishment of the Deputy Commandant for Information last year, a position for which Lt. Gen. O'Donohue was appointed by the Pentagon last June.

In his role as Deputy Commandant for Information, which was established to reflect the reality that information will play a large role in any future conflict, Lt. Gen. O'Donohue oversees all aspects of information warfare within the service.

"We were honored to host such a distinguished visitor at Crane," said Tricia Herndon, the Director of NSWC Crane's Special Warfare and Expeditionary Systems Department. "Lt. Gen. O'Donohue is leading the way in the evolution of technology for operations in the information environment. The realization that NSWC Crane is a critical partner for the success of this mission is exciting, and it challenges our workforce to reach beyond the art of possible."

During the visit, Lt. Gen. O'Donohue and his team saw a few of NSWC Crane's nationally-recognized technical labs and toured each of Crane's three mission areas – Expeditionary Warfare, Electronic Warfare and Strategic Missions.

NSWC Crane remains the largest Naval Sea Systems Command (NAV-SEA) Warfare Center provider to the Marine Corps, and the collaboration between the two organizations continues to grow.

"Any day that we can host senior leadership from the Marine Corps – or any service – on base, it is a great day

for Crane," said Alan Kirkman, NSWC Crane's Marine Corps Customer Advocate. "Lt. Gen. O'Donohue was very impressed with the Crane culture and the attitude of our tremendous workforce. He specifically noted Crane's enthusiasm, patriotism and can-do attitude, and indicated that this was the first of many visits for him and his team to Crane."

#### -- WAYS TO GIVE BACK --

In the last few weeks I've talked about scholarships and support of some cemeteries in our county. Those types of grants are possible through "scholarship" funds (surprise, huh?) and "field of interest" funds for the cemeteries. This week I'm going to give some examples for what "designated" funds can support. As a reminder, designated funds provide support to specific charitable organizations.

#### -- LIBRARIES --

Let's say you have a passion for making sure that our kids have good places to learn and opportunities to grow. Our public libraries are great places to build upon and expand the education that our schools so importantly provide. This year we had a \$750 grant from the Loogootee Public Library Fund and a \$572 grant from the Shoals Public Library Fund. These are designated funds whose payouts every year go straight to the organizations they support.

#### -- EDUCATION --

Another of our designated funds is the Whitfield Men's Club Educational Fund. This year's payout of \$2,169 went to the Men's Club for educational purposes. As you can see, a lot of the

designated funds are named for the organization they support. That's the choice of the donors and generally is a good idea.

We also recently granted \$3,651 to the Loogootee High School from the William McGovern II Fund. This fund was set up to split the payout between qualified seniors to help with their continuing education.


#### -- OTHER ORGANIZATIONS -





Last Saturday, I accompanied some fellow master gardeners on a trip to Goose Pond in Greene County. I often mention that one of my favorite winter activities in the garden is feeding and watching the birds. Sandhill Gardens is a certified wildlife habitat, so I have plenty of birds to watch. However, Goose Pond offers a different type of bird-watching. We went in search of the whooping crane and sandhill crane, and we were not disappointed. We also saw a wide variety of water birds, including ducks, geese, swans, coots, and white pelicans.

Historically, great areas of Indiana were covered in shallow water. Most of the swamps and wetlands were in the northern portion of the state, but the area between White River and the Wabash River had some wetland basins, including the area now known as Goose Pond. During the late 1800's most of Indiana's wetlands were drained and used for farm land. However, many farmers using the land often lost crops to flooding. As scientists came to acknowledge the value of these wetlands, conservation efforts were initiated and some wetland areas were recreated. The former owner of Goose Pond had entered into a permanent easement with the Natural Resources Conservation Service, which paid him to revert the farmland to wetlands. In 2005, the Indiana Department of Natural Resources bought the 7,200acre farm and the Goose Pond Fish and Wildlife Area was established.

As a fish and wildlife area, Goose Pond offers many types of recreation, including hunting and fishing within certain guidelines. Some adjoining properties have been purchased, and along with the Sullivan-Greene State Forest, which borders the property, an

area of some 20,000 acres offers many chances to explore the outdoors.

Goose Pond is not a pond in the traditional sense, but a series of shallow areas of water. Many areas are accessible by automobile. There are areas where tenant farmers still raise crops on the property and some areas have been planted in native wildflowers as a part of the monarch butterfly conservation effort.

A member of Friends of Goose Pond met our group and gave us an informational program at the visitor's center, which opened in 2016. He then escorted the group to areas where he had seen the cranes and pelicans earlier in the morning. He said we were a few weeks late for the peak season, as many types of shore birds use Goose Pond during their migrations. However, many of the birds have already left for more northern areas. Next year, I plan to go in February to do some bird watching. However, I also plan to visit the wildflower areas during the summer. There really is something of interest in all seasons for folks who love the outdoors.

I did get some gardening done over the weekend. I planted peas and onions in the garden and continued planting seeds for bedding plants in the greenhouse. I also burned off some of my tall grasses and did some other spring cleaning. There is still plenty to do, so I hope to have more nice days for gardening

Several more varieties of daffodils have burst into bloom. The hyacinths have also started to open. I have several along the walk from the driveway to the house. If funds allowed, I would plant hyacinths all along the walk. They supply a very pleasant scent when going down the walk. Spring is a treat for all of the senses.

### Emergency rule expedites repair of bridges, crossings and stream banks damaged by recent flooding

recent localized flood damage, temporarily eases DNR license requirements for specific repair or reconstruction was signed into effect by DNR director Cameron F. Clark.

Work covered by the rule includes repair or reconstruction of bridges and culvert crossings, and the stabilization and repair of unstable stream

Application of the rule is limited to work within a county under a state declaration of Disaster Emergency between February 24 and March 31. For a project to be authorized under this rule, it must be completed by March

An emergency rule that, in light of 14, 2019. Counties where a Disaster Emergency has been declared can be found at IN.gov/gov/2384.htm.

Property owners in the affected area who have specific questions about coverage should contact the DNR Division of Water at 877-928-3755 (select option 5 when answered), or by emailing at water inquiry@dnr.

This emergency rule only addresses property that falls under DNR jurisdiction. Other state, federal or local approvals may also be needed for some repairs.


