#### County, Loogootee, Shoals receive state road grants

Last week, INDOT announced 224 Indiana cities, towns, and counties received a combined \$133.4 million in state matching funds for local road projects through Community Crossings, a component of the governor's Next Level Roads program.

Martin County received \$1 million, Loogootee received \$619,340.25 and Shoals received \$206,982.42.

Launched in 2016, the Community Crossings Matching Grant Program provides funding to cities, towns, and counties across Indiana to make improvements to local roads and bridges.

Community Crossings is a partnership between INDOT and Hoosier communities, both urban and rural, to invest in infrastructure projects that catalyze economic development, create jobs, and strengthen local transportation networks.

Since 2016, the state has awarded over \$1 billion dollars in state funds to support local road and bridge projects throughout Indiana.

Cities and towns with a population of fewer than 10,000 match the funds received by 25 percent.

## Loogootee Primary mayoral candidates answer questions

MCJ: Tell us about yourself (Education, family, experience, etc.)

**Noel Harty:** I am a 1997 graduate of Shoals Jr./Sr. High School. While in high school I also attended the North Lawrence Career Center with a concentration in business and office occupations. After high school I attended the Missouri Auctioneers School going on to receive my auctioneer's license in the State of Indiana in the spring of 1998. After attending auctioneers' school, I attended the RECP Program in Bloomington and went on to obtain my real estate license as well in the spring of 1998. While working in food service for 10 years, as a manager at McDonald's and Stoll's Lakeview Restaurant, I attended food safety training and ultimately attended Vincennes University Jasper- Campus with a concentration on business management. Unfortunately, my responsibilities while working in food service and working as a licensed real estate agent and auctioneer made it difficult for me to finish my studies at the university. In 2006, I would decide to run for Perry Township Trustee. I held this role until the end of 2011, assisting residents who were not able to pay items such as rent, utility, or medical bills. In 2009, I left Stoll's Lakeview Restaurant after almost 10 years deciding to focus on other present endeavors along with becoming a school bus driver for the Loogootee Community School Corporation which I still do today. While I loved being township trustee, I decided that perhaps I could help the community in an even bigger way by running for Mayor of the City of Loogootee. So, as most if not all of you are aware, I ran for mayor in 2011 and began my first term in 2012. Since becoming mayor, I have attended countless training courses such as the Mayors Institute and economic development workshops. In addition to training, much of my experience has come from the past 11 years I have served as mayor along with the many organizations I am affiliated with. My parents, Kenny and Dee Sanders, who I love very much, reside in Shoals. My sister, Dawn Farrell, lives in Lancaster, Pennsylvania as well



With Arbor Day approaching, it is time to begin planning and shopping. Planting a tree on Arbor Day is more than a tradition. It is one of the best ways to help your world. However, it is not something to be done without planning. There is a lot to consider.

The first consideration is who will plant the tree. Arbor Day plantings are often a group activity. Many teachers involve students in the act, using the occasion for teaching some science. It is also a good activity for scouts, 4-H clubs and other organizations. Tree planting need not be limited to children. It is a good way for adult groups to share an evening outside. Perhaps the best planting team is members of different generations of your family. A tree planted by a family may become a special memory that tends to draw the family together in the future.

You then need to decide where the tree will be planted. If you own your home, you may wish to plant a new tree on your property. Otherwise, you will need to get permission to plant a tree in a public place. Many parks and forests appreciate having trees planted. Some schools allow classes to plant trees on school property. You still have time to make some contacts to find a place for tree planting. There are many other factors in siting a tree. You will want to choose a place where the tree will have room to grow to its full potential. For this reason, you will need to do some research into the tree you will plant. Whether you are planting a seedling, a sapling or a larger transplant, you must consider the eventual mature size of the tree. Always plan on a tree's reaching the largest potential size. Many trees have had to be cut down because they out-grew the available space. I just cut a tree I had planted a few years ago. It had been mislabeled. I thought I was planting a small tree that would only reach 15 feet tall, but it was a different species that grew too close to the electric lines. While you cannot know if something has the wrong label, do your best to avoid planting trees where they will not have room to mature.

Trees perform many functions, and the function you need determines the type of tree you will plant. You may want a tree for shade. Perhaps you wish to start or add to a home orchard. Beauty is in the eye of the beholder, and while I find most trees beautiful, you may be looking for something that has eye-catching flowers or perhaps evergreen foliage to be attractive in the winter. Many people plant evergreens as windbreaks or to buffer one's living area from busy street noises. Trees may be used to block unwanted views or to define approaches. Trees are invaluable in attracting wildlife. Trees provide food and shelter for birds and many other members of the animal kingdom.

Get busy! You have your homework assignment, but with the internet, it is easy to find information about trees and help finding the best fit for your needs and desires. Next week, I will tell you some of my personal favorite trees and the reasons I like them. I will also give you some instructions that will help your tree get off to a good start. Planting a tree is an activity that will provide consequences for many years.

## PURE COUNTRY Throwback By Dan Gregory

Corn planters started to roll this past weekend in Martin County. The farmers have pulled open the big machine shed doors and dropped the hitch pins between tractors and planters, coupling some of the most impressive planting equipment and technology known to agriculture, with horsepower capable of moving the machines efficiently and rapidly in fields from end-to-end and back again. If you think about the methods of putting seed to soil, it bears little resemblance to those of just a century ago. The massive tractors with climate-controlled workstations, hydraulics capable of lifting thousands of pounds with the flip of a switch or pull of a lever, monitors that tell the operators everything that is happening, and GPS equipment that will match the exact location of the machine in a field with a plot on a map. Given the right circumstances, a single planter unit can plant hundreds of acres in a day.

My first experience with corn planting was forty-some years ago. We had a four-row planter that didn't do all that bad in the little fields we were working in at the time. I enjoyed seeing the corn and bean rows pressed neatly behind the planter and it wasn't like work at all to plant from dawn to dusk. When finished, a field resembled a neatly combed head

On our way home from Jasper tonight I saw two farmers working the river bottom fields along the White River. With the equipment these guys have, I told Barb it wouldn't surprise me if they had the fields they were in completely planted by this time tomorrow. The soil looked just right and smelled like spring soil should smell.

The beginning of the growing season is one of hope and expectation. The risk

of the process is well known to these multi-generation farmers of the land. They have seen it all; flooding, drought, hail, and crop diseases. There are no guarantees of a harvest, but there is a careful calculation that involves all the risk factors of crop production. To farm the land requires a certain type of personality. One that tries to balance science with nature, and a healthy dose of dealing with adversity. The upside to the profession is the knowledge that only a few are left, and the rest of us depend on their skills and tenacity to supply the food we all depend

I have said this many times and, in many ways, but I think it bears repeating. The farm machines used in modern production agriculture have vastly outgrown the roadways. Moving from field-to-field is truly a safety issue. Most farmers are considerate of cars and trucks, but the reality is there are few opportunities to get them off the roadways completely or even partially, not to mention that visibility is often not that good either. I plead with you to be aware of the risk involved with following and passing these machines and give our farming professionals the room they need to maneuver these expensive and complex machines. The seconds or minutes saved by an unsafe pass are not worth the risk.

Teresa Nolley: As I have always been proud of the Loogootee School system, I have been equally proud to say I am from Loogootee. Having been involved in many boards and civic committees this past 8 years, I understand the many opportunities that are passing us by. It is time we find ways to capitalize on them and get our city moving forward.

MCJ: How do you feel businesses are doing in Loogootee? Is there anything you could do, as mayor, to help with economic development for existing businesses and attracting new businesses in the city?

**Noel Harty:** I think while all our local businesses are facing the same dilemma of obtaining products to sell and the

competition of online shopping, many are still doing well. I think Loogootee is no different than any other community right now in the United States still trying to rebound from COVID-19. For some it has been easier than others but tough in general, none the less. I have worked in the past and will continue to do so being a member of the Martin County Alliance for Economic Growth to assist in finding ways to fill the gap of losses of income when tragedy strikes for local business. I think in relationship to attracting new business, we have to have the available space. These spaces also almost have to be move-in ready. I feel our greatest way in continuing to move forward is to keep an inventory of what is available and perhaps what each location's needs might

be. We actually have already begun this process and I feel it is our biggest step to finding economic growth in the city and the county.

Teresa Nolley: As all businesses do, I'm sure Loogootee businesses wish they could do better. Obviously, growth in our city would help them. I feel the biggest obstacle for most is the need for employees. We need to work with the county's economic director, our Purdue Extension office, the school, and all state agencies to make sure all available resources are brought to our businesses.

MCJ: Stormwater issues have been a huge problem for the city for a long time. What do you plan to do to fix this? And do you have a timeframe?

Noel Harty: The stormwater issues throughout the city are, without a doubt, some of our biggest challenges. Over the last few years, the city has worked very diligently, with the help of Midwestern Engineers and the Southern Indiana Development Commission, in obtaining grant funding to address some of these issues. The city will continue to do this in the future as has been done in the past by utilizing Economic Development Income Tax funds and funds created from the stormwater fee to match these grants. However, this will be a much slower process than any of us, including me, want to bear. I think the real answer is much larger funding needs to be allocated from the state through larger grants to address these issues so many communities such as ours have.

**Teresa Nolley:** Time frames are almost always at someone else's mercy. That being said, we should very actively put together at least a 5-year plan to start working on the issue. Sticking an orange cone in it and walking away is not the answer. We need an aggressive attack on grant writing and setting aside matching funds to support those grants.

MCJ: What are your thoughts on the Mid-States Corridor?

**Noel Harty:** As I have gone on record many times stating, I fail to see the need for a new road. It would be wonderful to make upgrades to the existing roads we have and make accessibility to our fair city easier. I vote no to the Mid-State Corridor.

Teresa Nolley: The only explanation for this has been to increase development and speed travel time. With I-69 being so close, and the lack of development on it, we should be demanding more answers. I am not for the Mid-States Corridor in Martin County! But if given no other option I will work aggressively to make sure it benefits us as much as possible.

MCJ: What do you believe is the most pressing issue facing the city right now?

**Noel Harty:** As was mentioned in question four, I believe one of our pressing issues is continuing to make upgrades to our stormwater system. I also believe that the city needs to focus as much as we can on housing. The city is currently working on a development with private developers that will create the possibility of 40 new homes. However, the work does not stop there. We need to continue to move forward looking for ways to create new housing and developments.

Teresa Nolley: We must understand our budget and plan on the ways we use our money. Planning is the best way to save. Use the resources we have to move forward. Our people are our best resource, we must find a way to activate them into using their talents for the good of the city.

MCJ: Is there anything else you would like to get across to the voters?

**Noel Harty:** I have loved my time as mayor and if re-elected, will continue to work for the best interest of our residents!

**Teresa Nolley:** Voting is the first course of action. Vote on MAY 2, 2023. I would appreciate a vote for Teresa Nolley to be the next Mayor of Loogootee.

Board. Councilwoman Crew made a motion to accept the recommendation with Councilman Abel making the second and all were in favor. Council Member Albright thanked Brown and the Beautification Board for all of their continued dedicated hard work in the community of Shoals.

Ordinance Enforcer Cecil Ragsdale updated the board on property ordinance violations he has served to date and new violations served since the last meeting. Ragsdale said he has also issued three open burning violation warnings since the last meeting due to receiving complaints of burning of non-allowable items per the Indiana burning regulations and guidelines.

Ragsdale recommended the council allow him and Attorney Lett authorization to contact a bank that has a property of concern in foreclosure about the issues on the property needing to be addressed. Councilwoman Crew made a motion to approve authorization with Councilman Abel making the second and all were in

Ragsdale stated he had members of Indiana Landmarks in town today to look at the old Nu Tap building and stated while they were onsite they visited other historic buildings in the downtown area. Ragsdale stated it was a good meeting and he will provide an update once he has one from them.

Council Member Albright stated he wanted to provide an update on the wastewater system improvements project.
