





The experts say one should garden with a plan. A plan will result in a garden that has been thought out, with every plant having been selected to fill a specific purpose. Plants in a planned garden would be spaced properly and each would be in a place it will thrive.

That is all good, but we all know that no matter how much we plan, life sometimes throws a curve ball. On Saturday, after attending a memorial for a relative near Terre Haute, I returned to Sandhill Gardens to find that a storm had passed through in my absence. The walk leading to my house was blocked by a large limb that had fallen from one of the large silver maples in my yard. My plans for the rest of the weekend were immediately changed.

The first order of business was to assess the damage. t was, in fact, a very large limb, with the largest portion being about 15 inches in diameter. I was relieved to find that it had narrowly missed a treasured birdbath, but it smashed a cedar raised bed cart. The smaller branches came down across some flower beds. Somehow, it managed to come down between a black pussy willow and an Itea that is in full bloom. There were a few broken branches, but a few snips with the pruners and one could hardly see that there had been any damage. The butterfly bench was unscathed, and the butterfly kinetic sculpture was fine when set back upright. However, some of the plants in the bed did not fare so well. A weeping cedar was damaged beyond repair and had to be cut out. A Sunrise redbud tree had a couple of major limbs broken. I will work on shaping that tree. It should recover in time, but it will likely never have the natural form that was a big part of the original selection of that tree in that spot. A red weigela in full bloom was flattened. However, once the tree branches were removed, it began to

recover, and some hummingbirds found its tubular flowers. I will give it a few days to further recover before doing any more trimming. It will come back from the roots in a couple of years if heavy pruning is necessary. A sweet bay magnolia growing on the other side of the sidewalk was hit by some of the outer branches, breaking off some of the small magnolia branches. The tree was poised to start blooming, and it lost several of those wonderful-smelling buds. However, there does not appear to be any major damage to the tree. Beyond that, there were some perennials that were flattened, but should recover. Of course, the time spent cleaning up took away from other planned garden activities, including digging and dividing perennials.

There were some benefits from the incident. I will have a start on next winter's firewood. The clean-up put me into a bed where a small callery pear tree had sprung up, and I was able to remove that invasive plant. It has also served as the impetus to clean out some weeds in the

In this situation, there is not a real change in the growing conditions for the area. The limb was large, but the tree is huge, and one limb did not affect the canopy area very much. Sometimes, losing a tree or a large limb result in a shady area's becoming a sunny bed. In such a case, the shade plants would have to be moved to a more-appropriate area and one would have the opportunity to design a bed for plants that need a lot of

No matter how much we may plan, we must be ready to respond to the changes that are thrust upon us. Gardening and life have a lot in common.

Grants available for field trips to state parks, lakes

Educators interested in taking K-12 students on field trips to an Indiana state park or state-managed lake in the 2022-2023 school year can receive financial help through the Indiana Natural Resources Foundation (INRF).

Grants from the Discover the Outdoors fund are available for public, private, parochial, or home-school educators, according to INRF executive director Jody Kress.

"The Foundation's mission is to celebrate and preserve Indiana's natural legacy," Kress said. "This grant gives children an adventure that showcases some of Indiana's natural and cultural treasures and teaches the importance of protecting and preserving them for everyone to enjoy."

Since the grant program's inception in 2013, a total of 153 grants have been awarded, providing the opportunity for more than 17,000 students to visit state parks at less cost to the schools and stu-

Indiana has 24 state parks, eight state-managed lakes, two state recreation areas, and two off-road state recreation areas eligible for field trip funding that will engage students in learning about Indiana's fish, forest, wildlife, natural habitats, conservation, and outdoor recreation opportunities.

The Candy Mill Carolyn Parsons-Downey

"My family and my parents have definitely been a huge factor in who I am today, and even the locations where I've lived, I had been gone for 25 years living in other places which shaped who I am.

I actually started baking candy at home. It began with cookies, which I no longer do anymore. Someone had asked me to make cookies for a company that no longer did gift baskets they would send to their customers and asked me to bake cookies to give to people, and from there I got an order. Then I just kind of thought that if I wanted to do this again then next year I want different candies, so I just kind of played around and made different candies, tried different things at work. They were my guinea pigs so I would make something, and I asked, "good or bad?" I just got their opinion so every year I added things. I had worked with a lady that kept telling me about these cake balls that she had for a graduation party. She kept telling me I should try to make them. It took me around a year until I ever got around to trying them, so then I spent the next year or so making them and figuring stuff out. So then, I was no longer working outside of home. I just kind of did it at home for fun, but then you make this stuff you have to get rid of it.

I joined the Chamber of Commerce in Martin County to get connections and get advertisements. I mostly advertise on Facebook, since I was just advertising from home and then through the Chamber, I found out about the candy store that is already there, but she sold bulk candy, nothing homemade. So, when that became available, I thought I'd like to buy it, but it's kind of scary because we had owned a business before in Jasper, so you have to know your overhead and your cost. You have to know what it's going to cost to do this business if you can make it on what you're selling. I really didn't feel comfortable about it, but when I talked to the owner at the time, she said there were living quarters in the back. We had thought about renting it out to people to help with income, and then we went to see the building, and I couldn't imagine renting it to anybody. We had already talked about downsizing and so we decided to make a plan to sell our home and live there to do the business, because it's kind of our overhead. Even if I no longer did the candy store everything could still be taken care of and paid for. I actually called it the Gingerbread House of Candy.

When I went to do my business, I had to adjust because I could no longer use eggs unless I was safe certified, but I could use pasteurized eggs to get around that. I am still inspected by the board of health every year, so they do come in and inspect everything. But when we bought this business, we had to build a whole new kitchen because you have to have a certain setup. So, I had to build a whole other kitchen. Now I have two kitchens in my home and over the years I slowly got rid of the bulk candy, and I do nothing but homemade there now. Now that I do work other places again and Covid was my big killer, I just do orders and special occasions now.

My family was very supportive, probably the biggest thing was they couldn't believe we were leaving our dream home to move



into town. Things have changed in my life. My mom has cancer and I've got a grandson. And so, I didn't have the time to put it in the home and I realized that wasn't as important as other things.

As of right now, I am not planning to expand my business. I also do work outside the business. I am retiring in eighteen months. To be honest I even thought of closing it this past year. I had set everything up to get ready to close it and then my grandson wanted to keep it going. Now I am looking to pass it down even though he is only eleven, but I make him come and do the stuff. And it's kind of good cause when I retire, I may want to do the business at that time.

The bad thing right now is the food prices have gone up, which means I have to raise my prices. Then you think about how many cake balls it takes to pay the bills. The downfall is you always have to make sure you make enough money to cover your overhead. During my first year, I never got a paycheck from my business, but it always paid my bills.

That was the one thing I was taught through another business is that when you have your own business you have to put yourself out there. That was my thing about joining the Chamber. I met so many people through there and when I did banking even though most stuff is done online they still walk in and they see your face.

So that's another thing people kinda lose out now. I was always told if you need a cup of coffee don't go through the drivethrough go in and get it so people can see your face.

So that's another thing you have to do in person and with Covid, we really lose that, but that was the huge thing you have to put yourself out there. Before my business, my first job was I worked for an optometrist here in Loogootee when I was in college, and I was an office manager and now that I think of that I think how scared I was when I was eighteen and I ran his office. After that, we had moved away, and we moved 11 times in 7 years to give you an idea. So, it was really hard for me to get a job so then finally my husband's company hired me. We were at a restaurant where the interstates connected and there was a gift shop, so I ran the gift shop there. And then a few years later their company hired me again and I was their kitchen manager for restaurants for about 4-5 years. And then when we moved to Jasper that is how I got into banking altogether. I have about over 30 years with a German American. Most of my life I've done banking.

The struggle of owning my business is that I don't sell anything that people have to have. I sell something people want. I sell something that's not really healthy for people. January is what I call my slow month. I get all my taxes ready in January because everyone is out of money from Christmas and on a diet.

My favorite part of my job is probably the sales part, the customers coming in, when you're busy baking all day you want people to talk to. In five years, I might still be doing it but my grandson, when old enough, might be the one to take over and run it. If someone is thinking of running a business, people need to research really hard.
