## Commissioners open paving bid, approve ARPA money spending

The Martin County Commissioners met Tuesday, May 30.

County Attorney Dave Lett opened the one bid received for Community Crossings grant paving from E&B Paving. The bids were for sections of the following roads:

County Farm Road \$234,224.10  
Cherry Road \$188,726.60  
Rama Dye Road (two sections) \$44,689.40 and \$145,034.50  
Sherfick School Road \$104,766.40  
Rutherford Road \$81,339

The total cost for all the paving is \$798,800. It was noted that the county received almost the maximum of \$1 million and also has the 25 percent match. The roads were put at a high estimate, however the costs associated with road paving have gone down. They will apply again in July to regain the rest of the money not spent.

The commissioners tabled the bid from E&B Paving so it could be reviewed prior to the next meeting.

Highway Superintendent Scott Seals reported he ordered the grader the commissioners approved purchasing at their last meeting. He expects it to be late in the year before it is delivered.

Seals said one of his long-time employees has turned in his notice. He said he greatly appreciates the 30 years the employee gave to the county. Commissioner Paul George agreed saying he's been a great employee.

Veteran Service Officer Jonathan Cropp said he found out veterans, in the past, have been using the county's veterans' van and driving themselves to their medical appointments. He said he is putting a stop to that but wanted the commissioners to know because he is sure they will receive complaints. Commissioner George said those veterans are not on the county's insurance policy and should

not be driving the van. He said this is the first time he has heard this was happening. Cropp said he will inform veterans that if they have a working vehicle and are able to drive themselves, they need to do that. He said the veterans' van will be available to those who do not have the transportation.

Ambulance Director Jeramey Osborn reported they have had 466 ambulance runs for the year and have received around \$135,000 in insurance and reimbursements since the ambulance service began last August.

Osborn presented the commissioners with estimates to purchase items needed to get the ambulances ALS (Advanced Life Support) certified now that the county has a sponsor hospital and can perform paramedic-level services. He said Dr. Andrew Waters, with IU Health, will serve as the county's medical director and IU Health, Inc. will be the county's sponsor hospital. Osborn didn't have the contracts, yet, for the commissioners to sign.

The cost to purchase the equipment, which was originally a part of the ambulance start-up costs, is \$127,980.49. This also includes the purchase of cameras for the ambulances that provide a 360-degree view around the vehicles. He said they could be beneficial with insurance claims. The commissioners approved the purchases to come from the ARPA (American Rescue Plan Act) funds.

As a part of the money approved, the commissioners added an additional \$10,428 to J&K Communications for mobile radios that were purchased. Osborn said he inadvertently forgot to turn in the invoice to be paid after he had to go with a different vendor for radios. Some of the money has already been paid.

The commissioners also discussed a request from Osborn to purchase a chase vehicle for the ambulance service. The paramedic chase car is designated ALS and is always dispatched with an ambulance. (See 'COMMISSIONERS' on page 2)

## Carter's Legacy 5K to be held June 10 at Boggs

The Carter's Legacy 5k Walk/Run is held every year in loving memory of Carter Lee Kerns, son of Alyssa and Ed Kerns. Carter died in a tragic accident the day before his first birthday. Determined to bring good from tragedy, his parents founded the Carter Lee Kerns Memorial Fund, a permanent endowment fund established at the Martin County Community Foundation. Annual payouts from this fund will go to support

non-profit organizations that work to enhance the lives of children and families in Martin County. All race proceeds will go to the Carter Lee Kerns Memorial Fund held and administered by the Community Foundation Partnership Inc. on behalf of the Martin County Community Foundation.

The run/walk will be at West Boggs Park (by the beach house) on Saturday, June 10. Pre-registration is available on <https://runsignup.com/Race/IN/Loogootee/carterslegacy> or via paper forms at

Kerns Insurance and Running With Scissors Salon.

Onsite registration begins at 8:30 a.m. and the walk/run begins at 10 a.m. Ages 0 - 17 is \$15, 18+ is \$25. Both include a shirt. Awards will be given for the top three males and females in each category:

<18, 18-33, 34-49, 50-65, >65. Plaques will be awarded for the top male and female overall. The Shriners will be participating by leading the race with their karts. Other fun activities for participants include blowing bubbles, making sidewalk chalk art and eating snow cones.

10 a.m. - 5K begins

11 a.m. - 5K award ceremony begins

This event will occur rain or shine.

## Fountain repairs

Loogootee Mayor Noel Harty chose the new downtown fountain back in February 2021. The marble fountain was shipped from a company in New York early last year and installed in April of 2022. Since that time, it has had issues with leaking water and has had to be turned off several times. According to Mayor Harty, they are working this week to reseal the bottom of the fountain to keep the water in. That is supposed to be completed by Friday. Harty said they have discussed removing the top of the fountain due to its height and the wind causing water to blow outside the structure. Last year, the company where the fountain was purchased, sent a new top, however, Mayor Harty said that top is smaller than the current one and would not be any more beneficial. To date, \$89,200 has been spent on the downtown fountain, with \$20,000 of that coming from the Martin County Community Foundation and \$12,000 from Hoosier Uplands, in the way of grants. The rest has come from the City of Loogootee General Fund and EDIT (Economic Development Income Tax) fund. The fountain itself cost \$39,500 with the additional work around the fountain making up the remainder of the \$89,200. It is unclear how much the additional repairs will cost at this time.

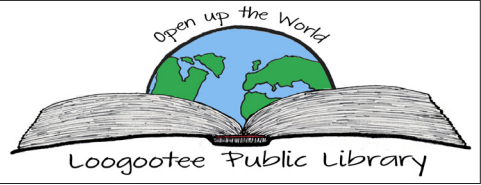




## LHS Scholarships

bulance capable of transporting the patient. The chase vehicle is equipped with a complete set of advanced life support equipment. Commissioner George said they would have to finance the vehicle because they cannot spend that much out of ARPA funds, or they would wipe out what is left. Commissioner George asked Osborn to get estimates on the cost and then they can check around with banks about financing.

Emergency Management Assistant Director Andy Ringwald told the commissioners that the civil defense building, that now houses the ambulance service, needs four more controllers for key fobs. He said they have two exterior doors, a supply room and a tool room that need the controllers. The cost is \$6,422.50 through Area One Protection.

Commissioner Cody Roush asked if regular keys would be cheaper.

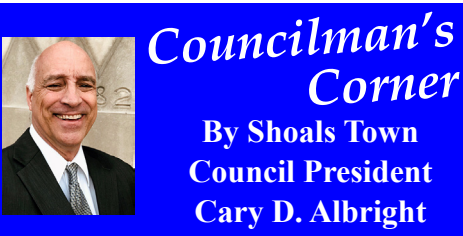
Ringwald said they would prefer to have the key fobs, so they don't have to track down keys when someone quits. He said they have also had issues with tools missing in the past from the tool room.

The commissioners agreed to pay the cost from ARPA funds.

A resident, who owns property near the WestGate Tech Park, talked to the commissioners about his 86 acres in Martin County, not sure if the county would be interested in purchasing it. He said he recently learned that due to a new law, homes cannot be built near Crane base, so he cannot sell it for that purpose. At-

torney Lett said federal law says there must be a buffer around military installations. He suggested the resident speak to Alliance Director Jessica Potts because she is well-versed in the law and can possibly help him. Commissioner Roush said houses cannot be built on the property however he could still sell the land to someone wanting to do manufacturing or commercial property. Attorney Lett asked to speak with the resident after the meeting to get his contact information for Potts.

The commissioners approved allowing the tourism board to use the commissioners' credit card for purchases. Auditor Norris said the board found out that if they hold onto the money collected for the innkeeper's tax, they are required to provide reports etc. to the commissioners. So, they have transferred their \$54,000 balance to the county so bills can be paid by the auditor's office. She said they need access to the money, however. The commissioners' credit card limit is divided between more than one entity and Norris said there isn't much left to provide to the tourism board unless they lower someone else's spending threshold. Ambulance Director Osborn, from the audience, said he may be able to lower the \$30,000 card limit he has but he will have to check on it and report back. The tourism board would like to have a limit of \$5,000 to \$10,000.

Spring has sprung in Martin County and summer is right around the corner. Sorry, I have not updated my column lately. I've been out with hand surgery for the last few months.

Here are a few things we need to be aware of.

We all want to get out and do yardwork right now. Be very careful around your water meter lid. We have installed very expensive new electronic read water meters. You will see the antenna that's attached to the top of the meter lid. It's a silver disk. Please stay away from small silver plastic, compound round disk with your weed eater and lawnmowers. If this becomes damaged, they are very expensive to replace and they will be the responsibility of the property owners to replace them.

Our infrastructure project has begun, and we're making necessary repairs in order to keep our wastewater system in operation. On the freshwater side of our operations, you'll see crews out replacing old water meters with our new electronic read water meters. We have the majority of meters replaced. The ones we are going after now are the difficult ones that are not so easy to replace. This may be done in phases.

I am concerned about the issues you addressed. I have never resolved an issue from somebody that has refused to identify themselves. 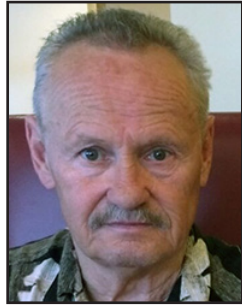

## In the Garden

It's all about the connections. I got a lesson in connections in my garden this week. As mentioned in my last column, the beautiful Arum dracunculid bloomed. It was spectacular. The bloom was about 18 inches long! This unusual plant grows right outside the picture window in my living room, so I could see that flower as I sat and ate my breakfast by the window. It is good to view the Arum through the window. Getting that close on the outside would mean enduring an almost unbearable stench of rotting flesh. However, that scent plays an important role. It attracts flies, which pollinate the plant. Also outside that picture window are several bird feeders and a birdbath with a solar fountain. I do a lot of birdwatching through the window. I get a lot of different birds that visit the feeders. However, there are some birds that do not frequent the feeders. Although I know they are present in the gardens, I do not get close-up views of them often. On Saturday, while admiring the Arum through the window, a flycatcher swooped down right in front of me and scooped up a fly. It was definitely the closest I have ever witnessed a flycatcher.

That made me think about just how much my garden is connected to the animal kingdom. Sandhill Gardens has been certified as a wildlife habitat, and many creatures call it home. In recent days, I have seen all sorts of insects and birds. I have seen squirrels, rabbits and chipmunks, a box turtle, salamanders, toads and frogs. I watched a deer romp through the meadow and saw an opossum and a groundhog at the edge of the woods. During the winter months, I put out some food for the wildlife, but in the summer, the garden feeds them and I try to understand that some garden damage is the price I pay to have this window on the natural world.

### Spring Mill State Park hosts program on railroad history

Spring Mill State Park will host What do Railroads Do?, a talk on railroad history, on June 17 at 2 p.m. in its Pioneer Village tavern.

Two long-distance railroad lines were built close to Spring Mill in the 1850s. These lines were a big reason the milling business was successful in the village, and why there was flour milling in nearby Mitchell. A similar story played out in Jackson County, where a mill in Rockford closed, but a new mill opened in nearby Seymour, a town the railroad ran through.

David Nord's presentation will compare these two stories and talk about how the railroads changed these areas. Nord is a professor emeritus of journalism and adjunct professor emeritus of history at Indiana University. He is a former interim editor and associate editor of the Journal of American History of Spring Mill and Lawrence County. The journal

It has been a great week for butterflies, also. Monarchs have received a lot of press in recent years, and most people, by now, are aware that the monarchs have a connection to milkweeds. It is the only plant on which the caterpillars of the monarchs feed, and for that reason, monarchs lay their eggs on milkweed. However, other types of butterflies also have specific connections to plants. The pipevine swallowtail relies on pipevine plants, and I delight when I see holes in this vine. Various butterflies rely on trees, flowers, herbs, grasses and even weeds for their larval food sources. Most adult butterflies feed on nectar from flowers, but some feed on animal dung, tree sap and other food sources.

I point out these things to demonstrate how connected our gardens are to everything around us. Our actions make a difference. If we decide to spray something to kill an insect, we may "save" a plant, but that poison becomes a part of the system. Birds, amphibians and mammals that feed on the insects will ingest that poison and may die. Pesticides may even cause health problems for humans, so their use should be very limited. Variety in a garden will also ensure that more types of animals will be able to survive.

I usually caution visitors to Sandhill Gardens that they will find plenty of weeds and insect damage. It certainly is not a finely manicured landscape, but there is variety, and it is alive. There is also great natural beauty.

Come out this Saturday, June 3, for the annual Sandhill Gardens Plant Swap. It will be from 10 a.m. until noon. The address is 3061 N. County Road 810 W., West Baden Springs.

### -- MALLORIE SUTTON --

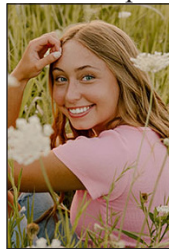

### -- LINDSEY NOLAN --

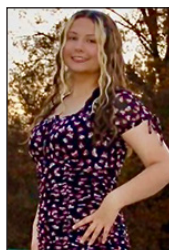

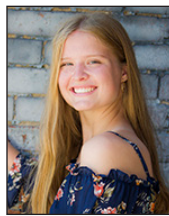
### -- SHAWNA MASON --

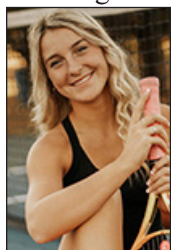

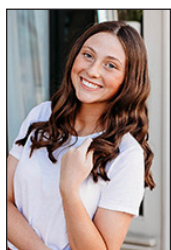

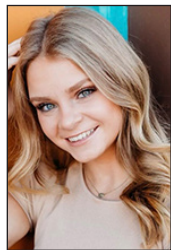
