## Shoals Catfish Festival starts tomorrow

The 27<sup>th</sup> Annual Shoals Catfish Festival will begin tomorrow, Thursday, June 30 with a business decorating contest at 5 p.m. followed by kids and chalk on sidewalk in front of G&R Variety at 6 p.m. and the annual auction at 7 p.m.

On Friday, softball, kickball and basketball tournaments will be held at the ballpark at 6 p.m. Opening ceremonies will take place on the stage at 6:30 p.m. and the queen contest will start at 6:45 p.m. The Dave Smith Family and Lakefire Warship will perform at 8:30 p.m.

On Saturday, the catfish contest on the bridge will begin at 7 a.m. A 5K walk/run will start at the ballpark at 7:30 a.m. and an adult volleyball tournament will begin at 9 a.m. The kickball tournament will resume at 10 a.m. and a corn hole tournament will start at the boat landing also at 10 a.m. The baby contest will be held at 10 a.m. at the fire station followed by a Horseshoe tournament at the boat landing at 2 p.m. "Rumble by the River" wrestling will be on the stage at 7 p.m. The Martin County Museum, along with the Albright Open House, will be held on Saturday from 10 a.m. to 4 p.m. A chainsaw carving demonstration, by Rick Chastain, will take place near the stage from 11 a.m. to 4 p.m.

On Sunday, July 3, the bridge catfish contest will continue from 7 a.m. to noon. A youth volleyball tournament will begin at the ballpark at 10 a.m. An egg toss will start at 3 p.m. in front of the post office and a "Friendly Feud" will be held on the main stage at 4 p.m. A gospel sing will end Sunday's events on the main stage at 6 p.m.

On Monday, the Catfish Festival parade will start downtown at 10:30 a.m. followed by the Big Catfish weigh-in at the fire station from 8 a.m. to 11 a.m. The cooking contest will be held on the east side of the post office at 2 p.m. along with the Battle of the Bands on the stage at the same time. Fireworks will end the festival at 10 p.m. at the ballpark.

## Commissioners discuss highway grant, ambulance service

The Martin County Commissioners discussed the Community Crossings Matching Fund (CCMG) grant at their meeting Tuesday night, June 28. The county didn't receive any funds in the first round of the 2022 CCMG grant cycle, which goes to road and bridge repairs. Due to the increase in fuel costs and the higher bids anticipated, all but two roads were removed from the application for the second round. Commissioner Paul George said those two roads are still estimated to cost close to \$900,000. The maximum

anyone can receive in CCMG funds for each calendar year is \$1 million. The two roads that will be paved, if the state approves the grant application, are Brett Road, from the highway to Rama Dye Road and Rutherford Road, from Beard Road to WR Cemetery Road. The work on Brett Road also includes replacing a culvert but that cost is not included in the grant application; the county will pay for that out of budgeted funds. The second round of the CCMG opens this Friday.

In other business, Highways Superintendent Scott Seals said they are doing a lot of mowing, along with filling potholes.

Jim Williams, Martin County Solid Waste Director, told the commissioners that the recycling center plans to add their employees to the county's insurance policy. The recycling center would still pay the premiums however Williams hopes that by going in with a bigger pool of insured, it will lower their rates. He said there are currently only two employees who receive insurance at the recycling center, but they will be adding more once the employees reach their full employment. Williams said he will go to the county council to inform them as well.

Dena Held introduced Dr. Casey Mull, Assistant Director of Extension and 4-H Youth Development Program Leader, who was visiting Martin County and presenting a program that evening at the fairgrounds. Dr. Mull talked to the commissioners about the importance of 4-H and the impact it has on youth development.

Courtney Hughett, volunteer with the Martin County Humane Society, presented the animal shelter's budget request for 2023. She told the commissioners that the animal shelter has taken in 110 dogs and cats so far this year and has spayed and (See 'COMMISSIONERS' on page 2)

## "Trooper of the Year" goes to Loogootee grad

The Indiana State Police held their annual awards ceremony yesterday to recognize troopers and state police civilian employees throughout the state for various accomplishments and awards. ISP employees were recognized for their service, bravery, and devotion to the department and the citizens of Indiana.

Through his hard work and dedication to public service, Trooper Adam McBeth has been selected as the "2021 Trooper of the District" by the Command Staff from the Jasper Post. The factors used to determine the "Trooper of the Year" included, but were not limited to, traffic and criminal enforcement, community involvement, and special assignments such as SCUBA, ERT, Meth Lab Team, Instructor ratings, or other services performed for the department that goes beyond normal expectations.

Trooper McBeth was awarded a plaque that read, "Presented to the Trooper who has achieved outstanding enforcement efforts in the areas of traffic and criminal enforcement, case and crash investigations, public information programs, and community service, and who has exemplified the professionalism and integrity expected of an Indiana State Trooper."

McBeth graduated from the 75th ISP Recruit School in 2015, he grew up in Comanche County, Oklahoma, and Martin County, Indiana having moved to Indiana in 1997. McBeth graduated from Loogootee Jr./Sr. High School in 2003. He attended Vincennes University, earning an associate degree in Conservation Law Enforcement in 2005. McBeth enlisted into the United States Army as a Military Police Officer and paratrooper in 2007 and served 5 years. Serving a year deployment to the Logar Province in Afghanistan from May 2009 through May 2010.

Upon his graduation from the Indiana State Police Academy, McBeth was assigned to the Jasper Post where he has served as a road trooper, having patrolled Crawford County. He has also patrolled Martin and Daviess counties and is now primarily patrolling Dubois County. Throughout his career, McBeth has served as a member of the TIP Team and as a Field Training Officer.

Trooper McBeth made a strong impact in his patrol area where he normally works the night shift. He made 176 criminal arrests and 1206 traffic contacts. He also had 8 OWI's" said Lieutenant Jason Allen, Commander of the Jasper District.

Trooper McBeth resides in Dubois County with his wife and children.

 neutered 784 dogs and cats in the spay/neuter clinic since July last year. She also told the commissioners that a volunteer is working to trap cats in Shoals currently. So far, the humane society has trapped, fixed and returned 15 cats in 2022. The goal is to stop the breeding of these feral cats.

Commissioner George reported that the county's ambulance provider has received a 60-day extension on having Good Samaritan Hospital serve as the medical sponsor, which they are losing. Each ambulance service has to have a hospital as their medical director. George said they have decided to pay the ambulance service monthly now as opposed to quarterly or yearly to see what comes of the situation. George said they haven't requested bids for ambulance service over the past several years because there has been no interest. They feel now that

there may be other interest, so the plan is to request bids in the future. He said he didn't want to say more until County Attorney Dave Lett was present.

New Auditor Michelle Norris told the commissioners that Bev Terrell, from her office, has submitted her resignation. She requested permission to advertise for her position. The commissioners gave approval. Commissioner Cody Roush said he has been talking with Auditor Norris about putting open positions out for internal applicants before making the position public. They plan to see if anyone internally would like to apply for a position for at least five days before advertising to the public.

The commissioners approved closing the courthouse this Friday because the Catfish Festival rides will be set up in the street in front of the building. The courthouse will also be closed Monday for Independence Day.

## 'Operation Dry Water' to target boating while under the influence

The Independence Day holiday typically means more boaters spending more time on the water across the United States, which typically results in an increase in the number of boating incidents and fatalities.

As a result, from July 2-4, Indiana Conservation Officers, in partnership with the National Association of State Boating Law Administrators (NASBLA) and the U.S. Coast Guard, will participate in the national Operation Dry Water heightened awareness and enforcement weekend.

During those days, law enforcement agencies from across the country will be focused on educating boaters about safe boating practices, including sober boating. Because alcohol use is the leading known contributing factor in recreational boater deaths, Indiana Conservation Officers will be working to increase public awareness of the dangers of boating under the influence of alcohol or drugs, for boat operators and their passengers.

Boaters during Independence Day weekend will notice an overall increase in officer patrols on the water and at recreational boating checkpoints.

Operating a vessel under the influence of drugs or alcohol is illegal on all bodies of water and can lead to serious injuries, death, property damage and legal consequences. Indiana Conservation Officers reminds boaters to always boat sober and to wear a life jacket when on or around the water. 

I am about to have a major life change that will affect my gardening. In a few days, I will be retiring from my job at the Southern Indiana Center for Independent Living. I will continue to pastor the Orleans and Leipsic United Methodist Churches, but I will no longer have a job to go to every day. It will be a big change for me, and I am counting on my garden to ease the transition.

Obviously, I will have more hours to spend in the garden. Perhaps I will finally get caught up with all the garden chores that I have been unable to do. I look around the garden and see a lot of weeds to pull. It seems I got behind earlier in the spring when I had some medical issues and just have been unable to get caught up. It seems that every time I am off, it rains. It will take a while to get there, but I will follow the shade around the yard and will eventually get things in shape.

I have several projects in various stages of development at Sandhill Gardens. While no garden is ever “finished”, I do want to get some of my projects done. I have a little more to do to get the moon garden to the point I want. I will have time to install the solar rope lights on the moon gate. I will hopefully find someone who will sandblast the old paint from the cast iron bench that will go there. Once the old paint is off, I will paint it a bright white that will blend in with the white flowers and the variegated plants that I have planted in that area. I will repair the light fountain and get everything mulched.

## *Daviess-Martin County producers have until August 1 to submit FSA county committee nominations*

Farmers and ranchers have until August 1, 2022, to nominate candidates to serve on the Daviess-Martin County Farm Service Agency (FSA) Committee. The U.S. Department of Agriculture (USDA) accepts nominations each year in certain Local Administrative Areas (LAAs) for individuals to serve on these locally led committees.

“The August 1 deadline is quickly approaching,” said Kathy Fears, Executive Director for FSA in Daviess-Martin County. “Committee members play a critical role in the day-to-day operations of the agency and are vital to how FSA carries out disaster programs, as well as conservation, commodity and price support programs. This is your opportunity to have a say in how federal programs are delivered in our county.”

This year, Daviess-Martin County is accepting nominations for LAA 3 and LAA 4. LAA 3 includes Van Buren, Barr, and Reeve townships in Daviess County. LAA 4 includes Perry, Rutherford, and parts of Center and Mitcheltree townships that are located north and west of the White River in Martin County. Agricultural producers who participate or cooperate in a USDA program and reside in the LAA up for election this year, may

be nominated for candidacy for the county committee. A cooperating producer is someone who has provided information about their farming or ranching operation to FSA, even if they have not applied or received program benefits.

Nationwide, more than 7,700 dedicated members of the agricultural community serve on FSA county committees. The committees are made up of three to 11 members who serve three-year terms. Individuals may nominate themselves or others and qualifying organizations may also nominate candidates. USDA encourages minority producers, women and beginning farmers or ranchers to nominate, vote, and hold office.

Producers should contact their local FSA office today to register and find out how to get involved in their county’s election, including if their LAA is up for election this year. To be considered, a producer must be registered and sign an FSA-669A nomination form. Urban farmers should use an FSA-669-A-3 for urban county committees. The form and other information about FSA county committee elections are available at [fsa.usda.gov/elections](http://fsa.usda.gov/elections).

Election ballots will be mailed to eligible voters beginning November 7, 2022.

## Reserved hunt applications open July 1 under new system

Beginning July 1, hunters can apply for a variety of reserved hunts online by visiting [on.IN.gov/reservedhunt](http://on.IN.gov/reservedhunt).

This year, instead of one application period for all draws, they are split into a few different date windows. The reason for the change is to help hunters more easily plan for their hunts and thereby increase the number of hunters able to participate.

The online method is the only way to apply for the hunts listed below. No late entries will be accepted. Applicants must possess a hunting license that is valid for the hunt for which they are applying.

Hunters will be selected through a random computerized drawing. Applicants will be able to view draw results online within two weeks after the application period has closed. An email will be sent to all applicants when draws have been completed.

Applications for the following hunting opportunities open July 1. Applications must be submitted by 11:59 p.m. ET on August 1:

**Dove Hunts:** Applicants may select the desired date and property. Due to inclement spring weather, other crops may have been planted in place of or along with sunflowers. Participating properties include the following Fish & Wildlife areas (FWAs): Atterbury, Goose Pond, Jasper-Pulaski, Kankakee, Kingsbury, Pigeon River, Willow Slough, and Winamac.

**Muscatatuck National Wildlife Refuge Youth Deer Hunt:** Muscatatuck NWR will host one reserved firearm deer hunt for youth, September 24-25.

**Indiana Private Lands Access (IPLA) Hunts:** IPLA will offer reserved hunts for squirrel and youth deer on private lands. Hunt dates and locations can be seen when applying.

Applications for the following hunting opportunities open August 22. Applications must be submitted by 11:59 p.m. ET on September 23:

**FWA Waterfowl Hunts:** Participating FWAs include Goose Pond, Hovey Lake, Kingsbury, Kankakee, and LaSalle. Province Pond Wetland Conservation Area, managed by J.E. Roush Lake FWA, will also participate.

**FWA Deer Hunts:** Deer Creek and Fairbanks Landing will host firearm season hunts.

**State Park Deer Hunts:** State parks participating include Brown County, Chain O’Lakes, Charlestown, Fort Harrison, Harmonie, Lincoln, McCormick’s Creek, Ouabache, Pokagon, Potato Creek, Prophetstown, Shades, Shakamak, Summit Lake, Tippecanoe River, and Whitewater Memorial. **Additional hunting opportunities:** Camp Atterbury (National Guard property) has decided not to allocate deer hunting opportunities through the Indiana DNR reservation system. The application process is now consolidated into the online services website along with licenses, CheckIN Game, and HIP registration. An online account is not required to apply, but you must have a Customer ID number.

Hunts without a registration fee will follow the same process as those with a fee. To register for hunts with no fee required, applicants will be asked to “Add to Cart,” “Proceed to Checkout,” and “Place Order.” If the transaction total is \$0, the applicant will not be asked to enter credit card information. Applicants must place an order to submit their application.

To view draw results, applicants can log into their online services account or click “View hunt draw results” at [on.IN.gov/reservedhunt](http://on.IN.gov/reservedhunt). From there, applicants should select “Click here” under Reserved Hunts to see the status of registered hunts. The link will only show upcoming hunts that an individual has registered for. Logging into an account online is required to see the full history of past hunt registrations.
