# Councilman's Corner


Here's an update on one of your town's current infrastructure projects. The wastewater project, which is our largest project this summer. This is the largest project that's been done to our wastewater system since it was installed in 1972. By now you've seen the very large tanker truck with a smaller box van truck following it around town. The tanker truck is a large vacuum cleaner with a high-pressure water system. The smaller box truck has a closed-circuit television equipment on board and recording devices. The first big truck goes from manhole to manhole that we have designated. Then it cleans them with a very high-pressure water jet and vacuums the pipes so they can be inspected. The smaller truck then lowers a camera down into the pipes and pushes it to the next manhole. While the camera is going through the pipe, it's recording all it sees. The camera has such high resolution we can see hairline cracks or breaks or where roots have grown into our system. Let's keep in mind that wastewater pipes are the deepest buried pipes in the town. These pipes (on average) run anywhere from 10 to 15 feet under the surface of the ground. As of this date, we have looked at approximately 5,900 linear feet of wastewater piping. That's the same as approximately 12 football fields long. The closed-circuit TV digital information has been reviewed by the engineers. The report we received shows over 55 intrusions (that's breaks in the line or where roots came in) The line that we surveyed runs from the intersection of

Spout Springs Road and Water Street to the Shoals High School. We will take this information and turn it over to construction companies that specialize in relining these pipes while they're still in the ground without having to dig them all up.

The bidding process will start, and we will take the lowest bid. All of this has to happen very quickly so we can utilize our grant money in the timeframe the state says we must spend it, or we risk losing it. It is very important that we address this first phase of our three-phase wastewater project. Wherever you have infiltration (breaks or roots) in your line, not only does that mean your wastewater is leaking out but it also means that ground water is coming in. This means when we have heavy rains or natural springs in the area our system is collecting it and we are spending money to process this water that is not necessary to clean. We process between 60 and 80,000 gallons of wastewater a day. When we have a heavy rain, we process between 120,000 to 150,000 gallons of wastewater. There's something very wrong with our system. We understand there are no perfect systems. Yet this is way far beyond what should normally be processed. Processing wastewater is a very expensive procedure. We cannot use property tax money to pay for this process. The only way we can pay for this is billing our wastewater users.

The next two phases are the processing point at our lagoons and the forced main wastewater pipe going across the East Fork White River bridge at Highway 50. Stay tuned for updates on those!

The Section 8 HCV program is available to income eligible individuals and families and exists to assist with rent payments to provide decent, affordable, sanitary, and safe housing for persons with low incomes. The Section 8 HCV program is not emergency housing assistance and your waiting time for assistance may exceed 24 months.

## In the Garden

Last week, I took a trip to northeastern Pennsylvania to the Pocono Mountains. It was just a vacation with a great nephew and two great nieces, and we really had no firm plans other than to get away for a while. Of course, I always love to check out the gardening scene wherever I go, and the children know they have to visit gardens and nature sites to pay for my taking them to the pools and play areas.

Our trip included short forays into New Jersey and New York. In New Jersey, we spent some time in a park along the shore of the Delaware River. In general, the Poconos area is not very different from the hills of Southern Indiana. Yes, the mountains are higher, but are not nearly as large as the Rockies. They have apparently embraced the trend to allow nature to re-claim lawn areas. Our resort had few lawn areas, but wildflowers were plentiful, especially black-eyed Susans. The state flower of Pennsylvania is the mountain laurel, and they were growing everywhere. There were a few blooms hanging on from the peak bloom time in early July. I could only imagine how beautiful the bloom time would be. A laurel relative, wild rhododendron, also is commonplace. Again, we were too late to see the blooms, but the evergreen leaves formed a backdrop for the wildflowers that were blooming.

My love of trains took us to the town of Jim Thorpe, where an excursion train took us on a ride through the mountains. We saw a lot more mountain laurels and rhododendrons along the tracks and enjoyed the beauty of the area, including a small waterfall. The train is also a good way to see black bears and other wildlife of the Poconos. The people of the town take their horticulture seriously. Jim Thorpe is essentially a tourist town, filled with Victorian houses and old churches. Most of the old homes in the historic section now house businesses, including numerous gift shops and coffee houses. However, in many cases, the shops occupy only the bottom couple of floors, with apartments on the upper floors. In a style that reminded me of my time in Paris, there were flower-filled window boxes at every window, both on the living quarters and the store areas. Unlike Paris, where the boxes are usually filled with red geraniums, the window boxes of Jim Thorpe were lush and varied. Some were filled with succulents, while others sported blooming annuals and foliage plants. In addition to the window boxes, there were many pots filled with flowers, small shrubs and even a few fruits and vegetables. In many cases, pots or groups of pots were

used to form barriers to keep shoppers from using the old fire escapes or to block access to non-public areas. I was impressed that all of them were free of weeds and the plants were in good shape. Sure, they could have just used signs to direct people away from the sites, but the flowers were a nice touch and much more pleasant.

Our final gardening-related outing was a trip to the Graver Arboretum near Bath, Pennsylvania. The 63-acre site was the life work of Dr. Lee and Virginia Graver, who spent 40 years clearing underbrush and invasive species from the property to create a habitat for rare and native trees, mountain laurels and rhododendrons, ferns and wildflowers. The site was donated to Muhlenberg College in 1994, and is maintained by the students of that school. Walking trails are mapped out through the arboretum. While not totally accessible, most of the trails are easy to walk and most would accommodate a wheelchair. There is a small lake we saw an assortment of wildlife on our hike. Not every tree has a marker, but the rare specimens are marked. There are more than 150 species of conifers and a lot of hardwood trees. Like other areas, it would have been more spectacular when the laurels and rhododendrons were in bloom, but it is a nice place to visit at almost any time. There is no charge to enter the arboretum.

While our trip to the Poconos was not timed will for the area's natural beauty, it was a good vacation and I would recommend visiting the mountains and enjoying the beauty.

## Rule changes on DNR properties take effect

Several rule changes that affect DNR properties took effect last week, with the Natural Resources Commission, Attorney General's Office, and Governor's Office having recently approved them.

Changes include the following:

-Stands or blinds (including portable ground blinds) are allowed to be left overnight on DNR properties if the blind or stand is legibly marked with the name, address and phone number of the owner or the owner's customer identification number issued by the DNR.

-Trail/game cameras can be placed on properties managed by the Division of Fish & Wildlife, as well as on state forests, and state recreation areas as long as the camera is legibly marked with the owner's name, address, phone number or customer identification number issued by DNR. Placement of the camera must not damage a tree.

-The placing of bait for wildlife is prohibited on any DNR property. Exceptions are granted for bait or food placed

for wildlife management as authorized by DNR, the result of authorized agricultural operations on the property (like tenant farming) or a bird feeder placed by a DNR employee. The definition of bait includes (1) a food that is transported to and placed for consumption, including but not limited to piles of corn and apples placed on the property; (2) prepared solids or liquids manufactured and intended for consumption by livestock, wild deer or birds, including, but not limited to, commercial baits and food supplements; (3) salt; and (4) mineral supplements.

-The collection of shed antlers without a permit is allowed, except on dedicated Nature Preserves.

-Via a permit, magnet fishing is allowed on public waters on DNR properties as long as the magnet is able to be carried and retrieved by hand. Individuals will need to contact the respective property office to get a permit for magnet fishing on a DNR property.

## Patoka Lake announces dove hunt information

Due to poor sunflower growing conditions locally, wildlife management staff at Patoka Lake will not conduct in-person drawings for controlled mourning dove hunting opportunities this year. Instead, the two sunflower fields on South Ramp Road within Newton-Stewart SRA will be open for mourning dove hunting on a first-come, first-served basis. The routine drawing process for mourning dove hunting opportunities is expected to return in 2023.

Hunters are reminded to procure the proper licenses, stamps, and their federal Harvest Information Program (HIP) number. Hunters are required to sign in at a property hunter check-in station and en-

sure they have a One-Day Hunting Permit on their person. Hunters are also reminded that they are federally required to use non-toxic shot of size 6 or smaller, in addition to having their firearm plugged so that it can only contain three shells at any time. Regular shooting hours are one-half hour before sunrise to sunset through the legal season(s).

Hunters should contact Indiana DNR Law Enforcement at 812-837-9536 regarding specific questions on federal or state laws, statutes, and rules. For other information on the controlled hunt, call Patoka Lake at 812-685-2464 between 8 a.m. and 4 p.m. and ask for the wildlife specialist.
