Commissioners try to solve multiple road issues

The Martin County Commissioners talked roads at their meeting Tuesday night, July 31. County Council Member Buck Stiles was present in the audience and asked multiple questions about the Community Crossings grant funds and blacktopping.

Stiles wanted to know how much blacktopping from the Community Crossings grant money had been completed. Highway Superintendent Leo Padgett responded that all the blacktopping for this year had been done. It was explained that the county applied for \$1 million for the grant but only received \$670,000, therefore some roads on the original list had to be removed. The county will be applying again this year for the Community Crossings grant and will again be asking for \$1 million. Commissioner Paul George explained that this year, there will be a combination of roads and bridges. Council Member Stiles responded that he thought the grant money was going toward blacktopping only. Commissioner George replied that there are three bridges in the county that need repairs, too costly for what the highway department has in their budget, so grant funds are going to have to be used.

Stiles also questioned how the commissioners were able to pass a vote choosing Farm Bureau Insurance as the insurance agent of record if two of the commissioners abstained making it a 1-0-2 vote. Commissioner George said Commissioner Kevin Boyd made the motion to accept Farm Bureau with George making the second, but George and Commissioner Dan Gregory abstained. County Attorney Dave Lett said the vote was legal.

Highway Superintendent Padgett reported that one of the highway trucks, that has been working on patching, hit a deer recently. The truck is at Greene's Body Shop awaiting a response from the insurance company.

A resident in the audience asked if his road, Poplar Grove, was now an unimproved county road due to its sorry state. He said the potholes are terrible and tore up his motorcycle. Commissioner Paul George said that Poplar Grove is one of the roads on the list to be patched and asked that the highway superintendent check out the road to see if it is worth saving. George said that if the asphalt cannot be saved, they may need to tear it up and instead do chip and seal.

Highway Superintendent Padgett said that a resident on Friends Creek Road, off Mt. Pleasant Road, has requested dust control on a 100-foot section of the road. The commissioners agreed to have the highway department spray the road at the owner's expense.

Padgett also reported that Butler Bridge Road's chip and seal work has been completed.

Sheriff Travis Roush told commissioners that there are currently 72 inmates in the jail with 21 of them from Vigo County. Commissioner George asked if the county had received all the money due from Marion County, from housing their inmates last year. Sheriff Roush replied that yes, they are paid in full. Sheriff Roush was asked by Commissioner Kevin Boyd how much Vigo County pays per day for Martin County to house their inmates. Roush replied that it was \$35 a day and that amount was modeled after the state. The state pays counties \$35 a day to house department of corrections inmates so county to county inmates cost the same. Roush added that there has been talk about increasing that per day rate to \$55.

Commissioner George said that he didn't think the construction of a new jail was moving along very quickly in Vigo County. Sheriff Roush replied that he believed a vote will be coming up soon to move it forward however it will (See 'COMMISSIONERS' on page 2)

Southern Indiana Development steps in the process. Ed Cole with Commission, in Loogootee, received a \$50,000 grant from the U.S. Department of Commerce's Economic Development Administration to support entrepreneurship in the region through the study of the Southwest Indiana Technology and Collaboration Hub Network or "SWITCH."

This study will help establish a network of entrepreneurial centers in southwest Indiana and allow the sharing of resources throughout the network. Once completed, this study will bring together the public and private sectors by building an economic development roadmap to strengthen the regional economy, support private capital investment and create jobs throughout the region.

Kent Utt, president Knox County Economic Development Corporation stated, "Two of KCDC's primary goals vetted out during our recent comprehensive strategic plan are to create an entrepreneurial ecosystem and improve retention and attraction of talent. These goals will be further advanced through the SWITCH feasibility study and enhance a collaborative region focused on innovation and entrepreneurship."

The study is a partnership of 11 different local economic development organizations (Crawford, Daviess, Dubois, Greene, Knox, Lawrence, Martin, Monroe, Orange, Pike and Washington), three regional planning commissions (SIDC, River Hills and IN 15), two regional economic development organizations (Radius Indiana and the Southwest Indiana Development Council), as well as Regional Opportunity Initiatives, Inc. and the Indiana Economic Development Corporation.

"Regional partnerships are challenging, but with clear focus the benefits created from a region working together create more opportunities than working alone. This initiative, if done right, will be a model for the rest of the country for increasing entrepreneurship and collaboration in rural America," said Greg Jones, director of SIDC. Radius Indiana received an initial grant from the IEDC to begin studying the concept of a SWITCH network and will use those funds to match the EDA grant. "We cannot thank IEDC enough for the initial investment in this concept and by partnering with the EDA I believe we will have enough funds to study the issue and stand up the framework for a lasting entrepreneurial ecosystem," added Jeff Quyle, president and CEO of Radius Indiana.

Dubois Strong said, "I am looking forward to the expanded opportunities for co-working space collaboration the SWITCH Network will bring to Southwest Indiana."

Ron Arnold with Daviess County Economic Development Corporation said, "SWITCH Network will allow Daviess County and the region to identify and understand steps needed to participate in an ever changing economy. I applaud the efforts of Radius Indiana and SIDC to bring the region together."

The planning process will kick off in the fall of 2018.

Kinder gives WestGate updates to commission

The Martin County Redevelopment Commission held a brief meeting Tuesday night, July 31, prior to the commissioners' meeting. Alliance Director Tim Kinder gave updates on happenings in the WestGate Tech Park.

Kinder said that due to a soil study, the proposed WestGate Hotel is being moved slightly from its original building location.

The hotel is a combination of a Sleep Inn and Mainstay hotel and is being built by Mike and Debbie Hicks who also own the Comfort Suites in French Lick and the Legend of French Lick Resort Boutique Hotel and Event Center. The new hotel will be situated west of the Battery Innovation Center in the tech park and will include 72 rooms, meeting space, a business center and fitness center.

The cost of the hotel is estimated at \$7 million and is located on Greene County's portion of the tech park. There is no start date on the hotel at





I am writing this week's column sitting in a condo in the Great Smokey Mountains. It is a family vacation and a rare trip that does not include any flower shows. However, that does not mean that I do not pay a lot of attention to the landscape around me.

Right now, the star of the landscape in this area is the crape myrtles. In Indiana, we have some beautiful crape myrtles, mostly planted within the past ten years since cultivars with more winter hardiness have become more available and more affordable. However, in Tennessee and farther south, there are massive crape myrtle trees, lifting high their plumes of white, red and various shades of pink and purple. Every yard seems to have a couple of the beautiful trees and hardly a commercial plot exists without at least one crape myrtle.

Another stand-by for late summer flowers is the panicled hydrangea. As with the crape myrtle, the biggest difference in the hydrangeas in Tennessee and those in Indiana is size. The panicled hydrangea is a more reliable bloomer than some other hydrangeas, even in southern Indiana. In Tennessee, one sees more tree-sized plants, whereas we tend to use them as shrubs in Hoosier gardens. The abundant white, green or pink cones held high above the leaves are great summer blooms that will persist into fall. In most cases,



the flowers will gradually change colors, finally drying to a papery brown that often stays around all winter.

It seems that every store takes pride in presenting beautiful flower gardens. I cannot say that I have seen anything that is out of the ordinary, but I have seen ordinary annual bedding plants combined with perennials, shrubs and evergreen trees to make borders and island beds that are invitations for shoppers to come and take a look. This is particularly true on "The Island", a retail and entertainment center that was opened a few years ago.

No trip to the Smokies would be complete without spending some time in the Great Smokey Mountains National Park. We took a leisurely drive through Cade's Cove and climbed to the top of Clingman's Dome. I enjoyed the wildflowers as much as I did the views. Large patches of Angelica along the path to the Dome were attracting bees by the thousands. The red bee balm was also attracting bees and butterflies. In Indiana, the native bee balm is usually pink or mauve. One may plant a variety such as Jacob Cline to get the red blooms, but nothing is as impressive as the expanses of deep red blooms advertising nectar to pollinators. The Angelica and bee balm along the path are accompanied by Heleniums, turtleheads, Queen Ann's lace and many other common wildflowers.

By the time you will have read this, I will have returned to Indiana and traveled north to Indianapolis for my annual stint of judging at the Indiana State Fair. It is always fun to see the vegetables and flowers grown by 4-H members around Indiana. I also like to see the landscape changes that have been made around the fairgrounds. The fair begins its run on Friday, August 3. If possible, make a trip to the capital city for the fair. It is a fun way to support our youth and Indiana agriculture.

The 312,000-gallon Fishin Pond is adjacent to the Natural Resources Building and is packed with fish that are ready to be caught and released. Youth fishing is available every day in the early evening and most mornings. Parents/guardians should check the daily schedule online or in the State Fair program. Exact hours differ on some days.

Visitors to the building also can view native Indiana fish in aquariums, pick up free copies of the just-off-the presses Hunting Guide, the latest Recreation Guide and Fishing Guide and other informational brochures, subscribe to Outdoor Indiana magazine at a special State Fair deal, ask questions of DNR experts, visit Mother Nature's Mercantile to buy unique outdoors-themed items, or just take an air-conditioned break.

All DNR activities at the fair, except buying items at the Mercantile, are free after paying gate admission to the Indiana State Fair.
