**LAKE JOHN/COWDREY LAKE  
OFFICIAL ICE FISHING CONTEST RULES**

➤All Colorado fishing rules and regulations apply.  
Please consult your 2018/2019 rules and  
regulations and be aware of any rule changes.

➤Only one major cash prize will be awarded to any  
one entrant. Winners of major cash prizes are also  
eligible for hourly prizes and/or the special prize  
for the largest fish taken from Cowdrey Lake.

➤Contestants must show valid contest registration  
receipt to enter fish for measurement. Official  
measuring stations are at the Lake John Resort  
store for Lake John, and at the Cowdrey Lake  
shoreline. Measuring stations will operate from 6  
am to 5 pm on Saturday, Jan. 12, 2019, and from 6  
am to Noon on Sunday, Jan. 13, 2019.

➤Prize payout will be held at 2:00 p.m. on Sunday,  
Jan. 13, 2018 at location TBD in Walden. Winners  
of cash prizes do not have to be present to win, and  
if not present at the prize payout will receive prizes  
by US mail. Raffle will be held after prize payout.  
Winners of raffle merchandise prizes must be  
present to win.

➤Official time clock is at the Lake John Resort.

➤In the event of a tie, the first fish registered wins.  
For example, if three (3) 35-inch fish are the largest  
fish entered, the fish registered the earliest will  
take 1st place, the second fish registered will take  
2nd place, etc.

➤Fish under 16 inches in length will NOT be eligible  
for measurement if brought in by an adult entrant.

➤ Only fish caught during the contest hours between  
6:00 a.m. Saturday, January 12, 2019 and 12:00  
p.m. Sunday, January 13, 2019 are eligible for  
prizes. \$75 hourly cash prizes will be paid for high-  
est scoring fish measured during each hour from

6:00 a.m. to 5:00 p.m. on Saturday, and from 6:00  
a.m. to 12:00 p.m. on Sunday.

➤Any violation of contest rules, Colorado fishing  
rules & regulations, State or County laws brought to  
the attention of the Chamber Board of Directors will  
subject the violator to review for prize eligibility by  
the Board.

➤Only registered anglers may win prizes.  
Unregistered anglers in your party may jeopardize  
the validity of a fish caught by a registered entrant.

➤Irresponsible use of motor vehicles or OHV  
(including ATVs & snowmobiles) by any member of  
a fishing party WILL result in disqualification of  
the entire party.

➤The North Park Chamber of Commerce, its  
Members, Colorado Parks and Wildlife and Lake  
John Resort, accept no responsibility for accidents or  
injuries on either thin ice areas or the  
surrounding areas of the Lakes as a whole. You are  
on the premises at your own risk. Use caution when  
on the lake or any property associated with the IFC.

➤Pre-registration entry forms must be received by  
the Chamber via US Mail no later than 12/31/18.  
All fields must be completed, and full payment must  
be enclosed. An official contest registration receipt  
will be mailed to you via US Mail. Registration in  
person requires completion of Entry Form and pay-  
ment of Entry Fee. Official contest registration re-  
ceipt will be given to entrant.

# PRIZES

Scoring consists of calculation of length plus girth of each trout caught by individuals during two-day contest.

**Fish under 16 inches in length will NOT be eligible for measurement if brought in by an adult entrant.**

One set of prizes for the two-day contest. To be eligible for the cash prizes, a contestant must have a valid Colorado fishing license, must be registered, and present receipt for paid entry fee.

### ADULT CASH PRIZES:

**Grand Prize \$1,000**

**2<sup>nd</sup> Prize \$ 750**

**3<sup>rd</sup> Prize \$ 400**

**4<sup>th</sup> Prize \$ 300**

**5<sup>th</sup> Prize \$ 200**

Highest Scoring Trout taken from Cowdrey Lake \$150

\$75 per hour paid for highest scoring fish measured during each hour from 6:00 a.m. to 5:00 p.m. on Saturday, January 12, 2019 and from 6:00 a.m. to 12:00 p.m. on Sunday, January 13, 2019. Top prize-winning fish are included in hourly payoffs.

### PRIZES FOR YOUTH UNDER 16 YEARS OF AGE:

Youth anglers under age 16 pay a \$10 entry fee, and compete for separate cash prizes.

1st Prize \$100    2nd Prize \$75

3rd Prize \$50    4th Prize \$25

The 16-inch length restriction does not apply to anglers competing in the youth category.

Youth anglers age 12 and up may compete for adult cash prizes by paying the \$30 adult entry fee, purchasing an Adult Fishing license, and following Adult rules in the Contest.
